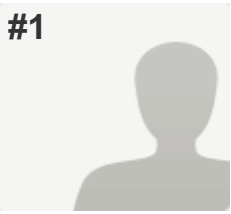
I would to express my concern at the impending closure of the nursery class at kings court. I have two children at the school one who has been through the FS unit and one who is currently in the FS1 unit but will be in reception in September 17 when the proposal to close takes affect. Although this will not directly affect my family as my daughter will have moved into the next unit. I would like to explain why I have felt the need to respond. The nursery and reception unit at the school was one of the deciding factors for my family to choose the school. We are practicing Catholic so had wanted my children to attend a faith school, however when I heard how children at this school get the opportunity to integrate between the FS1 unit and the FS2 unit during their time, I was really curious as to how this would benefit children and ultimately their learning. My oldest daughter was very shy and the thought of her having to settle into Nursery and then a year later moving into a different year and different teachers a different class room at this crucial stage in a 4/5 year olds life would have been over wellming and often enough to delaying learning for at least a term as the child becomes emotional secure and thus ready to take on learning, hence why we decided to look at Kings court nursery unit. The fundamental basis for children to learn is feeling emotional secure and having the Nursery class as the feed into reception works exceptionally well, the children are school ready by the time they transition into the reception class but ultimately are emotional secure with the staff and the environment. I believe this contributes to the outstanding academic achievement and the records that 98% of children in the school are above national average in all areas at the end of reception. I believe without the nursery class the children will all be new to the school environment and will take longer to settle and longer to learn which ultimately will affect education and results.

I think it would be a great loss to the school to close the nursery class as the children gain so much from being in the school setting and the interaction with the reception children in the foundation stage setting.

It makes the transition of starting school much easier for the children and staff. The children know the school & staff and are happy to stay all day as they feel safe and secure. The staff also know the children which helps them to give them the best start.

The children also gain from interacting with the reception children, seeing how they learn & play with each other. They also share skills and knowledge. My daughter loves playing with the children that have been in the nursery and are now in reception as she has made good friends with them.

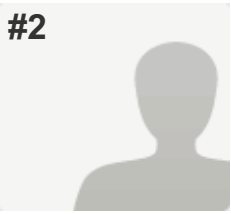
It also offers completely free half day sessions (Am & PM) which is important for a lots of parents who struggle with the cost of childcare, or only want their children to experience short sessions in a formal childcare setting. It also gives parents a choice of sessions to fit in with the child's needs, and other activities.

The nursery is also very useful for parents that have to drop off or collect at Kings Court School, as it means one drop off in the morning or pick up in the afternoon. If my child had to attend another nursery then I would have to take my car, as it would be too much for my child to have to walk to another setting after the school drop off, and very short on time. This would mean more traffic on the roads, as currently we walk, as do a lot of other parents. There are also parents with Children at more than one school, adding an extra nursery setting could mean three separate drop offs or pick ups.

Could the nursery offer just one session instead of the two they currently offer? This could cut some costs, whilst still offering the children the opportunity they currently have, and enabling other children to have the same opportunity.

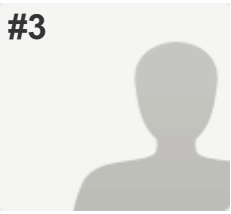

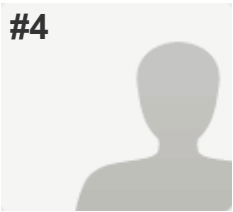
The school provides an alternative to the only other pre school setting in Old Windsor which is on straight road. I have found that the school was able to offer both morning and afternoon sessions every day which was not available at the other pre school. I feel much happier sending my child to a pre school setting which follows on to a school, particularly with my daughter who was born in May 2013, therefore she only has one year of this setting before starting in September.

With my oldest daughter she started at Kings Court nursery before joining the Reception class. Having been at Kings Court nursery she was fully ready and settled at the school by the time she had to begin in Reception- something that would have taken much longer if she only joined in Reception; therefore hugely impacting her first few terms at school. We are expecting another child this month and I would be concerned about our options for her if the nursery at Kings Court was to close.

Finally, I cannot express highly enough the care and support that has been provided by the staff at Kings Court nursery; from settling in, to helping my children to thrive and develop in their care. It would be a great loss if some of these members of staff were to lose their position, as mentioned in the proposal.

Yes there is a pre-school and independent nursery in Old Windsor but neither of these provide an intimate view of school life nor an introduction to education. Both of my children could read and write and knew their numbers before starting school and that was due in part to the nursery at Kings Court.

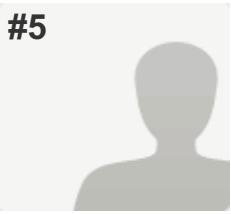
Also you should be aware that not only will 2 nursery nurses lose their jobs but also 2 lunchtime controllers who work with the nursery children to have lunch.

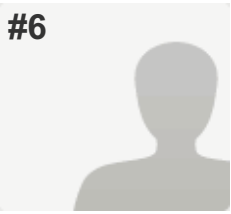

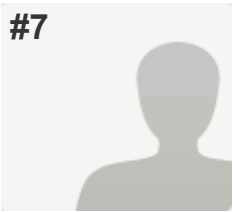

I'm not in favour of this idea which I think removes choice from the local residents and which will deprive the area of a much needed resource that greatly benefits children in their early years. Nursery is not just a stable where you park you children while you're at work. I know some of the other nurseries around here try and offer some form of stimulation but it's not always done in the more structured way that the FS stage did at and does at Kings court. In face removing Kings Court will increase the numbers going to these alternative suppliers and lessen their ability to supply that. Both my two children went to the nursery class at Kings Court and then seamlessly moved into reception there. I was really impressed by the start they got and we had in fact moved both of them from the other local providers. Now I would add that from what I see and hear from other local residents the standards have fallen and that's why numbers may have decreased. At the time my kids were there the standards were high and they learnt how to 'be' in school, there was focus placed on social and life skills and even on some of the basic "how to eat" skills which unfortunately needed in some cases. Most importantly because there was a structure to what they were learning it built on the reading and writing we'd done with the kids at home and prepared them really well for the education to come.

If you close the nursery you are taking away parent choice. There are other providers but what happens is they fall below standard, where would that leave parents. It is the state's obligation to provide a base level supply at all levels.

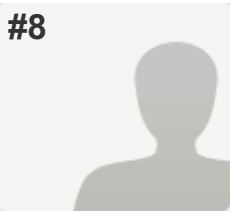

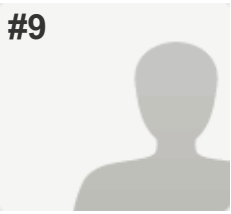

I feel that the proposed closure of the nursery class is a great loss to the village.

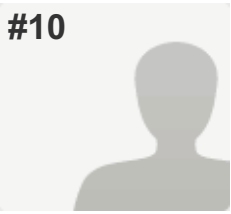
Both my children attend/have attended the setting and when applying for a space I found options in the local area very limited. There is the Old Windsor Memorial Pre-school which I found to be oversubscribed and Poppies nursery which requires a minimum of 2 full days and at a cost (which would not be fully covered by the government funding). If the Kings Court nursery does close this will put even more demand on local spaces. Equally, there may be government funding for up to 30 hours per week available from September 2017, again locally it will be difficult to access these hours.

It is quite challenging for some parents to collect/drop off children at lunchtime and local child-minders are often oversubscribed. Perhaps some full day sessions could be offered at Kings Court nursery? This may make it easier for working parents to utilise the nursery and increase numbers at both sessions. (As the school already has breakfast and after school club there is good wrap around care available for working parents, so the offer of some full day sessions would compliment this)

Kings Court nursery provides a great start for 3 year olds and can make transition to reception class much easier, it would be a shame to lose this.

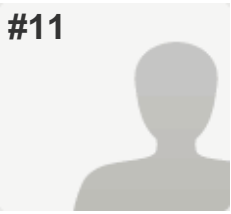

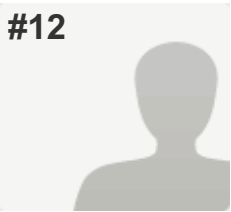

For parents with children at the school it is comforting to know that all your children need to be picked up and dropped of to the same location.

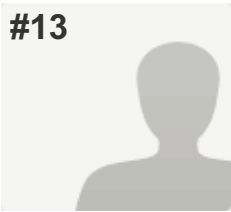
Parents get to know the teachers and build rapport which is very important when the child moves into the school. These relationships are key and especially for young children.

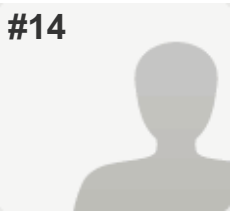
Local school nurseries are difficult to find in the local area. As I working parent, I am unable to afford to send my daughter to a private nursery or child minder.

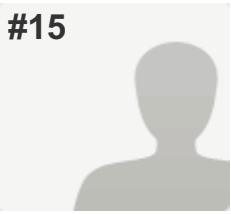

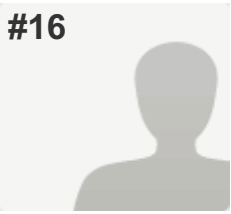

having worked in the FS unit since its inception, I have been witness to the dwindling numbers of children in FS1, particularly in the afternoon sessions. As the Nursery is no longer funded as a 26 morning and 26 afternoon setting, the cost of staffing, particularly at the beginning of each academic year is unsustainable and therefore has a considerable impact on the rest of the school including the FS2 (reception age children.) The scenario of taking children in at a younger age is not possible as this would require even more staff and the facilities in the unit would not be adequate for the needs of much younger children.

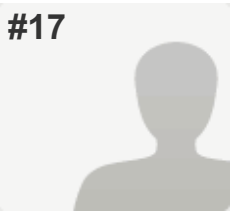
It is a pity that the closing the nursery would be the correct solution, but extending the 15 hour offer to nursery children also had an impact on space and staffing for the school, as well as a number of different providers now being present in the area.

There appears to be no future housing development plans for the Old Windsor area which would support keeping the nursery open.

If the nursery would continue, it would only have a negative impact across the school. Funding to pay for additional support staff in classes, such as Teaching support assistants, HLTA's and specialised teacher support has already been cut, to the detriment of all the pupils.

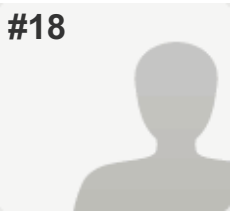

Kings Court Nursery is an excellent EYFS offering, and the only one of its kind in Old Windsor as in state / council controlled.

There are other options for parents in a nursery aged 0-5 (Poppies and more recently Montessori) However, both these offerings are managed by private companies and as such are less affordable to many as their rate far exceeds the government hourly allowance. Thus on a financial point alone, closing Kings Court may severely impact low-medium income families and for this reason I reject the proposal.

While I will not benefit directly from the nursery remaining open (my daughter will have been thru nursery by the time of proposed closure), I feel very sad that future Old Windsor Children will not benefit from the excellent foundation they gain from the dedication and focus of the nursery and regular staff.

I also feel that the outdoor space and mixing with older Reception Children helps to accelerate the nursery children's preparation for entry into reception class the following year.

In summary, closing Kings Court Nursery will be a significant loss for Old Windsor and will limit parental choice.... and in some cases, may reduce the amount of hours some families may be able to take up nursery places in more expensive offerings.

Whilst I appreciate the numbers have dropped, this should not detract from the fact that Kings Court Nursery is the only affordable

I fully support the proposed closure of the nursery at King's Court First School.

The cost of running the nursery is not being covered sufficiently by funding and the shortfall is being covered by budgets from elsewhere across the school. During my time as History/Geography subject leader the budget for these subjects has fallen by over a third. This has had a significant impact on the range of resources and enrichment opportunities provided for children in Key Stage One and Key Stage Two in this area of the curriculum. Other foundation subjects are also affected by similar budget cuts.

I also believe that the proposed closure would also benefit children in Foundation Stage 2 (Reception). The current Foundation Stage Unit encompasses both nursery class (FS1) and reception class (FS2) who are in separate rooms at various points during the school day. As the school is one and half form entry, this often means that up to 45 children in FS2 are confined to the larger room along with all the necessary resources required in such a unit. During inclement weather conditions, when the outdoor space is less desirable, this can be a challenging environment for young children. By closing the nursery, the 45 children could be divided into two smaller - and less intimidating - class groups and the resources spread between the two main teaching rooms.

At present, children are often sat on the floor during maths and literacy sessions in the larger room, or up to 15 children are taught in a smaller, rather cramped, side room. Spreading the resources between the two rooms would greatly increase the available space in the larger room, meaning additional seating could be provided. The children would then have the opportunity to sit more comfortably at tables while they complete tasks and I have no doubt that this would be beneficial to their learning.

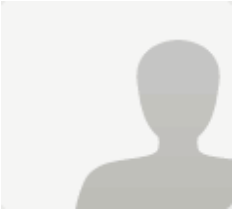
