## Who are PaCiP?

- **v** We are the parent carer forum for Windsor and Maidenhead
- v We cover children and young people 0-25 years
- We are for parents and carers of children and young people in any, or no educational placement, with all special educational needs and disabilities.
- v Run by a Volunteer Management Committee of 5 and a wider volunteer committee member totalling up to 9.
- We are accountable to parents and carers in the local area and our grant givers - DfE via Contact





## Why Parent Carer Forums?

#### S Children and Families Act 2014


- § The ambition:
  - S The Department for Education want all children and young people to achieve well in their early years, at school and in college; find employment; lead happy and fulfilled lives; and have choice and control over their support.
- S Section 19 CFA The Local Authority must have regards to:
  - 5 The views, wishes and feelings of the child, young person and their parents
  - S The importance of allowing them to participate in decisions relating to themselves (or their child)
  - S The importance of providing information to enable active participation in decisionmaking
  - 5 The need to support the child, young person and their parents to facilitate development and enable the best possible outcomes, educational or otherwise.
- § Key changes:
  - S Children and young people and parent carers at the heart of assessment and planning
  - S Change in culture assessments and plans should be undertaken using person centred approaches
  - **S** Focus on the outcomes for children and young people



## Why Parent Carer Forums?

#### **SEND Code of Practice 2015**

- 5 1.11 Local authorities must consult children with SEN or disabilities, their parents, and young people with SEN or disabilities in reviewing educational and training provision and social care provision and in preparing and reviewing the Local Offer. It is important that they participate effectively in decisions about support available to them in their local area.
- 5 1.12 Effective participation should lead to a better fit between families' needs and the services provided, higher satisfaction with services, reduced costs (as long-term benefits emerge) and better value for money. Local authorities should work with children, young people and parents to establish the aims of their participation, mark progress and build trust.
- I.13 Parent Carer Forums are representative local groups of parents and carers of children and young people with disabilities who work alongside local authorities, education, health and other service providers to ensure the services they plan, commission, deliver and monitor meet the needs of children and families.




