1. SUMMARY

This report sets out the amendments required to Part 5R of the Constitution as resolved by Cabinet on 26 May 2011.

2. **RECOMMENDATION:** That:

The Constitution Sub Committee authorises the Head of Legal to update the existing Part 5R of the Constitution, to reflect the decision of Cabinet.

What will be different for residents as a result of this decision?

This decision will allow residents to use the updated forms in the Constitution. Local voluntary organisations will be able to access grant funding in a more simplified and effective way. Successful organisations will receive grant funding more quickly following quarterly Grants Panel meetings.

3. SUPPORTING INFORMATION

3.1 Background

- 3.1.1 On 26 May 2011, Cabinet considered a report setting out changes to the document contained in the Constitution at Part 5R, 'Applying to RBWM for Grant Funding A Guide for Applicants', and the amended application forms, A and B, for revenue and capital grant funding.
- 3.1.2 Cabinet agreed the changes set out in the report, therefore the Constitution Sub Committee is requested to authorise the Head of Legal to make the agreed changes.
