## 1. Details of Recommendations

# **RECOMMENDATION:**

That members give authority to the Community Protection and Enforcement Lead to consult with the trade about adding waiting, other than on a Hackney Carriage rank, to the list of infringements covered by the Penalty Points System – and to make other necessary amendments to the System. A report on the results of the consultation will come before the next Panel.

#### 2. Reason for Recommendation and Options Considered

- 2.1 RBWM's Policies and Conditions for Hackney Carriage and Private Hire drivers both include a Penalty Points System, intended to provide an effective enforcement process for Licensing Officers in respect of drivers who are found to be in breach of conditions such as failing to display the vehicle identification plate, failing to notify the Licensing Officer of being involved in an accident, and so forth. Drivers who accrue a total of 12 penalty points are referred to the Licensing Panel to decide whether the driver should continue to be licensed. A copy of the current infringements covered by the System is attached as Appendix A
- 2.2 In recent months there have been issues with, primarily, Hackney Carriages over-ranking and illegally parking. This has occurred in and around both Windsor & Maidenhead town centres. Complaints have been received from residents and those representing businesses in the areas concerned.
- 2.3 Particular complaints have been received about too many Hackney Carriages being parked on the rank in Thames Street, Windsor which is designed to hold approximately 9 vehicles. Earlier this year the traffic regulation order for this area was re-drafted so as to introduce a loading ban. This means that the Borough's civil enforcement officers can now issue fixed penalty notices to those drivers who are parking on double yellow lines rather than on the rank, something which had previously provided practical difficulties.
- 2.4 In addition, RBWM's byelaws provide that vehicles arriving at a rank which is fully occupied should move on to another rank. However, the current penalty for a breach would be a prosecution. This is unwieldy and disproportionate for the offence.
- 2.5 At a Licensing Panel earlier this year members discussed a report that recommended that the Penalty Points System should be updated to include parking breaches (which are not currently included) so that Licensing Officers can have the option to give penalty points on the spot for that type of breach.
- 2.6 Members authorised consultation on that proposed change and a consultation process was indeed commenced.

- 2.7 However, subsequent legal advice was obtained on the current wording of the overall Penalty Points System – and that advice recommended a revision of the policy in a number of aspects. That legal advice is attached as a Part II document at Appendix B (confidential - although the authoring counsel has given his permission for it to be shared with Members) and the recommended revisions are set out in Paragraph 8 of the advice note.
- 2.8 Appendix C contains a draft of the proposed revised Penalty Points System, taking into account this legal advice.
- 2.9 Members will see also that Paragraph 9 of the advice note recommends that the revisions should be consulted upon before adoption hence the wording of the Recommendation above.

Option	Comments
1. Carry out the Recommendation	Consultation is the first step towards giving Licensing Officers an additional tool by which to ensure that Hackney Carriage and Private Hire vehicles within the Borough do not park illegally or without care.

#### PENALTY POINTS SYSTEM

The introduction of the Penalty Points System is to provide an effective enforcement process for Licensing Officers in respect of Hackney Carriage and Private Hire Driver and Vehicle Licence holders, as well as Private Hire Operators who are found to be in breach of local or national conditions and policies relating to the licensing functions.

The emphasis of the Penalty Points System is to increase and ensure the safety and wellbeing of members of the public as well as compliance with legal requirements.

The system is only intended to ensure compliance by those licence holders who it is **proved** have breached or are in breach of the rules and regulations that they should be complying with.

The system operates in line with penalty points endorsed on a driving licence and that where **12** unspent penalty points are accumulated this will result in automatic referral to the Licensing Panel.

Where a referral is made to the Licensing Panel, it will be that Panel's decision on what further action if any should be taken.

Where penalty points are administered by a Licensing Officer and the licence holder wishes to dispute the matter, the licence holder may request for the matter to be referred to the Council's Appeals Panel.

Any licence holder has the right to appeal against a Licensing Panel decision to the Magistrates Court within **21** days of notification of the Panel's decision.

### PENALTY POINTS SYSTEM

The introduction of the Penalty Points System is to provide an effective enforcement process for Licensing Officers in respect of Hackney Carriage and Private Hire Driver and Vehicle Licence holders, as well as Private Hire Operators who are found to be in breach of local or national conditions and policies relating to the licensing functions.

The emphasis of the Penalty Points System is to increase and ensure the safety and wellbeing of members of the public as well as compliance with legal requirements.

The system is only intended to ensure compliance by those licence holders who it is **proved** have breached or are in breach of the rules and regulations that they should be complying with.

The system operates in line with penalty points endorsed on a driving licence and that is where **12** unspent penalty points are accumulated this will result in referral to the Licensing Panel.

Penalty points become spent 12 months from the date of being administered.

Licensing Officers reserve the right to refer cases straight to a Licensing Panel, rather than imposing points, where they consider the seriousness of the case merits doing so.

Where a referral is made to the Licensing Panel, it will be that Panel's decision on what further action if any should be taken – such action could include the suspension or revocation of the licence.

The Licensing Panel will allow the licence holder the opportunity to challenge the imposition of individual sets of penalty points.

Where penalty points are administered by a Licensing Officer and the licence holder wishes to dispute the matter, the licence holder may request for the matter to be referred to the Council's Appeals Panel.

Such an appeal must be submitted to the Council in writing, stating the grounds for appeal, within 21 days of administration of the penalty points.

Any licence holder also has the right to appeal against a Licensing Panel or Appeals Panel decision to the Magistrates Court within 21 days of notification of the decision.
