- Draft Charging Public Consultation
- Examination by Independent Inspector
- Adoption

The council is consulting on the Preliminary Draft Charging Schedule. The consultation commenced 19/6/2015 and ends 20/7/2015. The rates are:

A few responses have been received but we are expecting the majority to follow the Workshop we are holding for developers on the 9 July 2015 when we will explain our evidence and justification for setting a CIL.

Representations will be considered after the end of the consultation period and any adjustments agreed with the Lead Member for Planning, Lead Member for Finance, Head of Finance and Director of Development and Regeneration.

The council will then proceed to Draft consultation, and then following consideration of representations, ask Cabinet to approve submitting the charging schedule for examination.

The Inspector will consider whether an examination in public will be held or whether the matter can be determined by written reps.

The inspector will issue his report and the council will be asked to formally adopt the CIL rates and set a date for implementation.

This charging schedule should be seen as an interim position in advance of the new local plan. A review of the evidence will be undertaken alongside the progress of the local plan and if appropriate a new round of consultations and examination will take place on updated rates.
