#### **Report summary**

This report comments on some of the points of particular note in the ministerial statement of 6 March 2014, relating to the publication on-line of the final version of the National Planning Practice Guidance. A separate report to this meeting addresses those parts of the ministerial statement announcing the implementation of changes to the 'permitted development' regime.

In summary, the new guidance is presented in the ministerial statement as streamlining and consolidating 7,000 pages of previous guidance. It supplements, amplifies and supports existing policy, as set out principally in the National Planning Policy Framework. It does not therefore change existing or create new policy. The ministerial statement identified a series of points considered to be of particular note (see Appendix 1).

## 3. Key Implications

The new guidance supplements, amplifies and supports existing policy, as set out principally in the National Planning Policy Framework (the Framework). It does not therefore change existing or create new policy, and must be read, understood and applied in this context. The ministerial statement identified 13 points of particular note, listed as bullet points; see Appendix 1.

Several of the points of particular note reinforce the flexibility afforded to local planning authorities over planning for future housing needs (see points 2, 3, 4, 5, 7, 10, 11, 12 & 13). These are helpful to the council in maintaining its commitment to protect the green belt. At the same time, it should be noted that these measures do not affect the responsibility placed upon local planning authorities by the Framework to boost significantly the supply of housing and to ensure that Local Plans meet the full objectively assessed needs for market and affordable housing. The underlying objective remains finding a sustainable form of development.

The points of particular note will have little or no impact on our work in preparing the Borough Local Plan because we were already working largely on the basis described.

#### 4. Financial Details

There are no direct, significant financial implications.

## 5. Legal Implications

The National Planning Practice Guidance is a material consideration and where relevant must be taken into account by decision makers in preparing new policy documents, in determining planning applications and other planning decisions.

#### 6. Value for Money

The national guidance supersedes a range of longer standing sources of guidance. There may be some time saving as a result of the reduction in the quantum of material available that planning officers must take account of. This may be off-set by additional time required to negotiate agreed approaches where previously guidance would have set the parameters. There is no practical means to quantify and anticipate these differences in time and therefore cost. They are considered unlikely to be significant in any one year.
