Title: REVIEW OF DESIGNATED PUBLIC PLACES ORDER

(ALCOHOL CONSUMPTION)

# 1. SUMMARY

1.1 Section 13 of the Criminal Justice and Police Act (2001) introduced Designated Public Places Orders (DPPOs) to replace drinking byelaws (which ceased to have effect from 1<sup>st</sup> September 2006). DPPOs (also referred to as Alcohol Free Zones) are a tool that can be used by local authorities to deal with problems of anti-social drinking in public places. Once in place a DPPO enables Police Officers and Police Community Support Officers (PCSOs) to use their confiscation powers to enforce the restriction. It is not an offence to consume alcohol within a designated area, but failure to comply with an Officer's requests to stop drinking and surrender alcohol without reasonable excuse is. Refusal to comply with an Officer's requests to refrain from drinking can result in a fine of up to £500.

- 1.2 In July 2002 a Designated Public Places Order was sealed by Full Council. Full Council extended this in May 2006 through the introduction of a new order to include streets in the Pinkneys Green area of Maidenhead. Both orders were based on evidence of alcohol related problems and both were subject to consultation before being sealed.
- 1.3 On 23<sup>rd</sup> October 2008 Cabinet gave authority to commence consultation regarding extending the borough's Alcohol Free Zones. This report now seeks authority to introduce a new order. The proposal is to revoke the existing orders made in 2002 and 2006 and seal a new order encompassing the streets currently covered in the existing orders and the new streets that have been identified as having sufficient evidence of alcohol related problems taking place (see Appendix A for the list of proposed streets/areas). The proposal is to revoke the existing orders at the same time that the new order is sealed, so there will not be a period of time where the existing areas are not covered by an order.

## 2. RECOMMENDATION

That Council be recommended to approve the revocation of the two existing Designated Public Places Orders and seal the proposed inclusive order.

What will be different for residents as a result of this decision?

Alcohol related disorder and anti-social behaviour will be restricted by increasing the number of public places where there are restrictions on public drinking.

#### 3. SUPPORTING INFORMATION

# 3.1 Background

- 3.1.1 Section 13 of the Criminal Justice and Police Act (2001) allows Local Authorities to designate public places where there is reasonable evidence that nuisance or annoyance to the public or disorder have been associated with drinking in that place. The Community Nuisance and Disorder Information System (CADIS), which is a system that is based on police records and borough data, has been used to compile a list of recommended streets that should be covered by a new order based on figures of alcohol related anti-social behaviour for the calendar year 2007. Areas can only be included if there is reasonable evidence of alcohol related anti-social behaviour taking place (i.e. properly recorded borough or Police data, or evidence of alcohol related litter). All the areas proposed for inclusion have received agreement from the Police.
- 3.1.2 The DPPO powers are not intended to disrupt peaceful activities, for example, families having a picnic with a glass of wine. The Police would only be expected to challenge an individual consuming alcohol if the individual is causing a problem. Section 13 of the Criminal Justice and Police Act makes it clear that the power is to be used explicitly for addressing nuisance or annoyance associated with the consumption of alcohol in a public place.
- 3.1.3 DPPOs do not address problems caused by underage drinking; there are already Police powers in existence to tackle this.
- 3.1.4 The procedure for introducing a DPPO is set out in the Local Authorities (Alcohol Consumption in Designated Public Places) Regulations 2007. These regulations include the consultation, publicity and signage requirements. ## 4 OPTIONS AVAILABLE AND RISK ASSESSMENT

# 4.1 Options

#### 4.2 Risk assessment

- 4.2.1 A risk assessment has been carried out. It identifies that if the decision is taken not to extend the borough's alcohol free zones then it will affect the borough's capability to address alcohol related anti-social behaviour and the associated crime and disorder. This is because some of the streets experiencing alcohol related anti-social behaviour are not covered by the current orders.
- 4.2.2 The main risks associated with extending the borough's alcohol free zones are as follows:
  - The DPPO may lead to nuisance or annoyance to the public or disorder associated with public drinking, being displaced into immediately adjacent areas that have not been designated. Adjacent areas to those highlighted as hot spots have been placed under consideration for inclusion where there is evidence to suggest that displacement may occur (i.e. where the order may lead to nuisance or annoyance to the public or disorder associated with public drinking, being transferred into immediately adjacent areas that have not been designated). For example, in the case of Inner Windsor, a zone has been proposed to help prevent displacement.

- Limitations in Police resources may limit the ability to enforce the order. Signs put up in the areas covered, to notify the public of the restrictions in place, should help to deter people from irresponsible drinking in public.
- The effect of the order should be minimal on most licensed premises situated within the proposed areas. The order does not relate to those drinking within premises, it applies only to drinking in public places. If clients go outside of a licensed premises with drinks and stray beyond the legal curtilage then they could be at risk of a fine if they do not desist from drinking if asked to do so by the Police.

# 5 CONSULTATIONS CARRIED OUT

- 5.1 All ward members have been consulted on two occasions (14<sup>th</sup> August 2008 and 13<sup>th</sup> October 2008).
- 5.2 Consultation has been carried out in line with government regulations. The law requires consultation with relevant stakeholders including the Police, Parish Councils and Licensed Premises in the areas to be affected and this exercise took place prior to consultation with the public. The Police are in support of extending the boroughs Alcohol Free Zones.
- 5.3 The law requires local authorities to consult with the public over a period of 28 days before an order can be introduced. A public notice was published in the local press on 4<sup>th</sup> December 2008, identifying the areas proposed for designation, setting out the effect of the order and inviting representations as to whether or not the order should be made. Maps of the proposed locations were also made available for the public to view. All representations received as a result of the public consultation have been considered by the Project Team and the Police. The law stipulates that areas can only be included if there is reasonable evidence of alcohol related anti-social behaviour taking place and new locations can only be included on this basis.
- 5.4 Throughout the consultation process there have been a mixture of responses, all of which have been carefully considered. Only one representation was received (from a member of the public) to express non support of the extension on the view that it shifts public drinking problems elsewhere. Eight representations were received suggesting additions to the proposed order (four of which suggested the same location). Out of the five locations suggested, two were approved and three were declined. A further representation was received from a Parish Council requesting that the order apply only at certain times but this is not possible as the order is valid 24/7.
- 5.5 Please see the table in Appendix A which shows the proposed streets/areas. Maps of the proposed locations will also be made available in the members' rooms.
