#### 1 PURPOSE

1.1 As schools convert to academies, membership of the Forum must be reviewed so that it remains representative. This paper summarises the changes needed to ensure membership of the Schools Forum proportionately reflects the numbers of pupils in primary and secondary maintained schools, and academies, as required by Schools Forum legislation, and recommends a reduced membership for September 2013.

#### 2 SCHOOLS FORUM IS RECOMMENDED TO:

- 2.1 Reduce the current membership of the RBWM Schools Forum from 20 members to 17, consisting of 15 school members and 2 non school members.
- 2.2 To note the reconstituted membership of the Forum reflecting academy conversions as at September 2013.

#### 3 SUPPORTING INFORMATION

- 3.1 Schools Forum Regulations set out the framework for the membership and practices of Schools Forums. Current membership requirements are:
  - Schools Forums should include school members (headteachers and governors of maintained and academy schools) and non-school members
  - 'school' members, representing primary, secondary and academy schools in proportion to the number of pupils in each category, must form at least two thirds of the membership.
  - non-school members must include PVI and 14-19 representatives, and may include others such as Diocesan representatives and union members
  - special schools, PRUs, and nurseries should also be represented if there is at least one
    in the area
  - executive members or 'relevant officers' (e.g. DCS) are not permitted to be members of the Forum.
  - schools members must be elected to the schools forum by the members of the relevant group, or sub-group, in the authority's area.
  - the members of the forum must elect a person as chair from among their number and determine the chair's term of office.
- 3.2 The following requirements, revised in October 2012, are also part of the Regulations:
  - No minimum number of members in a Schools Forum
  - only schools members and PVI representatives can vote on the local funding formula

- a limit to the number of LA attendees participating in meetings unless they are a Lead Member, a Director of Children's Services (or their representative) or are providing specific financial or technical advice;
- LAs are required to publish Forum papers and minutes on their websites
- Schools Forum meetings must be held in public
- a meeting is quorate if 40% of the total membership is present
- the Forum must meet at least 4 times a year.

### **RBWM Membership**

3.3 RBWM's Schools Forum currently has 20 places, of which 18 are schools members and 2 are non-schools members.

- 3.4 'School members' representing academy, maintained nursery and primary, and maintained secondary school, need to be in proportion to pupil numbers. An analysis of October 2012 pupil numbers in nursery / primary, secondary, and academy schools, taking account of expected conversions up to October 2013, shows that the number of representatives in each phase would remain unchanged.
- 3.5 However, we know that by October 2013 a number of existing Forum members will have left. School member vacancies among the academy, nursery and primary, and secondary sector<sup>3</sup> are expected to be as shown in Table 2 in October 2013:

3.6 Prior to October 2012, the minimum number of Schools Forum members was 15. The Government removed this stipulation in October 2012 in an attempt to make the operation of Schools Forums across the country less unwieldy.

<sup>&</sup>lt;sup>2</sup> Academy pupils are treated as one category, regardless of sector. The schools counted as academies are Lowbrook, Datchet St Mary's, White Waltham, St Marys, Charters, Desborough, Furze Platt Senior, Altwood and Cox Green.

- 3.7 Anecdotally, RBWM's current membership of 20 is already larger than most schools forums even though RBWM is one of the smallest LAs n the country. Continuing with a total membership of 20 would mean appointing 4 new Forum members by October 2013. Typically, interest in becoming school members on the Forum has been limited.
- 3.8 School Forum is asked to consider a proposal to reduce RBWM's Schools Forum total membership by 3 from 20 to 17. This would reduce the number of vacancies that would otherwise need to be filled, whilst ensuring a more compact and effective membership. A total membership of 17 would result in a proportional structure shown in Table 3.

- 3.10 Note that under this model there would be one too many maintained nursery/primary representatives than required. We would seek to manage this by not re-appointing to the next vacancy in this sector.
- 3.11 The above changes will need to be reflected in a revised Terms of Reference for the Schools Forum, which would require a change to the relevant section in the RBWM Constitution.
