1 SUMMARY

- 1.1 This paper summarises the changes needed to ensure membership of the Schools Forum proportionately reflects the numbers of pupils in primary and secondary maintained schools, and academies, as required by Schools Forum legislation.
- 1.2 Schools Forum are recommended:
 - 1.2.1 To note the existing membership of the Schools Forum and particularly, that, following the transfer of Knowl Hill to academy in September 2014, there are now two maintained primary vacancies and one maintained secondary vacancy on Forum, see table 1 and 2.
 - 1.2.2 To note the expected changes in pupil numbers in each sector following the forthcoming academy conversions and the effect this will have on the expected composition of the Forum. Specifically that by March 2015 there are likely to be two more academy representatives on Forum and one fewer representative in each of the maintained primary and secondary sectors, as set out in table 3.
 - 1.2.3 In view of this expected change in the composition of the Forum as a consequence of academy conversions, to seek nominations for just one of the two existing maintained primary vacancies, and none for the existing secondary vacancy.
 - 1.2.4 To seek nominations for two new academy representatives over the next six months when the number of academy pupils warrants an increase in the number of academy posts on the Forum.

2 SUPPORTING INFORMATION

- 2.1 The membership requirements of Schools Forums are set out in the School Forum Regulations. These are further defined in RBWM's Constitution and Schools Forum Terms of Reference.
- 2.2 Regulations require the schools membership to represent the Academies and maintained schools in proportion to the number of pupils in each phase and type of provision¹. The constitution includes a commitment to review the proportional representation each year. Head teachers on the Forum representing maintained schools should be endorsed annually by colleagues in their relevant sector.
- 2.3 The current membership on RBWM's Schools Forum is made up of 17 places. Two are for 'non school' members, and 15 are for 'schools' members. Of the 15 school members, 13 are for academy and maintained schools, one for the special school, and one for the PRU (see table 1).

¹ Special schools and PRUs, where they exist in a LA, have to be represented on the Forum regardless of how many pupils they have.

- 2.4 Until recently there was one vacancy among the maintained primary group, and one vacancy among the maintained secondary group. In September 2014, Knowl Hill converted to academy. This does not change the current distribution of places, but it does mean that a governor of Knowl Hill who is also a current member of the Forum, will need to step down as a representative of the maintained primary group. This means the Forum membership will now have two maintained primary vacancies.
- 2.5 Note that a member of the Forum representing a maintained school does not automatically become an academy representative when the school becomes an academy. This would only be the case if there was a vacancy among the academy group, and the person had been formally nominated by academy proprietors. Currently, the four academy places on RBWM's Schools Forum required by the existing distribution of pupils are already filled (see table 2).

2.6 Whilst the current distribution of places is proportionate to the number of pupils in each type and phase of school, this is only likely to be the case for a short time. An analysis of pupil numbers as at July, which takes account of further possible academy conversions up to March 2015, shows that the proportion of pupils in academy schools would increase from 31% to 45%. This would mean academy representatives on the Forum would need to increase from four to six, and maintained primary and secondary sectors would need to reduce by one each, to five and two respectively. See table 3.

- 5.6 This would leave just one vacant post in the maintained primary sector, and none in the maintained secondary sector. Our recommendation to Schools Forum therefore is that nominations are sought for one representative from the maintained primary group, and no attempt is made to fill the remaining primary or secondary vacancies at the current time, as it is very likely that that the number of places in each of these sectors would probably need to reduce again by the end of the financial year, see recommendation 3. It is further proposed that over the next six months, as the new academies convert and existing maintained places on the Forum are 're-assigned' to the academy group proportional to academy pupil numbers, two additional members are sought from the whole group of academy schools (including free schools), see recommendation 4.
- 5.7 Academy representatives are nominated and elected by the proprietors of the academy schools. Representatives are not restricted to head teachers or governors from the Academy Schools and it is a matter for them to decide who is best placed to represent them. Currently three of the four academy representatives are from the secondary phase.
- 5.8 The above changes will need to be reflected in a revised Terms of Reference for the Schools Forum, which would require a change to the relevant section in the RBWM Constitution.
- 5.9 Annex A lists the <u>existing</u> membership and groupings of the Schools Forums based on July 2014 pupil numbers and academy conversions up to the end of October 2014. Annex B lists the <u>expected</u> membership and groupings of the Schools Forums based on July 2014 pupil numbers and academy conversions up to the end of March 2015. The final column of the table shows the required number of representatives based on pupil numbers.
