#### **Report Summary**

- 1. This report deals with the action plan arising from the Berkshire East Dementia Plan, which was approved by the Berkshire East Joint Strategic Commissioning Board and published in 2011. The Board is asked to note the contents of the action plan.
- 2. It recommends that a specific grant from the Department of Health to develop memory services be allocated to continue funding the Dementia Care Advisor which is already funded by the LAA reword grant as agreed at the Health and Wellbeing Board in July 2011
- 3. This recommendation is being made because dementia advisory services are an important component of the dementia action plan, and extending the service will give better value to more people.
- 4. If adopted, there are no financial implications for the Council, as this fixed term post's continuation will be funded by a Dept. of Health specific grant.

# 1. Details of Recommendations

**RECOMMENDATION:** That a specific grant of £25,000 from the Department of Health to develop memory services be allocated from the PCT to the Council to continue funding the Dementia Care Advisor.

### 2. Reason for Recommendation(s) and Options Considered

The Borough's demographic profile as reported in the Joint Strategic Needs Assessment (JSNA) indicates a steady increase in the incidence of dementia among older residents. The Council and NHS Berkshire have a duty of care towards both cared-for and carers, and the dementia action plan contains proposed initiatives that will develop and enhance local services for those with dementia. The 2011 JSNA indicated that dementia is a key priority for Windsor and Maidenhead, with a predicted 71% increase by 2030.

The recommended post of Dementia Care Advisor as previously agreed forms a key part of the enhanced service offering which, when combined with the allocation of LAA reward fund will enable the service to continue for longer than one year. Towards the end of this period, a review of the effectiveness of the post will be carried out, and a further recommendation made to the Board in respect of future service options. The specification for the proposed post has been based on a model implemented by Bracknell Forest Borough Council in 2009, which demonstrated effective outcomes for dementia sufferers and their carers.

Borough residents suffering from dementia, and their carers, are supported to continue living independently and participating in community life. Dementia sufferers will be able to delay moving to residential care services, thus favourably impacting the effects of dementia on NHS and Council budgets.



The Dementia Action Plan for The Royal Borough of Windsor & Maidenhead 2011 – 2012







#### Introduction

The National Dementia Strategy, Living Well with Dementia, was published in February 2009 and was the first ever national strategy document focussing solely on Dementia.

The strategy envisions people with dementia and their carers being helped to live well with dementia at all stages of their condition and/or wherever they are within the health and social care system.

The aim of the Strategy is to ensure that significant improvements are made to dementia services across four key themes:

- improved awareness,
- earlier diagnosis and intervention/support,
- living well with dementia/a higher quality of care., and
- strategy implementation

The Strategy identifies 17 key objectives which, when implemented, largely at a local level, should result in significant improvements in the quality of services provided to people with dementia and should promote a greater understanding of the causes and consequences of dementia.

This vision requires commissioners to take the lead and work with providers across social, health, housing, voluntary and independent sectors to secure and deliver high quality specialist and universal services and support to achieve positive outcomes for people with dementia and their carers to "live well with dementia"

A joint commissioning approach is therefore essential in ensuring this vision is made a reality, and as such the Berkshire East Joint Commissioning Dementia Plan (2011) has been developed for all health and social care organisations in East Berkshire, including Unitary Authorities, Primary Care Trust and voluntary organisations.

The Plan sets out an overarching framework for the next five years for adoption by all agencies in East Berkshire the three localities will develop their own specific action plans which can be monitored by the Joint Strategic Commissioning Board through the East Berkshire Mental Health Local Implementation Team (LIT)

The DH Quality Outcomes for people with dementia: building on the work of the National Dementia Strategy, suggests a revised implementation plan for health and social care localities and their delivery partners. This includes four priority objectives:

- good quality early diagnosis and intervention for all
- improved quality of care in general hospitals
- living well with dementia in care homes
- reduced use of antipsychotic medication

The improvement of community, personal support services is integral to and underpins the four priorities.

The Windsor and Maidenhead Dementia Action Plan, reflects the national and local dementia requirements including DH Quality outcomes for people with dementia: building on the work of the National Dementia Strategy, Equity and Excellence: Liberating the NHS, Liberating the NHS: Transparency in outcomes-a framework for the NHS, The use of antipsychotic medication for people with dementia: Time for Action and the outcomes of our public consultation at the Windsor and Maidenhead Dementia Conference in May 2009 and the Berkshire East Joint Commissioning Dementia Plan 2009 – 2014

The key principles of the local plan are:

- We will work with universal services throughout Berkshire East to deliver socially inclusive provision.
- We will work collaboratively to develop, innovative solutions, which can evidence positive outcomes for people living with dementia, and their carers
- We will ensure that there is equality of access to the range of services and that entry to services is tailored to individual need in line with the principles of personalised care.
- We will provide integrated health and social care wherever feasible.

In this action plan these principles will be developed with new GP clinical commissioning groups following consultations. It is anticipated that the new local authority led Health and Wellbeing Boards will have a key role in overseeing the implementation of this action plan and commissioning priorities identified will be recommended to the Health & Well Being Board This action plan reflects and contributes to the Next Generation Care development.

This Action Plan is divided into the four themes of the national dementia strategy under which the 17 key objectives sit and now include the objectives listed in the *DH Outcomes doc*. which focus on activities that are likely to have the greatest impact on improving quality outcomes for people with dementia and their carers. The *DH quality* outcomes are highlighted in **RED**. These are set out below.

We are writing in the light of the announcement about provision of £10m of additional funding support to social care via Primary Care Trusts (PCTs) for Memory Services. This letter clarifies the expectations placed on PCTs and local authorities (LAs) in spending these resources.

Early diagnosis and intervention for all is one of the Government's four key priorities for improving dementia care as set out in the NHS Operating Framework for 2011/12. The audit of memory services for dementia showed that memory services are in place across most of England and we want to ensure that good services are in place across the whole country. The £10m additional funding will help to support this

The funding will be transferred to PCTs from DH on 29 September and should be transferred from PCTs to LAs by the end of 2011/12 via an agreement under section 256 of the 2006 NHS Act. Details of the PCT level allocations to support these services, which are to be transferred to local authorities are included in Annex A.

PCTs and local authorities need to agree appropriate areas of investment in memory services and the outcomes expected from this investment. This could, for example, include provision of advice and support including information about local care and support services; follow up and review services including peer support, assessment of carers' needs and advice and support on planning for the future. The Department expects that decisions about the use of this funding will take into account the Joint

Strategic Needs Assessment for local populations, and the existing commissioning plans for both health and social care. PCTs should work with local authorities to achieve these outcomes in a transparent, efficient and integrated manner, with local authorities keeping PCTs informed of progress using appropriate local mechanisms.
