- 1. This report deals with the outcome of the 2011 Participatory Budgeting (PB) exercise for the Windsor and Eton area.
- 2. It recommends that members of the Windsor Town Forum decide the allocation of funds for Windsor & Eton priorities as voted on by local residents.
- 3. These recommendations are being made because power was delegated to the Forum by the Cabinet Participatory Budget Sub Committee which met on 21 July 2011
- 4. If adopted, the key financial implications for the Council are the spending of £50,000 on Windsor/Eton residents' priorities.

£300,000 capital budget was set aside for PB in 2011, £125,000 of which was allocated for borough-wide schemes and £125,000 for area-based schemes in Maidenhead (£50,000), Windsor and Eton (£50,000) and Ascot and the Sunnings (£25,000). The final £50,000 is being used for the new neighbourhood online voting scheme.

## 14. Consultation

- 14.1 The 2011 PB exercise gave residents the opportunity to vote for geographic area-based options for spending capital money (for Maidenhead & surrounds, Windsor & Eton and Sunningdale & Ascot).
- 14.2 The project options for the geographic area-based schemes were selected in consultation with parish councils, chambers of commerce, town partnerships, town forums and taking into account suggestions from other local organisations and interest groups.
- 14.3. The consultation ran between 17 May and 17 June 2011 under the banner Your Local Budget, in line with the national branding of PB. Graphic design for the posters, leaflets and consultation forms was provided free through the Council's Big Society vanguard work with the national PB Unit.
- 14.4 Leaflets containing the questionnaire (attached Appendix A) were delivered

to 61,500 homes and were available through Council offices, libraries, leisure centres and First Stop Shops. The questionnaire was also available online. A public relations campaign was staged to raise awareness, including the use of Facebook and Twitter, and there were email communications with parish councils and local organisations as well as directly with residents who provided their contact details through the 2010 PB exercise so they could be kept up to date about Council services and initiatives.

- 114.5 The consultation attracted a total of 2,963 responses 957 of them online and 2,006 by the return of the postal questionnaire. This is a 20% increase in the response rate over last year's exercise.
- 14.6 The responses have been analysed and the outcome for the Windsor/Eton area was as follows:
  - The Windsor schemes were ranked by 44% of respondents, with the highest proportion of them (37%) selecting pavement repairs and maintenance as their number one priority. There is a sharp drop to the second most popular scheme a contribution towards the Olympic Legacy Bridge (20%). In third place is improved parking facilities on 16%.
  - When residents' top two priorities are taken into account pavement repairs and maintenance remains the favourite on 57%, with improved parking second (37%) and street cleaning and tree care third (31%). The option to contribute towards the Thames Legacy Bridge drops to fourth place with 25%.
