

- Stage 2 PUBLICATION to 28 July Cabinet / 10 August Council (docs to be ready by CMT last week June)
- Stage 3 SUBMISSION to end of Regulation 19 Consultation period (docs to be ready 29th September)
- Stage 4 EXAMINATION to Examination (sometime between Oct 2016 and March 2017)
