REPORT SUMMARY

- 1. This report deals with the urgent decision, taken with the necessary approval of the Mayor in the absence of a Chair of Corporate Overview & Scrutiny.
- 2. The decision was taken to add a £1.6m capital budget to the capital programme to build an extension to Lowbrook School providing classroom space for an additional 120 pupils and making the school a 2FE school on a permanent basis.
- 3. The urgent decision was required as we were required to confirm further school place allocations from the 1st June to comply with our allocation duty and the Academy can only offer the places if there is certainty over the finance of the expansion. The Interim Head of Finance therefore used delegated powers under the Council's Constitution to approve the budget in consultation with the Lead Member for Finance.
- 4. The report recommends that Council acknowledges and notes that this decision has been taken.

1. Details of Recommendations

RECOMMENDED: That Council:

i) Notes the inclusion of a £1.6m capital budget in the 2016-17 capital programme for the construction of an extension to Lowbrook School along with temporary works for September 2016.

2. REASON FOR RECOMMENDATION(S) AND OPTIONS CONSIDERED

- 2.1 The recommendations are made to ensure that an adequate budget exists to cover the costs of the full expansion of the school which includes classrooms and ancillary spaces.
- 2.2 The council has a statutory duty to provide sufficient school places for every school age child whose parents request one. We receive capital grant funding to support the provision of these so called "basic need" places. Our forecasts of demand have indicated September 2016 would be the highest level and that the investment programme currently approved would provide sufficient places. That is how the admissions round has played out in the Maidenhead area.
- 2.3 However within the sub area of Cox Green, the level of demand has been particularly high and all of the schools are full, with a significant number of pupils being offered schools outside of the area. Specifically 96 families applied for the 30 places available at Lowbrook Academy. Those 30 places were allocated to 2 Children in Care and 28 children with siblings already in the school. 3 siblings were not offered a place and none of the 24 first children living in the catchment area were offered a place.
- 2.4 The school does not have the physical building to accommodate more pupils, however through the use of an adjoining piece of land, leased to Cox Green Academy, it is possible to extend the school to make it a 2 FE school on a permanent basis. The cost of the building project is estimated at £1.6m for an additional 120 places. This is £13.3k per place which is lower than the primary school average level of £13.7k published by the Education Funding Agency in February 2016 and represents good value in school expansion terms.

4. FINANCIAL DETAILS

4.1. The urgent decision was taken primarily to commit £1.6m to the Lowbrook Academy for this project, the first £375k of which will be spent in the remainder of 2016 to accommodate 30 extra children from September 2016.

5. LEGAL IMPLICATIONS

5.1 A strip of land that is currently leased by the Council to Cox Green School will be transferred to Lowbrook School for the new classroom. The lease will be reassigned to Lowbrook School.

6.1 Careful budget monitoring and detailed discussions with the school are intended to ensure the project comes in on budget and that value for money is achieved.
