THIS CONVEYANCE is made the 27th day of May 1954 by THE RIGHT HONOURABLE ALEXANDER THOMAS CLAIR VISCOUNTS GAGE (hereinafter called "the Vendor") of the first part THE PUBLIC TRUSTEE of the second part and THE MAYOR ALDERMEN AND BURGESSES OF THE BOROUGH OF MAIDENHEAD in the County of Berks acting by the Council (hereinafter called "the Council") of the third part

WHEREAS

(1) By a Vesting Assent dated the fifth day of March One thousand nine hundred and fifty-three and made between the Public Trustee of the one part and the Vendor of the other part the property hereinafter described together with other property was vested in the Vendor in fee simple upon the trusts declared concerning the same by the Resettlement dated the twenty-sixth day of April One thousand nine hundred and ten and made between the Right Honourable William Henry Baron Desborough of the first part the Honourable Julian Henry Francis Grenfell of the second part the Right Honourable Ethel Anne Priscilla Baroness Desborough of the third part and Mackworth Bulkeley Praed Herbert Haynes Twining and Charles Patrick Johnston of the fourth part or upon such other trusts as the same ought to be held from time to time and that the Public Trustee was the Trustee of the said Resettlement for the purposes of the Settled Land Act 1925

(2) The Vendor has agreed with the Council for the sale to them of the unnumbered fee simple in possession of the property hereby conveyed at the price of Twelve thousand one hundred pounds (£12,100)

NOW THIS DEED WITNESSETH as follows:-

1. IN consideration of the sum of Twelve thousand one hundred pounds (£12,100) paid by the Council by the direction of the Vendor to the Public Trustee (the receipt whereof the Public Trustee hereby acknowledges and the payment whereof in manner aforesaid the Vendor hereby acknowledges) the Vendor as trustee in exercise of the power in this behalf conferred on her by the Settled Land Act 1925 and of every other power enabling her in this behalf hereby conveys unto the Council ALL THAT piece or parcel of land situate at Maidenhead aforesaid containing 135.101 acres or thereabouts comprising Maidenhead Golf Course and Rushington Copse and being Enclosures Pt. 491 491i 492 and 513 on the Ordnance Survey Map for the Parish of Maidenhead which said piece or parcel of land is more particularly delineated on the plan annexed thereto and thereon coloured pink TO HOLD the same unto the Council in fee simple

2. THE Vendor hereby assigns to the Council all such rights vested in her in respect of her claim under Part VI of the Town and Country Planning Act 1947 as may be found to be attributable under the provisions of future legislation to the land hereby conveyed or any part thereof and covenants that she will from time to time at the request and cost of the Council do and concur in doing all such acts and things as may be necessary or desirable to secure that any such claim should be assessed at the maximum possible amount

3. THE Vendor hereby acknowledges the right of the Council to the production of the documents specified in the Schedule hereto and to delivery of copies thereof

IN WITNESS whereof the Vendor has hereunto set her hand and seal the Public Trustee has caused his Official Seal to be hereunto affixed and the Council have caused their Common

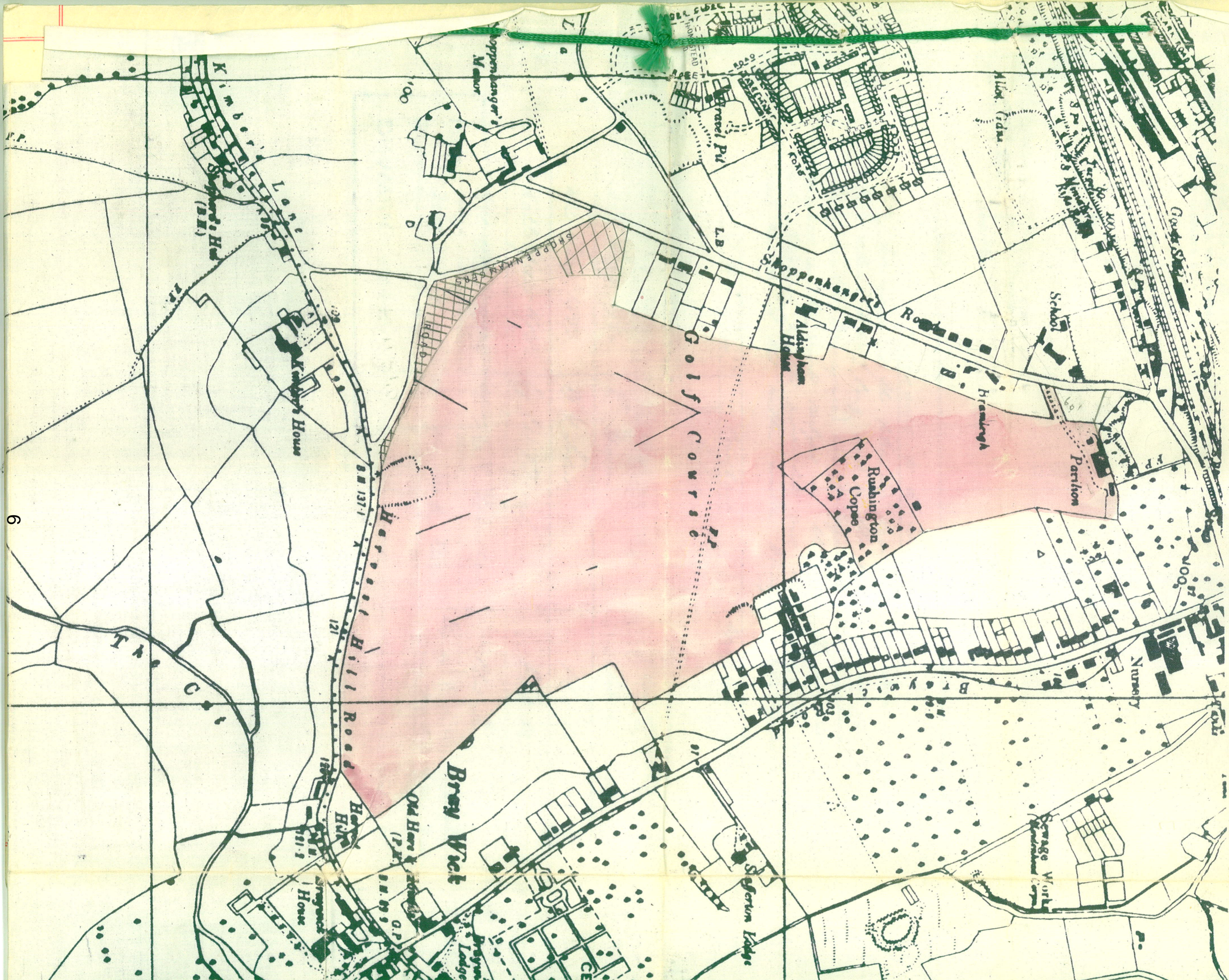
