#### REPORT SUMMARY

Cabinet considered an urgent report on 12<sup>th</sup> June 2020 pertaining to the short-term introduction of free parking for residents to support the reopening of town centres (which formed part of the Covid-19 recovery planning).

The reason the decision was urgent and hence not subject to call-in is due to the wish to introduce the revised scheme by Monday 15 June in line with shops reopening. The Mayor, in the absence of an appointed Chairman of the relevant Overview and Scrutiny Panel, agreed that any delay would not be in the public interest.

In line with Part 3B, Paragraph 4b)of the constitution (Urgent Decisions Outside the Budget or Policy Framework) there is a requirement for the decision taker to provide a full report to the next available Council meeting explaining the decision, the reasons for it and why the decision was treated as matter of urgency. Hence, this report to Council.
