1. PURPOSE AND SUMMARY

1.1 The purpose of this report is to seek the views of Forum on the proposed priority areas of budget allocation with the High Needs Block for 2021/22. The High Needs Block allocation is set out nationally by the Department for Education and the local authority has the authority to determine how it is spent, in line with the detailed regulations.

2. **RECOMMENDATIONS**

Schools Forum is asked to:

- note and comment on the contents of this report.
- provide feedback on the priorities as set out in table 1 which the local authority will use to develop the High Needs Block budget for 2021/22.

3. REASONS FOR CHANGE

- 3.1 The High Needs Block budget is currently forecast at an in-year deficit of £810,000 for 2020/21, leading to a cumulative Dedicated Schools Grant deficit of £1,233,000. This deficit requires the local authority to provide a deficit recovery plan to the Department for Education and the main element is a review of the High Needs Block expenditure.
- 3.2 Since the local area inspection of services for young people with additional needs, there has been a three year pilot of a number of system changes to increase the effectiveness of the system for young people and to drive up inclusivity. That funding ends in the current financial year and consideration needs to be made about securing the progress that has been made.
- 3.3 The council is undertaking formal consultation on opening four new resource bases in primary schools from September 2021 and will need to ensure there is sufficient resource allocated from the High Needs Block to enable those units to recruit staff and develop in due course.

4. PRIORITY AREAS FOR THE HIGH NEEDS BLOCK

4.1 Table 1 sets out, *in order*, the proposed priority areas of expenditure from the High Needs Block along with the rationale, including if the duty is statutory or required by regulation.

5. **IMPLICATIONS AND NEXT STEPS**

- 5.1 With the increasing number of pupils with Education, Health & Care Plans (1,008 in August 2020) there will be further pressure on the High Needs Block which means there will be less choice in the allocation of the block.
- 5.2 The detailed regulations continue to restrict the range of services which can be charged directly to the DSG, with the national focus being on delegating funds to schools. It is therefore likely that some services will only continue on a system wide basis if a buyback / retention is agreed by the Forum when setting the budget.
- 5.3 The Local Authority will make a detailed High Needs block plan for adoption as part of the overall Dedicated Schools Grant budget to be approved by the Forum in late 2020.
