#### **Homelessness and Rough Sleeping Strategy**

#### Background:

Royal Borough of Windsor & Maidenhead

In 2018, the Council approved a five-year Homelessness and Rough Sleeping Strategy. The Homelessness and Rough Sleeping Forum is the delivery vehicle for the strategy, which reports to the Health and Wellbeing Board. The Forum met on 30 June 2021.

## Strategy priorities

During its lifetime the strategy seeks to:

- Reduce the numbers of people becoming homeless
- Reduce the numbers of households in temporary accommodation and improve the quality of that accommodation
- Support people into good quality affordable and sustainable accommodation options
- Reduce rough sleeping and support those who find themselves on the street
- Improve the customer service provided to people approaching housing services
