Ecologist: The bat survey report identified a small number of localized features suitable for use by roosting bats where there is cladding on the dormer window. The report recommends a precautionary approach. This advice should be secured via a planning condition.	Noted and condition added.	Condition added.

#### 3. ADDITIONAL CONDITION RECOMMENDED FOR INCLUSION IF PERMISSION IS GRANTED

3.1 Works which could affect identified potential bat roost features shall be undertaken under the

supervision of an appropriately qualified ecologist [full member of CIEEM and or a Natural England Bat licence holder with experience of supervising demolitions/works where there is a risk of bats being present]. Works are to follow a method statement agreed between the ecologist and the contractor detailing techniques, including the careful removal of tiles by hand, and the procedure to follow should bats or signs of bats be found. A closing-out report including details of the methods used, and any bats or signs of bats found, is to be issued to the council.

Reason: To ensure that bats, a material consideration, are not adversely impacted upon by the development.
