What magic bullet does the RBWM have to address this?	Davey	The Council's approach to addressing this issue is focussed around enabling residents to choose healthy behaviours. We have recently commissioned an app aimed at helping residents to understand their drinking, and the impact it is having on their health, to support reduction in drinking. We have a smoking cessation service in place. In addition to this we will be exploring options for how we can best deliver healthy behaviour support to our residents, e.g. an integrated service (looking at diet, physical activity, smoking and alcohol), digital, face-to-face. We will also be working with colleagues across East Berkshire and Frimley ICS to review the evidence base, identify best practice and consult with key stakeholders, to ensure that those that need the support the most receive it.

The BLP has identified a need for 434 AH for each year of the plan, which equates to 9,000 over the life of the plan. So far less than 1,000 have been delivered. That means for the remaining 12 years of the plan 740pa are required. This target of 1,000 means 200 pa, way below what is required. This target needs to be significantly revised upwards.	Price	The Borough Local Plan is prepared on an evidence base which includes the Strategic Housing Market Assessment which identified a net need for 434 affordable homes, the Housing and Economic Land Availability Assessment which looks at the potential availability and deliverability of land for housing, and a Viability Assessment which is necessary to ensure that policies are realistic and the total cost of all relevant policies is not of a scale that will make the plan undeliverable.

This is made clear in paragraph 7.11 of the Borough Local Plan which states: '7.7.11 On the basis of the results of the SHMA and the HELAA, it is clear that the Council will not be able to deliver sufficient affordable housing to meet the level of identified need. The Council will therefore explore opportunities to deliver affordable housing from other sources of sites. The details will be determined on a site-by-site basis through negotiation.' Essentially it is impossible to meet the identified need on the basis of sites which have been identified as available and deliverable in the plan period. That said, circumstances often change over a plan period and windfall sites (those which are not identified at the stage of plan making) often come forward over the years. It is hoped such sites may provide additional affordable housing to contribute to the need and the policies in the plan would secure this.
			The target within the Corporate Plan is based on the likely housing trajectory arising from the adoption of the Borough Local Plan, which is ambitious but should also be achievable. It is also a significant positive step change in affordable housing when compared to delivery over recent years as recorded in the Council's Annual Monitoring Reports. While the Council would obviously seek to maximise affordable housing wherever possible and would love to exceed the goal, it is prudent to set the targets based on accurate evidence and planned delivery and would not be appropriate to set a target which would be unachievable.

We also consulted with the police regarding violence connected to the NTE against women. There have been 40 reported non domestic serious sexual assaults since 2019 during Windsor's NTE. The murder of Sarah Everard and the constant media and social media communications have heightened the publics perception of
	residents feel safe and secure in their immediate community which is all part of a thriving community. What targets will you set regarding this area, including drug crime and ASB?	Price	safety. The survey showed that women felt most unsafe when exercising in open spaces, mostly during evenings, walking alone. The survey showed a majority would like more uniformed officers, extra lighting and increased CCTV. Although the emphasis of the goal is on women and girls, the 'safety by design' approach, including improvements in lighting and CCTV will benefit all residents.
