MEMBERS' GUIDANCE NOTE

DECLARING INTERESTS IN MEETINGS

DISCLOSABLE PECUNIARY INTERESTS (DPIs)

DPIs include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any license to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where

a) that body has a piece of business or land in the area of the relevant authority, and

b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body **or** (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

PREJUDICIAL INTERESTS

This is an interest which a reasonable fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs your ability to judge the public interest. That is, your decision making is influenced by your interest that you are not able to impartially consider only relevant issues.

DECLARING INTERESTS

If you have not disclosed your interest in the register, you **must make** the declaration of interest at the beginning of the meeting, or as soon as you are aware that you have a DPI or Prejudicial Interest. If you have already disclosed the interest in your Register of Interests you are still required to disclose this in the meeting if it relates to the matter being discussed. A member with a DPI or Prejudicial Interest **may make representations at the start of the item but must not take part in discussion or vote at a meeting.** The term 'discussion' has been taken to mean a discussion by the members of the committee or other body determining the issue. You should notify Democratic Services before the meeting of your intention to speak. In order to avoid any accusations of taking part in the discussion or vote, you must move to the public area, having made your representations.

If you have any queries then you should obtain advice from the Legal or Democratic Services Officer before participating in the meeting.

If the interest declared has not been entered on to your Register of Interests, you must notify the Monitoring Officer in writing within the next 28 days following the meeting.

APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Lynda Yong, Colin Rayner (Lead Member for Highways and Transport) and Carwyn Cox (Lead Member for Environmental Services).

It was announced by the Chairman that the meeting was being recorded.

DECLARATIONS OF INTEREST

None.

MINUTES

That the Part I minutes of the Panel held on the 20 July 2015 were agreed to be correct.

PUBLIC RIGHTS OF WAY MANAGEMENT AND IMPROVEMENT PLAN 2016-2026

The Principal Rights of Way Officer, Anthony Hurst, informed Members that the report sought the Panel's approval to publish the "*Public Rights of Way Management and Improvement Plan 2016-2026*", in Appendix 1. It was noted that all local highway authorities had a statutory duty to publish and review their Public Rights of Way Improvement Plans every ten years. The Principal Rights of Way Officer explained that the Royal Borough's current Plan ran from 2005-2015 and the replacement Plan would cover the period 2016-2026. The Plan before the Panel set out the Council's strategy for managing and improving the public rights of way network and other accessible routes in the Royal Borough over the next ten years. Members were informed that following a statutory consultation on the Draft Plan during August/October a number of comments had been received as set out in Appendix 2, and consequently some amendments had been made to the Plan.

The Principal Rights of Way Officer showed Members before and after photos of improvement works that had taken place throughout the year. Members were informed that there was a total of 307km of public rights of way in the Royal Borough which equated to 32% of the total highway network (967km). The Principal Rights of Way Officer explained the differences to Members between the types of public rights of way (footpath, bridleway, restricted byway and byway open to all traffic).

Members were referred to pages 20 - 21 of the agenda which showed the twelve new or upgraded routes that had been created in the 2005-2015 Plan. The Chairman thanked the East Berkshire Ramblers for all they had done (physical help, funds, etc) for the Royal Borough which was echoed by the Panel. It was suggested that a letter be drafted from the Mayor to thank the volunteer groups involved in the improvement work.

Members were referred to page 22 of the agenda which showed the results of the public satisfaction survey 2015: National Highways and Transport Network. Members were informed that the Royal Borough had scored high in all seven categories and the highest in the South East in the 'provision of information on public rights of way' category. The Chairman praised the Principal Rights of Way Officer and his team for achieving such high scores. It was noted that this success would be promoted in the Around the Royal Borough newsletter.

Members were referred to the Plan on pages 23 - 49 of the agenda which showed the consultation responses. It was noted that the Ascot, Sunninghill and Sunningdale Neighbourhood Plan Delivery Group had put forward a lot of suggestions which could be found on pages 44 - 46. Members noted the proposal that the paths listed on pages 47 - 49 should be recorded as either adopted highway, public rights of way or as permitted paths, although the process for achieving this would require further investigation on a case-by-case basis in discussion with the relevant landowners.

The Principal Rights of Way Officer explained to Members that item 26 referred to establishing a continuous riverside route of the Thames Path in Maidenhead beside the river bank from the landing steps opposite Thames Hotel to Bridge Gardens. It was noted that this was still an aspiration if the opportunity ever arose.

It was requested by the Panel that in order to make it clearer in the report / appendix that the suggestions received were aspirational targets an additional bullet point be added to page 35 to explain that the list of suggestions was a 'wish list' rather than a guaranteed list and that some of the requests may turn out not to be feasible or achievable for reasons out of the RBWM's control. It was also suggested that a sub-group heading be added to page 44 before item 51, to say the proposals had been put forward by the Ascot, Sunninghill & Sunningdale Neighbourhood Delivery Group, and had the support of the RBWM, and to wish them luck with completing the suggestions.

The Principal Rights of Way Officer referred Members to the existing public rights of way and permitted path network maps which were being shown on the big screen. Members were informed that each map included a disclaimer to state they were proposed routes. The Chairman stated that she felt the maps were excellent. It was suggested that ward boundaries be added to the maps.

The Chairman informed Members that the Lead Member for Environmental Services, Councillor Carwyn Cox, had informed her by email in advance of the meeting that there had been twelve events encouraging responsible dog ownership. It was noted that it was difficult to catch owners that did not clear up after their dogs, but wardens were on the look out when they were patrolling. The Chairman explained that the Community Wardens in her ward took this issue seriously as she was sure Community Wardens in other wards did too.

The Principal Rights of Way Officer informed Members that the work on the Thames Path was considered the most significant work planned for the future, along with work on the Hurley footbridge to be replaced by a ramped bridge and repairing damage to the riverbank in Datchet as a result of the floods.

The Chairman informed Members that they could ask the Principal Rights of Way Officer if they required new leaflets for their parish councils and his team would be happy to help design and fund them. It was suggested that joint ward leaflets were also an option.

Thursday 10 March 2016.

The Chairman asked for the Panels thanks to be minuted to everyone who had helped with the improvement works over the past year in particular the East Berkshire Ramblers, the Local Access Forums, volunteer groups and the Rights of Way team and congratulated the Rights of Way Team on being voted the best team in all councils in the South East for the provision of information about rights of way.

The Chairman wished everyone a very Happy Christmas.

1 INTRODUCTION

1.1 General

The Royal Borough as the surveying and highway authority is responsible for the management and maintenance of the public rights of way network in the borough. There are over 300 km (approx. 190 miles) of public rights of way, about a third of the borough's total highway network (see Table 1 for lengths of rights of way by parish).

This Milestones Statement sets out the Council's priorities and targets for ensuring that the network is legally defined, properly maintained and well publicised. The Statement also incorporates an annual update on the Public Rights of Way Improvement Plan 2005-2015 (now replaced by a new Plan to cover the period 2016-2026).

1.2 The Milestones approach

The 'milestones approach' is an effective means of prioritising public rights of way work and measuring performance against an agreed set of targets. This is achieved by:

- setting individual, realistic targets, taking into account the available resources these are the Milestones Targets (see page 6).
- monitoring progress towards achieving the Milestones Targets (see page 19).

1.3 Partnership working

The Council works closely with public rights of way user groups, landowners, parish and town councils, local conservation volunteers, and the borough's Local Access Forum. Two Parish Councils (Cookham and Old Windsor) undertake routine clearance of vegetation from public rights of way in their area on behalf of the borough, as part of the Parish Paths Initiative.

1.4 Volunteers

During 2015/16, a number of volunteer groups worked on public rights of way around the Borough:

The Conservation Volunteers (TCV) carried out **8** work days with a total of **75** participant days.

Ways in Work (WiW) carried out **25 work days** with a total of **149** participant days. Berkshire College of Agriculture (BCA) carried out **19** work days with a total of **107** participant days Pinkneys Green Scouts carried out 1 day's work clearing vegetation and installing waymarks on public rights of way with a total of 25 participants. Ascot and Sunninghill Girl Guides carried out approximately 2 day's work clearing vegetation on public rights of way with an estimated 20 participants. Volunteers from the East Berks Ramblers undertook 338 hours of work, including path surveys and practical works.

1.5 Resources

The Council employs a public rights of way team of 2 full time and 1 part time Public Rights of Way Officers (total 2.7 fte). In addition, the Council's Legal service (*Shared Legal Solutions*) provides legal support, and the Democratic Services team provides secretarial support for administering the Rights of Way and Highways Licensing Panel and the Local Access Forum.



The Council has maintenance responsibility for approximately 175 bridges on footpaths and bridleways on public rights of way in the borough. These bridges are inspected on a rolling programme by the Council's consultants Jacobs, and remedial safety works identified. In some cases this work is reactive, in response to bridge damage caused by public use, flooding, or general wear and tear.

2 **OBJECTIVES** (CHANGES SUGGESTED BY LOCAL ACCESS FORUM SHOWN IN **BOLD ITALIC**)

2.1 Priorities for 2016/17

- Maintenance and enforcement: bring all public rights of way up to an acceptable standard for all users.
- Encourage and support the involvement of volunteers in the maintenance and improvement of public rights of way.
- Equality of service: ensuring that the needs of all users, regardless of race, disability, sexuality, age and religion, are taken into account.
- Ensure that the Thames Path National Trail is consistently safe and easy to use by all members of the public.
- Seek to complete the missing links in the Millennium Walk.
- Partnership working: working with all interested parties in the management of public rights of way, (e.g. Local Access Forum, Parish Councils, Civic Societies, residents associations, user groups and landowners)
- Claims: reduce the backlog of applications to add to or amend the Definitive Map.
- Changes to the network: seek improvements in association with development and other proposals.
- Improvements: seek improvements to the network for horse riders, *cyclists* and people with restricted mobility.
- <u>Enhance and extend the network through</u> <u>the creation of Multi User Routes</u>
- Ensure effective early consultation with interested parties on proposed changes to the network, in accordance with government regulations, circulars and codes of practice.
- Liaise with landowners and occupiers on all public rights of way matters, including updating and advising landowners on changes in legislation.
- Maximise the use of recycled and reused materials in rights of way maintenance where practicable.
- Develop and enhance the information available online for public rights of way, including the use of social media where appropriate.

2.2 Milestones Targets for 2016/17

Well Maintained

WM 1: To ensure that all public rights of way are easy to use by members of the public. (This is the former Best Value Performance Indicator for public rights of way). Target for 2015/16 is **95%**.

WM 2: To carry out major surface improvements/ vegetation clearance on **10** public rights of way.

WM 3: To repair or replace 5 bridges.

Legally Defined

LD 1: To actively progress a minimum of **4** applications to add public rights of way to the definitive map, including resolving significant errors in the map.

Well Publicised

WP 1: To produce <u>3 *leaflets*</u> publicising access opportunities for *targeted user groups*.

WP 2: To assist others to produce effective promotional material. Target: a minimum of **1** new publication.

Improving Access and Connectivity

AC 1: Create 1 new strategic path, either public right of way or permitted, to fill identified gaps in the public rights of way network

AC2: To make 15 physical access improvements, including the replacement of stiles with gates or gaps, to facilitate use by those with special needs, the elderly, people with pushchairs etc.

Enforcement

EN 1: To resolve <u>10</u> enforcement issues.

2.3 Equal opportunities

The Council continues to seek improvements to public rights of way to enable use by a wide range

of people with sensory or physical disabilities or learning difficulties.

The Council supports the establishment of routes suitable for use by disabled people, in consultation with the Council's Access Officer, the Access Advisory Forum, the Windsor and Maidenhead User Network (WAMU) and the Disabled Ramblers.

The Public Rights of Way Management and Improvement Plan and annual Milestones Targets include a number of policies and proposals relating to access for people with special needs.

2.4 Parish Paths Initiative/Big Society

The Parish Paths Initiative (PPI) works with Parish and Town Council's to identify or carry out maintenance, improvement or promotional works on local path networks. All Parish Council's in the Borough and Eton Town Council participate in the PPI scheme.

Additionally, two Parish Councils (Cookham and Old Windsor) undertake routine vegetation clearance on the public rights of way networks in their area. Discussions are being held with other Parishes on whether they would like to adopt similar arrangements in their parishes.

The British Horse Society, East Berks Ramblers and National Trust are also members of the Parish Paths Initiative. The scheme operates a rolling condition survey of all public rights of way in the borough, carried out in partnership with the East Berks Ramblers.

2.5 Local Access Forum

The Local Access Forum is "a partnership to promote and develop sustainable access for the growing benefit of the environment and all in our community". Established in 2003, the Forum is statutory advisory group which advises the Council on the management and improvement of public access to land in the Royal Borough for open-air recreation.

The Forum has discussed and given advice to the Council on the following topics during 2015/16:

- The Rights of Way Management and Improvement Plan 2016-2026.
- The Milestones Targets for 2016/17
- Multi-user routes and bridleways.
- M4 Smart Motorway proposals.

- Ramblers Big Pathwatch.
- Improvements for cycling.
- Proposed diversion of Hurley Footpath 18 at Berkshire College of Agriculture.
- Proposed gating of Eton Footpath 51 at Thameside, Eton.
- Use of volunteers for works on public rights of way.
- Responding to the South Lincs and Rutland LAF consultation regarding a national access forum.

The Forum publishes an annual report detailing its activities.

2.6 Thames Path National Trail

Natural England promotes the Thames Path as one of 13 National Trails in England.

The Thames Path passes through Hurley, Cookham, Maidenhead, Eton, Windsor, Datchet and Old Windsor, where possible following the course of the river. In places the Trail crosses the Thames to follow the Buckinghamshire side of the river.

The Royal Borough recognises both the national and local importance of the Thames Path and is represented on the Thames Path Partnership, which also includes representatives from the relevant Highway Authorities along the route of the Trail, the Environment Agency, the Ramblers, SUSTRANS, Cyclists Touring Club, and Natural England.

2.7 Equestrians

• Investigating possible upgrading of existing footpaths to bridleways, by negotiating with

landowners and user groups, to improve road safety for horses and riders while taking into account the needs of other users. All negotiations must have clear resolutions, and ensure that all users are satisfied with any changes to the status of the footpath(s) before modifications take place, including adequate width and, where appropriate, segregation of users.

- Continuing with an initiative to designate highway verges as horse margins by identifying suitable areas adjacent to the carriageways, and adapting the maintenance of highway verges to enable safe use by horse riders. As an example, a new horse margin has been created adjacent to the Henley Road, to create a safe riding link between Rose Lane and Hodgedale Lane.
- Continuing with an initiative to identify and establish multi-use paths to allow horse riders to use existing cycleways and other tracks where appropriate, and where suitable surfaces can be provided, in conjunction with land owners and Parish Councils.
- Development and promotion of circular riding routes where appropriate, in particular to avoid main roads.
- Improvements to gates to make them more 'horserider friendly'.

3 WELL MAINTAINED

3.1 Maintenance and Enforcement

Table 2 (over page) includes a summary of reported maintenance and enforcement problems.

The number of reported problems outstanding has reduced from **53 to 32** during the course of the year.

Path condition surveys are carried out on a 3-year rolling programme, with approximately 1/3 of the network being surveyed each year. Volunteers from the East Berks Ramblers carry out these surveys on the Council's behalf.

During these surveys the volunteers also check whether problems that had previously been reported and entered onto the Council's rights of way database have since been resolved, and this helps to keep the records up-to-date.

Priority criteria for dealing with maintenance and enforcement problems are listed on page 15 of this Milestones Statement.

3.2 Noteworthy current issues

- Improvements to the Thames Path National Trail
- Replacement of step-stiles with easy access gates

3.3 Access for people with special needs

When dealing with the provision of stiles and gates, an assessment is made to ensure that the appropriate type of barrier is used, and that wherever possible gaps are used rather than stiles or gates.

The Council places high priority on the use of effective designs of barrier to facilitate use by those with restricted mobility, the elderly, people with young children in pushchairs etc.

Service standards, including British Standards for path furniture, are set out on page 16 of this Milestones Statement.

4 LEGALLY DEFINED

4.1 Definitive Map and Statement

The Definitive Map and Statement of Public Rights of Way are legal documents that provide conclusive evidence of the existence and status of public rights of way. It is therefore important that these documents are kept up to date and accurate.

The Map and Statement was last updated in 2015 (effective date 1st November 2015) including all legal changes made since the previous consolidated Map was published in 2008.

Copies of the Map and Statement are available for inspection in Maidenhead and Windsor central libraries, Borough Council offices, and can also be viewed on the borough website.

Copies are also held by user groups and relevant extracts are held by Parish Councils.

4.2 Modification Orders

Definitive Map Modification Orders are made to update the definitive map, to show the effect of legal changes to public rights of way. Copies of the Orders are sent to all those who hold copies of the Definitive Map and Statement, so that up to date information is available

4.3 Rights of way database

The Definitive Map is shown on the Council's GIS system. The Council also maintains a comprehensive public rights of way database, the Countryside Access Management System (CAMS). Information is held on path maintenance records, condition surveys, reported problems, landownership details, and path furniture such as stiles, gates, bridges and signposts.

The Council also maintains a comprehensive electronic library of photographic records covering many of the public rights of way in the borough.

These electronic records enable the rights of way officers to record, analyse and prioritise problems, and respond to public requests for information quickly and effectively.

4.4 Applications to modify the Definitive Map (claims)

There are 7 claims currently being investigated, listed in Appendix 5. A statement of priorities for dealing with claims is shown in Appendix 2.

4.5 Changes to the network

Applications for changes to the network are occasionally received from landowners or developers, and can also be initiated by the Council where they are considered to be in the public interest.

Planning applications are checked by planning officers who consult the Public Rights of Way team and the East Berks Ramblers on applications that may affect public rights of way. The Local Access Forum is also consulted on planning applications affecting public rights of way, and is sent weekly lists of all new planning applications received.

Where appropriate, conditions and informatives are then included in plannings consents.

Policy R14 in the borough's Local Plan states that: "The Borough Council will safeguard and enhance the public rights of way network and recreational cycle routes"

The East Berks Ramblers, the British Horse Society, SUSTRANS and commercial publishers have produced a number of leaflets, booklets and books promoting routes along public rights of way locally, including the Thames Path National Trail.

5.3 Guided walks and rides

Guided walks and rides encourage the public to enjoy the countryside. The Ramblers organize a programme of walks for its members and the general public, and the British Horse Society organize various rides and events using the boroughs public rights of way and minor roads network.

5.4 Borough Website

The Borough's Public Rights of Way web pages on can be accessed directly at

The web pages contain detailed information including publications, report forms, and maps of all public rights of way in the borough.

The Council's MapsOnline service now allows users to view maps showing the locations of all stiles, gates, bollards and signs on public rights of way.

The web pages also include Registers of applications for Definitive Map Modification Orders (DMMO's), and landowner's statutory declarations, together with application forms and guidance notes for path diversion orders.

6. MONITORING AND REVIEW

6.1 Monitoring

The Council publishes a performance indicator which provides a useful benchmark for assessing the condition of the network:

"The percentage of the total length of footpaths and other rights of way which were easy to use by members of the public"

The indicator is calculated using a methodology originally devised by the County Surveyors Society, and is widely adopted by Highway Authorities to enable benchmarking between individual authorities' performance.

The borough's indicator is based on information obtained from condition surveys undertaken by volunteers from the East Berks Ramblers, and the indicator result for the borough in 2015 was 93% (against a target of 95%).

6.2 Review

The Council is committed to working with all interested parties in carrying out public rights of way work in the borough.

This Milestones Statement and Public Rights of Way Improvement Plan will continue be reviewed and published annually and the Milestones Targets will be discussed with the Local Access Forum and other interested parties so that coordinated priorities can be adopted.

Monthly updates on progress towards the Milestones Statement targets are also published on the borough website.

The Public Rights of Way team also produce a 6monthly Path Progress Report, which provides updates on specific path improvements. These reports are submitted to the Rights of Way and Highway Licensing Panel in March and September each year, circulated to the Local Access Forum and published on the borough website.

Statement of priorities for dealing with applications to amend the Definitive Map

The Council aims to process uncontested applications for Public Path Orders and Definitive Map Modification Orders (claims) within 1 year of receipt.

Applications for Orders to amend the Definitive Map and Statement (claims) will be prioritised on the basis of the following factors:

Highest Priority: Closure very likely (e.g. area subject to planning application).

Path currently blocked by planting, fencing etc. which could be removed.

Path currently blocked by permanent structure e.g. building.

Possible threat to path, and/or partial blocking likely.

Lowest Priority: No recognised threat, and route useable by the public.

Statement of priorities for dealing with maintenance and enforcement problems

Maintenance and enforcement problems will be prioritised on the basis of the following factors:

Safety of users

Level of usage

Extent of obstruction of definitive line (i.e. completely obstructed or partially obstructed)

Benefit to public once resolved

Cost/time effectiveness in resolving problem

Number/level of complaints

Potential for deterioration of the problem

Age of the problem

Note: for efficient working practice, lower priority problems will be dealt with alongside higher priority problems where appropriate, for example if they are in the same locality or involve the same landowner. Lower priority problems will also be tackled as required in order to meet specific targets.

Service standards

The Royal Borough of Windsor and Maidenhead has the following key aims in relation to public rights of way:

- To ensure that the borough's public rights of way network is properly maintained and well publicised
- To ensure that public rights of way are safeguarded and enhanced
- To help landowners and users to understand their responsibilities and rights
- To consult and work with interested parties to achieve the provision of a well-maintained and signed network of public rights of way

- Parish and Town Councils
- Natural England
- East Berks Ramblers
- Disabled Ramblers
- British Horse Society
- British Driving Society
- Cyclists' Touring Club
- Sustrans

- Any other interested parties

Comply with **British Standards** on all new structures and furniture, and where possible, upon replacement of existing structures or furniture. BS 5709-2006 gaps, gates and stiles; order of preference; a) gap, b) gate, c) kissing gate, d) stile.

Barbed wire, razor wire, farm type electrical fences and suchlike should not normally be used in the vicinity of structures covered by this standard, but where these wires are necessary then assessment should be made of the effect they have on the safety and convenience of people in the vicinity.

A condensed version of BS 5709-2006 produced by the Pittecroft Trust is available on request from the public rights of way team.

Carry out:

- A condition survey of each path every three years, based on a rolling programme of sixmonthly surveys (in partnership with East Berks Ramblers Association).
- An inspection of rights of way in a dangerous condition within one working day of notification, make safe within one working day of inspection, and inform correspondents of the results within three working days.

Use our powers:

- To enforce and remove any obstructions to the public rights of way network within three months of inspection, and enforce compliance with the Rights of Way Act 1990 (ploughing etc) within 6 weeks of inspection, and give consideration to all available statutory powers including prosecutions where appropriate.
- To process uncontested applications for Public Path Orders and Definitive Map Modification Orders (claims) within 1 year of receipt.
- To inform the correspondents of the reasons for any delay beyond the periods stated above.

Publish:

- The definitive map and statement every five years.
- Information leaflets and updates regularly

Effective management of the public rights of way network has a positive impact on healthy lifestyles by encouraging walking and cycling.

3. DEFINITIVE MAP MODIFICATION ORDER (DMMO) applications (path claims)

3.1 <u>Wraysbury claimed footpaths 501 to 505 (Thamesfield)</u>

Five DMMO applications were received in June 2009 for footpaths crossing land at Thamesfield in Wraysbury. A Village Green application was also received for the land crossed by these claimed footpaths, and the footpath applications were held in abeyance pending resolution of the Village Green application. The Village Green application was refused following a public inquiry held in November 2012. Following a Judicial Review, the Council's decision on the Village Green application was upheld in 2014. The footpath applications are currently being investigated.

3.2 <u>Windsor claimed footpath 502</u>

A DMMO application was received in March 2014 to add a footpath running from Priors Road to Keepers Farm Close to the Definitive Map of Public Rights of Way. An Order was made in December 2014, and as objections were received a Public Inquiry was held on 21st October 2015. The Inquiry Inspector published a revised Order with amendments to the path width: however, a further objection was received to the revised Order, and the matter is currently being reviewed by the Planning Inspectorate.

3.3 Cookham claimed footpath 501

A DMMO application was received in December 2015 to add a footpath running from Strande Lane to Maidenhead Road in Cookham to the Definitive Map of Public Rights of Way, and delete the existing line of Cookham Footpath 48 which runs over the same land. This application is currently being investigated.

4. RAMBLERS BIG PATHWATCH PROJECT

Between July and December 2015 the 'Ramblers' national office organised a major condition survey of public rights of way across the whole of England and Wales. Called the "Big Pathwatch", the survey involved members of the public selecting one or more Ordnance Survey 1km grid squares and walking all public rights of way within that area and recording any problems they encountered (such as blocked paths, missing signs, broken stiles etc.) The results of the surveys were collated by the Ramblers Big Pathwatch project team and circulated to the relevant Highway Authorities. Every two

weeks each Highway Authority (including RBWM) received a report setting out any problems reported in their area. This provided useful feedback, and supplemented the information already provided by the local East Berks Ramblers from their own regular path surveys.

Within the RBWM area a total of 189 grid squares were covered by the Big Pathwatch survey, and almost the entire public rights of way network (303km out of 306km) was surveyed by members of the public taking part in the project. Across England and Wales as a whole, 83,434 km of public rights of way were surveyed.

The 'Ramblers' are currently preparing a full report on the project to be published in the Spring.

5. BIG SOCIETY

5.1 Working with Parish Councils, path user groups and the National Trust

All Parish/Town Councils in the borough, as well as the British Horse Society, East Berks Ramblers and National Trust, are members of the Parish Paths Initiative (PPI). Through this scheme the rights of way officers work directly with the Parish/Town Councils and the voluntary groups on maintaining and improving the rights of way network in the borough. As part of the PPI project, annual grants are paid to Cookham and Old Windsor Parish Council's who organise routine path clearance works in their parishes. A number of successful projects have been completed this year and the partnership continues to deliver benefits to all involved.

5.2 Volunteers

The Public Rights of Way team have worked with The Conservation Volunteers (TCV), Berkshire College of Agriculture (BCA), Ways into Work (WiW) and Sunninghill and Ascot Girl Guides (SGG) to carry out practical work on public rights of way in the borough over the past 6 months. The PROW team is actively looking to expand works with other volunteer groups including local Scouts and Girl Guide groups and other conservation groups.

5.3 Partnership working with the East Berks Ramblers

Local volunteers from the East Berks Ramblers carry out inspections of the public rights of way network in spring and autumn each year, based on a three year rolling programme (i.e. approx. 1/3rd of the network is surveyed each year). The information obtained from these surveys is used to identify and prioritise works, and to calculate the annual performance indicator that measures the percentage of public rights of way that are easy to use. The 'easy to use' figure for 2015/16 is 93%.

6. PUBLICATIONS

<u>Public Rights of Way Milestones Statement 2016/17</u> The Milestones Statement for 2016/17, which sets out targets and priorities for the coming year, has been submitted for approval by the Rights of Way & Highways Licensing Panel at its meeting on 10th March 2016.

The "Public Rights of Way Management and Improvement Plan 2016-2026" came into effect on 1st January 2016. Annual updates are published as part of the Milestones Statement.

1 Welcome, apologies and introductions

The Chairman Peter Thorn welcomed everyone to the thirty-third meeting of the Local Access Forum.

The Chairman explained that very sadly in August 2015 Gordon Harris had passed away. It was noted that Gordon had been on the Forum since 2006 and that this meeting would be held in memory of him.

Apologies for Absence were received from James Copas, John Foulger, Tom Jarvis, Andrew Nye and Rachel Forsyth.

The Forum approved the minutes of the meeting held on 24 June 2015.

<u>Matters arising from last meeting</u> Andrew Fletcher referred members to pages 13-28 of the agenda.

Action (AF): Item 1(c) That Andrew Fletcher would look into whether there we any options to put in a crossing at the Bisham roundabout as the 3 options had been dropped.

Councillor Beer arrived.

Action (AF): Item 1(c) That Andrew Fletcher would ask Sharon to update the horse margin as concerns had been raised about the barrier as a number of accidents had taken place and it was felt that someone might die soon.

2 Members' update

None received.

3 Membership update

Election of Chairman and Vice-Chair

Andrew Fletcher informed the Forum that one nomination had been received for the Chairman's position, that of Peter Thorn. It was noted that Peer Thorn had been invaluable on this Forum and it was hoped that he would continue in his role. Councillor Hunt proposed Peter Thorn as Chairman, which was seconded by Christine Gadd.

Unanimously agreed: That Peter Thorn would remain as Chairman for the next two years and the Vice-Chair position to remain open until the next meeting.

Andrew Fletcher explained that the Forum membership was made up of a balance of 53% user interests, 29% land management, 6% other interests and 12% RBWM Councillors. It was noted that Slough had a disabled Members on their LAF who was happy to give the Royal Borough advice re: disabled access when needed.

Action (AF): That Andrew Fletcher would write to everyone who had resigned (particularly Chris Westacott who was very ill) to thank them for their time on the Forum.

It was noted that the Royal Borough were able to jointly fund training with other Local Authority LAF's.

Action (ALL): That anyone interested in being trained to let Andrew Fletcher know by the first week in December and to let Andrew Fletcher know what were the areas of interest.

LAF Fast Response Team membership

Andrew Fletcher informed the Forum that the LAF Fast Response Team looked at issues outside the Forum meetings in order to meet deadlines and reported back to subsequent meetings. It was noted that these issues tended to be handled via email as it was less time consuming than meeting face to face. Andrew Fletcher stated that additional LAF members were needed on the LAF Fast Response Team.

Action (ALL): That ideally two new members to the Fast Response Team were needed - anyone interested to let **Andrew Fletcher** know by the first week in December.

4 Rights of Way Management and Improvement Plan 2016-2026

Andrew Fletcher informed Members that the purpose of this report was to consult the Forum on the outcome of the "Draft Royal Borough of Windsor and Maidenhead Public Rights of Way Management and Improvement Plan 2016-26" public consultation and to seek the Forum's endorsement of the Final Plan.

The Chairman explained that the Royal Borough had received a commendation from Natural England to say good effort / approach and congratulated officers on their hard work, which was echoed by the Forum.

The Chairman went through the "Draft Royal Borough of Windsor and Maidenhead Public Rights of Way Management and Improvement Plan 2016-26" (pages 33 – 57 of the agenda) page by page and the following comments were noted / agreed:

• It was noted that the annual risk assessment of the Thames Path Nation Trail was felt not to gain any new / useful information and it was proposed by Andrew Fletcher that this be stopped in the future. The Forum suggested that instead of an annual assessment, a risk assessment should be conducted in response to an extreme weather event (such as flooding), and also to ensure that all waymarks along the Thames Path have RBWM telephone numbers on them. EBR also stated that they could arrange for a dedicated Thames Path warden as well.

Unanimously agreed: That the annual risk assessment no longer needed to take place.

Unanimously agreed: That a monthly update of issues and what had been done to resolve them be added to the RBWM website / be circulated to Forum members & Parish Councils.

Unanimously agreed: That the wording on page 37 1.2(b) include 'in consultation with public ROW team on major developments'. Parish councils were also thought to be key to identifying these areas.

Unanimously agreed: That the wording on page 38 1.5(c) include Community Wardens.

Unanimously agreed: (page 39 2.1(a)) to a minimum of 2 cuttings per year.

Unanimously agreed: (page 44 2.23) To add an additional identified needs section in about increasing multi-user routes (for horse riding & cycling).

Councillor Beer left the meeting.

Unanimously agreed: (page 47 3.6) To add in improve communication / responses on issues and problems & to ensure signage has contact telephone numbers on them. This was a target to improve Community responses rather than communication responses.

Unanimously agreed: That Woodland Path be added (B.Hill Recreational Ground to F/Path 13).

Action (AF): Re: A404 - that Andrew Fletcher contact Highways England and also change the wording to emphasise safety re: the Bisham roundabout crossing.

Unanimously agreed: (page 53 ref: 26) To add in the wording 'to establish a continuous riverside route'.

Unanimously agreed: The overall plan (pages 31-47) was agreed subject to the changes noted above.

Action (AF): That Andrew Fletcher send a copy of the final plan to the Forum members once it had been to the Rights of Way & Highway Licensing Panel on the 7 December 2015.

5 Milestones Statement and Annual Targets for 2016-2017

Andrew Fletcher informed the Forum that this report was to consult the Forum on the priorities, targets and service standards to be included in the Milestones Statement & Public Rights of Way Improvement Plan Annual Review 2016/17.

The Chairman explained that the views of the Forum were requested on the following:

- Priorities for 2016/17: Were there any recommended changes to the priorities listed in the current 2015/16 Milestones Statement (Appendix A)?
- Milestones Targets for 2016/17: Were there any recommended changes to the Milestones Targets listed in the current 2013/14 Milestones Statement (Appendix A)?
- Service Standards for 2016/17: Were there any recommended changes to the Service Standards listed in the 2015/16 Milestones Statement (Appendix A)?

Andrew Fletcher gave Members a brief overview presentation which was agreed would be emailed out with the minutes.

Andrew Fletcher informed the Forum that over the last five years the number of issues had reduced from 314 to 42 which he was very proud of. It was noted that the issues considered 'cold cases' had not been included in his figures as suggested by the Rights of Way & Highway Licensing Panel. The Forum congratulated Andrew Fletcher

and his team on such a fantastic achievement.

It was noted that it had been agreed with Violia that they would collect rubbish bins in agreed locations (in this case at the entrance points of Cookham Brtidleway 19) but it was not possible to place rubbish bins at every location along public rights of way because the refuse collectors will not walk great distances to empty them.

The Forum were shown before and after photos of:

- Bray Footpath 41 stile replacement by conservation volunteers.
- Old Windsor Footpath 2 surfacing works.
- Cookham Bridleway 19 surfacing works.
- Hurley Footpath 25 surfacing works.
- Datchet Footpath 8 bank repair works a joint scheme between the Royal Borough and the National Trails Office (50/50 funding of £10,700).

Peter Thorn informed the Forum that Andrew Fletcher had been very pro-active in engaging the volunteers for which he was congratulated.

It was noted that the priorities and targets could be found on page 97 of the agenda.

Action (AF): That Andrew Fletcher add cyclists & enhance multi user network to the ninth bullet down on the priorities for 2015/16.

Unanimously agreed:

- That no changes were requested to be made to the priorities listed in the current 2015/16 Milestones Statement.
- That the targets remained as proposed bar LD1 being left blank, WP1 being increased to 3 and the wording be changed to 'targeted user groups', WP1 to include updating current leaflets & EN1 being reduced to 10.
- That the service standards wording was agreed.
- That a vote of thanks be given to the team of 2.8.

6 Proposed diversion of Hurley Footpath 18 at Berkshire College of Agriculture

Andrew Fletcher referred Members to pages 99 – 102 of the report.

It was noted that the purpose of the report was to consult the Forum on the proposal to divert Hurley Footpath 18 at Berkshire College of Agriculture.

Members were informed that Hurley Footpath 18 ran from Hall Place Lane in Burchetts Green to the junction of Hurley Footpath 17 at Prospect Hill in Hurley. It was noted that the route of the path took it through the centre of the Berkshire College of Agriculture campus.

Andrew Fletcher explained that the Berkshire College of Agriculture was considering applying for a diversion of the centre section of this footpath to take the path around the main buildings of the college instead of running through the centre of the complex. It was noted that a map detailing the proposed diversion could be found in Appendix A of the report.

Councillor Hunt expressed her concern that children and young adults used the area / campus and that the new route would allow walkers to walk through the area without being noticed. Andrew Fletcher explained that the Berkshire College of Agriculture had considered alternative route to the south and had discounted it.

Action (AF): Andrew Fletcher to give feedback to say that the Forum had no objections to the proposal made by Berkshire College of Agriculture.

Action (AF): Andrew Fletcher to request that an information board be added to the bottom of the statue and ensure the bridleway access was OK.

7 Looking forward issues

Andrew Fletcher informed the Forum that he had nothing prepared for this item as he was seeking views on ways to improve cycling, bridleways and disabled access, etc.

Action (AF): Andrew Fletcher to write to the Parish Councils to ask them to help identify and prioritise which bridleways needed linking.

Action (ALL): That suggestions be sent to Andrew Fletcher by the first week in December.

8 South Lincs and Rutland LAF consultation: Making our needs known and future of permissive access

The Forum was referred to pages 103-116 of the agenda.

The Chairman explained that the South Lincolnshire and Rutland Local Access Forum, working with the Mid and West Berks Local Access Forum had sent a proposal and consultation document to all Local Access Forums advocating the re-instatement of a modified "England Access Forum" to work and advise on specific 'nationally significant' issues. It was noted that in addition to this proposal, the South Lincolnshire and Rutland LAF were seeking the opinion of the Forum regarding the future of permissive access in stewardship schemes nationally.

The Chairman went onto explain that the proposal prepared by the South Lincs and Rutland LAF was included in the agenda as Appendix A to the report and that accompanying the proposal was a consultation document asking various questions, which was attached as Appendix B to the report.

The Forum were invited to consider and discuss the report and respond to the consultation questions.

Action (GM): Gordon Marrs to inform Andrew Fletcher of the ones the RBWM had lost.

The Chairman expressed his concerns that there could potentially be issues that the Royal Borough were not consulted on and that he saw this as a group to help raise the Forums profile.

It was suggested that the Forum be more reactive and focus its efforts more on how to solve issues once the Stewardship Scheme had gone rather than trying to influence Government.

Unanimously agreed: That the Forum would prefer to tackle issues at a local level and not support the proposal re: national support.

9 LAF Monitoring items

The Forum was referred to pages 117-120 of the agenda.

It was noted that the purpose of the report was to update the Forum about the status of projects on the LAF regular monitoring list and to seek the Forums advice regarding the members' discussion forum.

Thames Path 'missing link' at Bridge Gardens

Andrew Fletcher showed the Forum before and after photos of Bridge Gardens roadside path which was now in place but explained that the riverside route was still included in the Plan.

Deregulation Bill update

Andrew Fletcher informed the Forum that the Deregulation Bill had been passed and received Royal Assent on the 26 March 2015. It was noted that regulations and guidance enacting the public rights of way sections of the bill were expected in April/May 2016.

Volunteer Works

Andrew Fletcher showed some before and after photos of Hurley Footpath 29 and Cookham Footpath 48 and explained that his target was to reach 50 task days with the volunteers which he had already met.

Action (AF): Andrew Fletcher to write a letter to the volunteers thanking them for their hard work and also write to the Council (cc. Cllr Dudley) saying how wonderful the volunteers had been and how the Forum would like their work to continue.

Activities of the LAF Fast Response Team

Andrew Fletcher referred the Forum to page 119 in the agenda that listed the activities.

Action (AF): Andrew Fletcher to send the response he had received from Highways England to the Forum members.

Action (ALL): That suggestions of where to go from now be sent to Andrew Fletcher by the first week in December.

10 Feedback from meetings and conferences

Action (AF): Andrew Fletcher to prepare a briefing note on the feedback from meetings and conferences and circulate it to the Forum members.

11 Date of next meeting

The date of the next meeting was to be confirmed.

The Chairman wished everyone a Merry Christmas and a Happy New Year.

The meeting which started at 6.30pm, ended at 9.05pm.
