Agenda Item 3 MEMBERS' GUIDE TO DECLARING INTERESTS IN MEETINGS

Disclosure at Meetings

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a DPI or Prejudicial Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

A member with a DPI or Prejudicial Interest **may make representations at the start of the item but must not take part in discussion or vote at a meeting.** The term 'discussion' means a discussion by the members of meeting. In order to avoid any accusations of taking part in the discussion or vote, Members should move to the public area or leave the room once they have made any representations. If the interest declared has not been entered on to a Members' Register of Interests, they must notify the Monitoring Officer in writing within the next 28 days following the meeting.

Disclosable Pecuniary Interests (DPIs) (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any licence to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where:
 - a) that body has a piece of business or land in the area of the relevant authority, and

b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body <u>or</u> (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

A Member with a DPI should state in the meeting: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations on the item: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Prejudicial Interests

Any interest which a reasonable, fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs the Member's ability to judge the public interest in the item, i.e. a Member's decision making is influenced by their interest so that they are not able to impartially consider relevant issues.

A Member with a Prejudicial interest should state in the meeting: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations in the item: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Personal interests

Any other connection or association which a member of the public may reasonably think may influence a Member when making a decision on council matters.

Members with a Personal Interest should state at the meeting: 'I wish to declare a Personal Interest in item x because xxx'. As this is a Personal Interest only, I will take part in the discussion and vote on the matter.

CONSIDERATION OF APPLICATION FOR A REVIEW OF A PREMISES LICENCE UNDER THE LICENSING ACT 2003

A) The Application

In this case, Thames Valley Police are applying for a Review of the Premises Licence under Section 51 of the Licensing Act 2003. As with all other applications under the Licensing Act 2003, the basis of the Review must be one of the four licensing objectives:

- Prevention of Crime and Disorder;
- Public Safety;
- The Prevention of Public Nuisance,
- The Protection of Children from Harm,

In this case, the Police allege that all four licensing objectives are being seriously undermined. Attached to the Report is the police evidence.

The Police confirm that all the relevant information has been sent to the Premises Licence Holder and to the Responsible Authorities on 9.3.2017.

The relevant notice has been in place on site and in the Council offices in the Customer Service Centre since the 9th March 2017.

The Licensing Authority can reject an application if it considers it to be frivolous, vexatious or repetitious. This is the first time that an application for a Review has been received in respect of these premises and it is considered that the application is an extremely serious one.

Members must take into account the application and any relevant representations and they may take such of the following steps as they consider necessary for the promotion of the Licensing objectives:-

- a) to modify the conditions of the licence
- b) to exclude a licensable activity under the scope of the licence
- c) to remove the designated premises supervisor
- d) to suspend the licence for a period not exceeding three months
- e) to revoke the licence

On this occasion, the application from Thames Valley Police is for the licence to be revoked.

C) National guidance

In the revised guidance to Local Authorities issued by the Secretary of State under Section 182 of the Licensing Act 2003 the following advice is given:-

Representations from the police

9.12 In their role as a responsible authority, the police are an essential source of advice and information on the impact and potential impact of licensable activities, particularly on the crime and disorder objective. The police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area. The police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective, but may also be able to make relevant representations with regard to the other licensing objectives if they have evidence to support such representations. The licensing authority should accept all reasonable and proportionate representations made by the police unless the authority has evidence that to do so would not be appropriate for the promotion of the licensing objectives. However, it remains incumbent on the police to ensure that their representations can withstand the scrutiny to which they would be subject at a hearing.

Crime and disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day-to-day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular premises, poor management competency could give rise to issues of crime and disorder and public safety.

Reviews arising in connection with crime.

11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises; money laundering by criminal gangs, the sale of contraband or stolen goods, or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.

- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crime are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.
- 11.27 There is certain criminal activity that may arise in connection with licensed premises, which should be treated particularly seriously. These are the use of the licensed premises:
 - For the sale and distribution of Class A drugs and the laundering of the proceeds of drugs crime;
 - For the sale and distribution of illegal firearms;
 - For the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
 - For the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime and young people;
 - For prostitution or the sale of unlawful pornography;
 - By organised groups of paedophiles to groom children;
 - As the base for the organisation of criminal activity, particularly by gangs;
 - For the organisation of racist or the promotion of racist attacks;
 - For knowingly employing a person who is unlawfully in the UK or who cannot lawfully be employed as a result of a condition on that person's leave to enter;
 - For unlawful gaming and gambling; and
 - For the sale of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where

reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

Public safety

- 2.7 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote the crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.
- 2.8 A number of matters should be considered in relation to public safety. These may include:
 - Fire safety;
 - Ensuring appropriate access for emergency services such as ambulances;

Protection of children from harm

- 2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered. Moreover, conditions restricting the access of children to premises should be strongly considered in circumstances where:
 - adult entertainment is provided;
 - a member or members of the current management have been convicted for serving alcohol to minors or with a reputation for allowing underage drinking (other than in the context of the exemption in the 2003 Act relating to 16 and

17 year olds consuming beer, wine and cider when accompanied by an adult during a table meal);

- it is known that unaccompanied children have been allowed access;
- there is a known association with drug taking or dealing; or
- in some cases, the premises are used exclusively or primarily for the sale of alcohol for consumption on the premises.
- 2.29 Licensing authorities should give considerable weight to representations about child protection matters. In addition to the responsible authority whose functions relate directly to child protection, the Director of Public Health may also have access to relevant evidence to inform such representations. These representations may include, amongst other things, the use of health data about the harms that alcohol can cause to underage drinkers. Where a responsible authority, or other person, presents evidence to the licensing authority linking specific premises with harms to children (such as ambulance data or emergency department attendances by persons under 18 years old with alcohol- related illnesses or injuries) this evidence should be considered, and the licensing authority should also consider what action is appropriate to ensure this licensing objective is effectively enforced. In relation to applications for the grant of a licence in areas where evidence is presented on high levels of alcohol-related harms in persons aged under 18, it is recommended that the licensing authority considers what conditions may be appropriate to ensure that this objective is promoted effectively.

Licensing authorities acting as responsible authorities

- 9.13 Licensing authorities are included in the list of responsible authorities. A similar framework exists in the Gambling Act 2005. The 2003 Act does not require responsible authorities to make representations about applications for the grant of premises licences or to take any other steps in respect of different licensing processes. It is, therefore, for the licensing authority to determine when it considers it appropriate to act in its capacity as a responsible authority; the licensing authority should make this decision in accordance with its duties under section 4 of the 2003 Act.
- 9.15 It is also reasonable for licensing authorities to expect that other responsible authorities should intervene where the basis for the intervention falls within the remit of that other responsible authority. For example, the police should make representations where the representations are based on concerns about crime and disorder. Likewise, it is reasonable to expect the local authority exercising environmental health functions to make representations where there are concerns about noise nuisance. Each responsible authority has equal standing under the 2003 Act and may act independently without waiting for representations from any other responsible authority.
- 9.17 In cases where a licensing authority is also acting as responsible authority in relation to the same process, it is important to achieve a separation of responsibilities within the authority to ensure procedural fairness and

eliminate conflicts of interest. In such cases, licensing determinations will be made by the licensing committee or sub committee comprising elected members of the authority (although they are advised by a licensing officer). Therefore, a separation is achieved by allocating distinct functions (i.e. those of licensing authority and responsible authority) to different officials within the authority.

9.18 In these cases, licensing authorities should allocate the different responsibilities to different licensing officers or other officers within the local authority to ensure a proper separation of responsibilities. The officer advising the licensing committee (i.e. the authority acting in its capacity as the licensing authority) must be a different person from the officer who is acting for the responsible authority. The officer acting for the responsible authority should not be involved in the licensing decision process and should not discuss the merits of the case with those involved in making the determination by the licensing authority. For example, discussion should not take place between the officer acting as responsible authority and the officer handling the licence application regarding the merits of the case. Communication between these officers in relation to the case should remain professional and consistent with communication with other responsible authorities. Representations, subject to limited exceptions, must be made in writing. It is for the licensing authority to determine how the separate roles are divided to ensure an appropriate separation of responsibilities. This approach may not be appropriate for all licensing authorities and many authorities may already have processes in place to effectively achieve the same outcome.

Powers of a licensing authority on the determination of a review

- 11.16 The 2003 Act provides a range of powers for the licensing authority, which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate. Similarly, licensing authorities may take into account any

civil immigration penalties, which a licence holder has been required to pay for employing an illegal worker.

11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:

• modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;

• exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);

• remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;

- suspend the licence for a period not exceeding three months;
- revoke the licence.
- 11.20 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review.
- 11.21 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.22 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.23 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives or preventing illegal working. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's

decision is appropriate and proportionate to the promotion of the licensing objectives and for the prevention of illegal working in licensed premises. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

D) Observations.

The Sub Committee is obliged to determine this application with a view to promoting the licensing objectives, which are:


- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy.

Of course, the Committee must have regard to all of the representations made and the evidence it hears.

The Committee must take such of the following steps, as it considers appropriate for the promotion of the licensing objectives:

- Reject the whole or part of the application
- Modify the conditions of the premises licence.
- Exclude a licensable activity from the scope of the licence
- Remove the designated premises supervisor
- Suspend the licence for a period not exceeding three months;
- Revoke the licence.

As you can see, within a few months, the premise has gone downhill and is of serious concern to both Thames Valley Police and RBWM Licensing. There have been serious concerns over fire doors being locked and barricaded, with customers inside, on several occasions. We have had the dreadful assault, on the Designated Premises Supervisor in November 2016, but it must be said that the premise, should not have been open and trading, at 1.30 a.m. in the morning.

Steve Smith and I, have tried to work with the Designated Premises Supervisor. We have kept her informed of the issues and our concerns, through our Licensing Meetings. The Designated Premises Supervisor, was informed that if improvements were not made, she was putting the Premise Licence at risk and either Thames Valley Police, or RBWM Licensing, would have to apply to Review the Premise Licence.

Both Thames Valley Police Licensing and RBWM Licensing, are very concerned about this pub; the way it is being managed and run and the continual problems. Thames Valley Police and RBWM, cannot continue to let this premise undermine the Licensing Objectives and put members of the public at risk, by being locked in. The DPS was assaulted at a time when the premises should not have been open. Two under age children were sold alcohol in the pub. The DPS bought along her Site Manager to a Licensing Meeting smelling of alcohol, from the night before. Staff members completely ignoring Police Officers, when we know that customers were in the premise, after their permitted Licensable hours.

The DPS is responsible for the running of the premises and has shown disregard, to the advice she has been given and has totally undermined the Licensing Objectives. It is not for the Police, or the Local Authority, to be held responsible for what happens at this premise, this is down to Ms Singh.

Both Thames Valley Police Licensing and RBWM, have no faith in the current DPS, or Site Manager running this pub and because of these reasons, Thames Valley Police has no other option, but to request that this Premise Licence is Revoked.

PC Hughes-Parry, PC McLullich and Steve Smith will be in attendance at the review hearing to support this review application.

Laurence informed us that he had just attended a Personal Licence Course and had passed. His application for a Personal Licence, had not yet been submitted. He confirmed that he had been working at the premises, since November 2016 and lives upstairs.

Alka was then updated re the issues and concerns from the failed test purchase on the 18/01/17 and the issues and concerns raised during the early hours of 18/02/17. Gen 40's for both incidents were read out.

Alka stated that the failed test purchase had been a mistake and would not happen again. She informed us that her son was behind the bar, only because Laurence, was upstairs unwell. Alka said that her son doesn't normally work in the premise, without supervision. At this point PC Hughes-Parry stated that he had attended the pub several times over the past year or so and that on each occasion, Myron had been working behind the bar, on his own, unsupervised.

The Team were then shown an 'ID Check Log Book', which contained photographs of the different types of IDs which had been used by young people. There were no entries, nor dates, of any refusals in this log book. Alka was informed that the failed test purchase incident, had totally undermined the 'Protection of Children from Harm' Licensing Objective. She was also told that with regard to the Shisha lounge, the locked and barricaded door, had again totally undermined the Public Safety Licensing Objective. This was not the first time the Team had spoken about this and had already advised her about this at our previous meetings.

Alka was issued with a 'Police Warning' in relation to the failed test purchase.

At this point, PC Hughes-Parry asked Laurence, if he had been drinking before the meeting, as he could smell alcohol on him. He then asked, if he had driven to the Police Station? Laurence stated that he had had a drink the previous night and that was what, he could probably smell. He informed the Officer that he had not driven to the Police Station. PC Hughes-Parry stated that he felt it inappropriate for the Site Manager, to attend a Licensing Meeting at the Police Station, smelling very strongly of alcohol was not making a good impression of himself.

Gen 40 dated 18/02/17 and PC McLullich statement was read out.

Alka informed the meeting that 'it was the cleaner cleaning up and it may have been some of his friends'. General discussion then took place with regard to this assertion. TVP and RBWM Licensing stated that the people inside, were in double numbers and they did not believe that it was the cleaner with his friends.

When asked for the CCTV coverage of the relevant times, the Team were informed that the CCTV had not been working for 6 days. They were informed that there was an issue with broadband and they would do their best to try to see if there were any recordings available.

Debie Pearmain concluded the meeting, by informing Alka Singh that due to the ongoing serious issues found, which included under age children being sold alcohol and the continual breaches, she would be applying to Review the Premises Licence under the Public Safety and Protection of Children from Harm Licensing Objectives.

Steve Smith then added that he would be fully supporting Thames Valley Police, at the Review hearing. The review process was then explained to Alka. Steve Smith advised her that she should seek legal advice.

Meeting concluded at 12.30pm

Gen 40 Licensed Premise Incident Report dated 18/02/2017 at 00.25am

Gen 40 submitted by Debie Pearmain in relation to issues found by Thames Valley Police Licensing and Steve Smith, Licensing Officer, RBWM. The following was found:

At 0.15 a.m. on the 18th February, Steve Smith, Licensing Officer RBWM and Debie Pearmain Police Licensing Officer, attended the above premise. At that time, they could clearly see that the lights were on in the main bar, with the curtains drawn. The lights were also on with the curtains drawn in the shisha lounge area. In the main bar area, they could see through the windows that 5 males were still playing pool and could hear customers in the Shisha lounge. Music being played which was audible outside in the street.

At 0.25 a.m., the Team turned back to their vehicle which was parked at the back of Ward Royal. At this time they witnessed 3 customers leave the premise, via the back door. They were let out by someone inside the pub and they quickly left the area. Due to what had just been witnessed, they returned to the Police Station and requested that 2 Police Officers attend the pub with them, as they suspected that customers were still inside the premise and that alcohol was still being sold. The premise was licensed until midnight, on a Friday evening.

At 00.36 hours the Team returned to the premise with PC 1229 Large and PC 7830 McLullich. The two Officers, Debie Pearmain and Steve Smith, knocked simultaneously, on the back door, the front door, the front windows to the bar area and the front windows to the Shisha lounge area. When PC Large first knocked at the back door, the 5 males who were playing pool were clearly seen to run from the bar area where they had been playing pool, into the Shisha lounge area.

Music could be heard from the Shisha lounge area, but each time the Police Officers knocked on the window, the music stopped. Voices which could also be heard, would stop for a moment and then start again. Just before the Team and Officers left, they could hear the sound of water bubbling and could also see LED lights lighting up. This led them to believe that people were inside, smoking shisha.

The Team found it quite surprising and disappointing that no-one opened the doors, to speak to them. If they had nothing to hide, they should have been willing to open the doors for a Police Licensing Check. The Officers had knocked on the doors so hard, it was not possible for those inside, not to have heard them. The Officers had also stated they were 'Police Officers' and their marked police car was parked outside the premises.

At 1.00 a.m. PC Large and PC McLullich left the area. Steve Smith then contacted Alka Singh - the DPS and left a voicemail message, to inform her of about had just happened. At 1.07 a.m., the DPS contacted Steve and stated that 'it was the cleaner in there'.

The Team left the area at 1.11 a.m. At which time, they observed customers at the front of the premise, who appeared to have just left by the front door of the premises.

Gen 40 Licensed Incident Report dated 20/02/2017 at midday

Gen 40 submitted by Debie Pearmain, Police Licensing Officer. Licensing Meeting with Alka Singh, Premise Licence Holder and DPS. Also in attendance were Laurence Worsfold, Site Manager, PC Hughes-Parry, Town Centre Neighbourhood Officer, Steve Smith, Licensing Officer, RBWM and Debie Pearmain, Police Licensing Officer. The Licensing Meeting had been arranged specifically to discuss the recent failed test purchase and the issues Steve Smith and Debie Pearmain had found during their visit during the early hours of 18/02/17.

Ms Kajal Bains attended the premise. She informed them that she was a 'Director' of the business. She was then fully updated of what had happened by Debie Pearmain and Steve Smith. They did not see Laurence, during their time at the premise.

Both of the young female volunteers said that they felt very uncomfortable in the premises, due to the customer's behaviour, whilst they were there. One of the volunteers has taken part in numerous operations in different areas, visiting multiple licensed premises and this is the first time this volunteer felt very worried and felt the need to make this comment to us.

Both Thames Valley Police and RBWM Licensing, felt that immediate action was needed by the DPS, to ensure the safety of her customers and members of the public. **Gen40 dated 18/01/2017 refers**

Gen40 Licensed Premises Incident Report dated 24/01/2017 at 1.00pm

Gen 40 submitted by **Debie Pearmain, Police Licensing Officer**. Following a Licensing Meeting with Michael Ekberg, Business Development Manager, Lisa Eveleigh, RBFRS, Steve Smith, Licensing Officer, RBWM and Debie Pearmain.

Michael was fully updated and Gen40's were read out for: 12/11/2016 incident at 01.30 am, Gen 40 dated 16/12/2016 drugs dog visit and Fire Safety concerns, Licensing meeting with Alka Singh on 11/01/2017, Gen40 dated 18/01/2017, the failed test purchase operation at the premise. Gen 40 dated 21/01/2017 concerns over the DPS's knowledge of basic information about the premises.

Lisa Eveleigh, Fire Safety Officer then updated Michael with her concerns and updated him about the issues found during her visit with Steve Smith, at the end of November 2016. Lisa updated Michael about these and informed him that these outstanding issues would be followed up. Lisa also informed Michael that an out of hours visit would be conducted by the Fire Service, in the very near future.

Steve Smith also mentioned that there had been noise nuisance complaints received by RBWM at around 01.30 a.m., which would fit in with the suspected after hours drinking at the premise.

Michael was also informed that it is the Licensing Team's view that the premises is attracting certain members of the community that require a strong management style. The DPS is continually breaching fire regulations and is allowing the operating of an illegal Shisha area and immediate action needs to be taken by the DPS, before something terrible happens to members of the public. There is a huge concern for public safety.

A general discussion then took place about all of the above issues and Michael was informed that due to the incidents and huge concerns over public safety, a failed test purchase op, Thames Valley Police have no other option, but to apply to Review the Premise Licence and request a Revocation. Furthermore, Steve Smith informed Michael that RBWM Licensing were going to also apply for a review even before the test purchase failure had occurred.

Alka was also informed by Steve Smith and Debie Pearmain that due to the ongoing issues and concerns, there may be a possibility that either, Thames Valley Police Licensing, or RBWM Licensing may apply to review the premises licence.

Gen 40 submitted by **PC 799 Phillips.** Incident report dated 21st January 2017, relates to a report that when he attended the premise to conduct a licensing check, the DPS was not on site. Staff contacted the DPS and she then returned to the premise. Police Officers state that it was clear from talking to the DPS that she knew very little about the premise and was totally reliant upon a staff member, **Laurence**, for the answers to questions posed by the Officers. These included general Health and Safety issues, such as the capacity of the premise. PC Phillips reported that the door to the left - the Shisha Lounge area, wasn't locked and there were people inside, smoking shisha.

Gen40 Licensed Premises Incident Report dated 18/01/2017 at 8.15pm

Gen 40 submitted by **Debie Pearmain, Police Licensing Officer** reporting a Test Purchase Operation, with two female volunteers, one aged 14 and one aged 15. They both attended the premise. Myron Bains, the barman (who is a non- personal Licence holder), sold them, two Bacardi and Cokes. Neither ID, nor age, was asked for, from the two female volunteers. Sergeant Jo Buckley, PC Robin Kinghorn, Steve Smith, RBWM Licensing Officer and Debie Pearmain the Police Licensing Officer were in attendance. They then spoke to the barman about this at 8.20pm.

As the Police and Licensing Officers entered the premise, they noticed that the left hand **Fire Door** was once again locked. They also spoke to Myron about this. They also asked if the DPS, or anyone else in charge, was on the premises. Myron stated that the General Manager, Laurence Worfold, was upstairs. Whilst they were waiting for Laurence to come down, they were shown through the bar area, to the Shisha Lounge by Myron.

Inside, they observed between 4-6 Asian males, sitting smoking, what appeared to be Shisha. A male who later identified himself as Mr Karin Akkari, informed us that he was in charge of the food and shisha area, not the bar. Debie Pearmain, explained to him what had just happened in relation to the under- age sale. At that point she observed smoke, coming from the waste bin, which was next to the locked door, which was also barricaded with stools. She then informed Mr Akkari that there was smoke emanating from the waste bin. He denied it was smoke. She again informed him that it was smoke. He then went to the bin and put the smoke out. Steve Smith informed him that the bin had been a fire hazard and that the Fire Door, should not be locked and that this was the second time, he had seen it locked. The reasons the door should not be locked, were then explained to him. It was the officer's view that the door was locked, as customers were smoking inside. This Shisha Lounge is not 50% open sided and smoking is not permitted. It should not therefore, in my opinion, be operating as a Shisha smoking area.

We were then informed by Myron that the owner had been called and she was on her way. Sergeant Buckley, made the decision that we were not going to stay at the premise any longer, as some of the customers were known to police. They were very loud, screaming and shouting and he did not want any further issues at the premises at that time. Just as the the premise, were leaving - at approximately 8.35pm

Gen40 Licensed Premises Incident Report dated 12/11/16 at 01.30am - 01.40am

Gen40 submitted by **PC 7260 Livingstone**, states that the Designated Premises Supervisor was assaulted by a woman inside the pub. The woman was asked to leave, after a man had bought her a drink. The DPS recognised the woman as someone who had previously been barred, earlier in the year.

An incident occurred, between the DPS and the woman, as she was being escorted out of the premises by another customer. The DPS was assaulted by the woman as she was being taken out. The Police were called by a staff member at 02.08am, as the woman was outside, laughing at them. Police attended and she was arrested. The Police Officer reports that at 01.40am the pub was still quite busy, with at least 15-20 people inside. The Police Officer reports that the Police were not called straight after the assault, but only when they realised that the suspect was still outside laughing at the DPS. Suspect arrested and DPS taken to Hospital.

Incident Report submitted by **Steve Smith, RBWM Licensing Officer**. The Incident Report, states that at 11.45pm on Friday 16th December 2016, during a Joint **Drugs Dog Operation** with Thames Valley Police, Steve Smith observed that the **Fire Door** to the bar, located to the left of the front entrance, was being used as a 'Shisha Lounge' area and was locked. Steve Smith and Police Officers, entered the public bar, where all customers were being screened by the drugs dog. There were no positive indications of drugs. As they were leaving the premise, Steve Smith heard a noise (a chair being moved) behind the locked door to the Shisha Lounge. Police Officers then tried to gain access, by another **Fire Door**, which is located at the rear of the pub. They discovered that this **Fire Door** was also locked, but from the inside.

The Police finally had the locked door opened by the occupants who were inside. As they entered the Shisha area, they observed approximately 35 Asian males sitting around tables. No alcohol was being consumed and all the customers were screened by the dog, with no indications of drugs being given. Steve Smith reports that he observed a very heavy dense cloud of thick smoke at ceiling level, with a strong smell of what he believed to be tobacco. Advice was given to the DPS by Sergeant Littlewood and Steve Smith in relation to fire safety and public protection. Steve Smith informed the DPS that a report would be submitted to the Fire Safety Officer. Officers then carried out a full inspection of the premises and also found the rear fire door exiting out to the rear car-park was also locked. In total 3 locked fire doors were found. Officers ensured that all doors were unlocked before they left.

The Gen 40 dated 16/12/2016 was then read out. Alka Singh informed us that she was not there at the time of the visit. Steve informed her that she was present at the venue and she was sat at a table in the public bar.

Thames Valley Police are requesting the review of the Copper Horse, Ward Royal Parade, Alma Road, Windsor, Berkshire, SL4 3HR, premise licence under the Prevention of Crime and Disorder, Public Safety, Prevention of Public nuisance and the Protection of Children from Harm Licensing Objectives.

Alka Singh is the Designated Premises Supervisor and the Premises Licence Holder, since July 2014.

During the review application you will see references and concerns made in relation to the inside Shisha area. The concern around this is that the Shisha area is not 50% open and we believe that customers are smoking tobacco and Shisha in this area. The definition of smoking is:

Smoking tobacco or anything which contains tobacco, or smoking any other substance and includes being in possession of lit tobacco or of anything lit which contains tobacco, or being in possession of any other lit substance in a form in which it could be smoked. This includes smoking cigarettes, cigars, herbal cigarettes and pipes (**including water pipes, shisha and hookah**). Vaping E Shisha's is not smoking. Smoking is banned inside enclosed premises.

Detailed below are the relevant incidents, which have led me to apply to Review the Premises Licence:

Gen40 Licensed Premises Incident Report dated 04/11/2016 at 01.06am

Gen40 submitted by **PC Jenkins** stating that a member of public had reported sounds of a disturbance outside the premises. PC Jenkins and PC Littlewood attended the scene to deal with the incident. On attendance an area search took place with no-one being found. The Officers attended the Copper Horse as part of their enquiries. Access was only gained to the premises after repeated knocking on the door. The Police Officers could hear persons inside but it took some time for people to open the door. When the Officers went inside there were 4-5 Asian/black men inside. All the men would not engage with the Officers and would not answer any questions. They refused to identify the person in charge. Repeated questions were asked to the group and they essentially played **28**mb' and didn't know what was meant by 'in-

At approximately 0130 hrs on 12th November 2016 the landlady of the COPPER HORSE PUB, ALMA ROAD WINDSOR was assaulted by a female she knows called **Copper Horse** for the landlady of the COPPER HORSE PUB, ALMA ROAD

There was a female inside the pub that had been served a drink as a male had bought her it, however when the landlady realised who it was for she saw that it was a female that had previously been barred earlier in the year. This female who she does not know the details for then continuted to be abusive to people inside the pub and Alka (landlady) asked her to leave at around 0130 hrs. When she asked her to leave set involved and started shouting and swearing at Alka saying why does she have to fucking leave. Alka tried to explain to that it had nothing to do with her and that the other female needed to leave. This would not leave it and tried throwing a drink over it and the other second by the secon was being ejected she has leant forward and struck Alka once to the face causing an abrasion to her left As stood laughing at Alka whilst she was on the floor complaining of pain to her eye. eye. was taken outside of the pub and given her belongings. Approximately ten minutes later she walked past the front of the pub continuing to laugh. Then called police informing what had happened and said that the was still outside the pub. The was arrested outside the pub. The has been interviewed and given an account of self defence stating that Alka had pulled her hair whilst trying to get her out of the pub and that she hit her as a reaction to this. No other witnesses stated that Alka touched with or assaulted her at all. CCTV does not show Alka touching with at all (however the assualt happens in the corner and cannot be seen clearly on CCTV). The has had her ball extended so that outstanding witness statements can be obtained and a medical statement can be obtained for level of injuries.

It is not known what the licencing hours are for the pub however this incident has taken place at 0130 hrs which is believed to be outside of licencing hours. The pub is quite busy with at least 15-20 people inside the pub at this time. This is reflected on the CCTV that has been seized and a copy with OIC investigating should it need to be viewed. The staff tried to eject the parties causing trouble without any trouble or physically ejecting them. They have called police to attend however not straight away only when they realised that the suspect was still outside and laughing at the victim. They did not/would not provide a statement at the time (the victim, ALKA and witness for the victim was taken to Wexham Park and stayed there until approx 0500 hrs and witness went with her to hospital. The victim did not provide a first account. Officers went to hospital with the victim but accounts could not be taken from witness or victim.

Police arrived within minutes (two vans, vivaro and transit). The suspect was arrested straight away. The victim and witness were spoken to however statements were not obtained by either due to them stating they were in shock. No other details of any other witnesses were obtained and it is believed that at least three other males witnessed the assault. These details have been obtained since. CCTV was checked however details did not know how to get this burnt on to a disk. On entering premises I noticed that the door to the bar located to the left of the front entrance, how being used as an electronic Shisha lounge, was locked. We entered the "public bar" located to the right of the main entrance. All customers screen by passive dog, with no Indications. On leaving the premises I heard a noise (chair being moved) behind the locked door to the Shisha lounge. We then tried gain entry to the Shisha lounge by the back door located to rear of the premises and this was in fact locked from the inside. We finally had the rear locked door of the Shisha lounge opened by the occupants inside. On entering the room we observed approximately 35 Asian males sitting around tables, no alcohol appeared to be being consumed by these, all the customers were screened by dog with no indications. However, there was a very heavy dense cloud of thick smoke at ceiling level, with a strong smell of possibly tobacco, I could not see any evidence of non-electronic Shisha being used. Advice was given to the DPS by PS Littlewood and Steve Smith regarding fire safety and public protection. she was informed we would be submitting a Report to the fire safety officer.

Also we found the rear fire door exiting out to the rear carpark locked, in total we found three (3) locked fire doors. We ensured all doors were unlocked before we departed.

AS - Said that's not true, all customers were outside.

SGS - Informed Alka to ensure they keep to the hours and activities attached to the issued premises Licence.

SGS DP – Raised the report from the passive drugs dog operation on Friday 16.12.2016, at 22.45 hrs:-On entering premises noticed that the door to the bar located to the left of the front entrance, now being used as a electronic Shisha lounge, was locked. We entered the "public bar" located to the right of the main entrance. All customers screen by passive dog, with no indications. On leaving the premises I heard a noise (chair being moved) behind the locked door to the Shisha lounge. We then tried to gain entry to the Shisha lounge by the back door located to rear of the premises and this was in fact locked from the inside. We finally had the rear locked door of the Shisha lounge opened by the occupants inside. On entering the room we observed approximately 25 / 30 males sitting around tables, no alcohol seemed to be being consumed, all customers screened by drug dog with no indications, however, there was a heavy cloud of smoke at ceiling level. I could not see any evidence of non-electronic Shisha being used, we had all three (3) locked fire doors reopened and strong advice was given to the DPS from Sgt Littlewood. SGS informed that a report will also be submitted to the RBFRS informing that three (3) Fire doors were found locked, with people still inside the premises.

AS – Replied that she wasn't there!

SGS- Informed that AS was at the venue sitting at a table in the public bar.

DP / SGS – Informed Alka that following this incident and other that are still ongoing, there is a possibility That either TVP or RBWM licensing could be applying for a review of the issued premises licence.

Sergeant Buckley, PC Kinghorn, Steve Smtih, RBWM Licensing Officer and I attended the premises to speak to the seller at 8.20pm. As we entered the premise we noticed that the left hand door was locked (this is a fire door). We spoke to the seller, Mr Mryron Bains and informed him of what had happened. We also asked if the DPS or anyone else was in Charge. He stated that the General Manager was upstairs. Whilst we were waiting for the General Manager, Lawrence Worfold to come down, we were shown thrown the bar area to the room next door. We could not get in this room by the front door as it was locked. We observed between 4-6 Asian males sat down smoking shisha. A male I now know identified himself as Mr Karin Akkari and he informed us that he was in charge of the food and shisha, not the bar. I explained to him what had happened re the under age sale. At this point I observed smoke coming from the bin which was next to the locked barricaded door - it was barricaded with stools. I informed Mr Akkari that there was smoke coming from the bin. He denied it was smoke and I again informed him that it was smoke. He attended to the bin and put the smoke out. He was then informed by Steve Smith that the fire door should not be locked. It is our view that the door was locked as the customers were smoking. This shisha area is not 50% open, therefore should not in my view be operating.

We were then informed by Myron Bains that the owner had been called and she was on her way. The Sergeant made the decision that we were not going to stay at the premise any longer as some of the customers were known to police and they were very loud, screaming and shouting and we did not want any further issues at the premises. Just as we were leaving at approximately 8.35pm Ms Kajal Bains attended the premise. She informed us that she was a Director of the business. She was fully updated of what had happened by myself and Steve Smith.

This premise is attracting the wrong cliental, it is continually breaching fire regulations and in my view the shisha area is not legal and should not be used for shisha. Both of the young female volunteers informed us that they felt very uncomfortable in the premsie and this was due to the customers behaviour whilst they were in the premsies.

total 3 locked fire doors were found. Officers ensured that all doors were unlocked before they left.

Michael was updated that Steve Smith and I had held a meeting with the DPS, Alka Singh on 11th January 2017 where she was updated of the concern of after hours on the 12th November 2016 and the visit on the 16th December 2016 in relation to the 3 fire doors being locked. It was made very clear to Alka of our concerns and worries. Steve also informed her that we would be meeting with her BDM for him to be updated of the issues and concerns.

Gen40 dated 18/01/2016 was read out - this relates to a failed test purchase operation whereby a 14 and a half and a 15 year old female volunteers were served alcohol by a staff member, who did not ask for any ID or request any age verification of the girls. When the 2 palin clothes Officers, Steve Smith and I attended the pub shortly after this had happened at approximately 8.20pm we observed that the left hand door to the Shisha lounge was once again locked. We spoke to the young man who had served the alcohol to the under age volunteers and asked to speak to the person who was in charge. We were told that the General Manager, Lawrence Worfold was upstairs. Whilst we were waiting for him to come down we spoke to Mr Karin Akkari who was in charge of food and the Shisha Lounge. We spoke to him in the Shisha Lounge and as I was explaining what had happened in relation to the under age sale, I noticed that smoke was coming from the bin which was placed by the locked barricaded door. I informed Karin that there was smoke coming from the bin. He denied it was smoke and I again informed him that it was smoke. He then attended to the bin and put the smoke out. He was then informed by Steve Smith that the fire door should not be locked and that this was the second time he had personally seen it locked. It is our view that the Shisha area is not within legislation and this is why the doors are being locked. The seller then informed us that the owner was on her way but due to some of the customers in the pub, who were known to police and due to the atmosphere in the premise, we could hear very loud screaming and shouting from the customers in the bar area, the Sergeant made the operational decision for us all to leave the premise. Just as we were leaving the DPS daughter arrived and informed us that she was one of the Directors of the Company. She was updated of what had happened. It is our view that the premise is attracting the wrong cliental, is continually breaching fire regulations and is operating an

illegal Shisha area and immediate action needs to be taken before something drastic happens to members of the public. There is a huge concern for public safety.

Gen40 dated 21/01/17 was read out - licensing check DPS was not initially on site but was called back. The Officer reports that the DPS knew very little about the premise and was reliant on a staff member for all the information to the questions she was asked. The door to the Shisha Lounge was not locked and there were customers in there.

Lisa Eveleigh, Fire Safety Officer then updated Michael of her concerns and updated him of the issues found during her visit with Steve Smith during the end of November 2016. Lisa updated Michael of these and informed him that these outstanding issues would be followed up by/on 11th February 2017. Lisa also informed Michael that an out of hours visit would be conducted by the Fire Service in the very near future.

Steve Smith also mentioned that there had been noise nuisance complaints received at RBWM at around 01.30am which would fit in with the suspected after hours drinking at the premise.

General discussion then took place on all of the above and Michael was informed that due to the incidents and huge concerns over public safety, failed test purchase op, Thames Valley Police have no other option but to apply to review the premise licence and request a revocation. Infact, Steve Smith informed Michael that RBWM Licensing were going to also apply for a review before the test purchase had occurred.

At 00.25 hours we returned back to our vehicle which was parked at the back of Ward Royal. At this time we witnessed 3 customers leave the premise via the back door. They were let out by someone inside the pub and they quickly left the area. Due to what we had just witnessed we returned to the Police Station and I requested 2 Police Officers attend the pub with us as we suspected that customers were still in the pub and alcohol was still being sold. The pub is licensed until midnight on a Friday evening.

At 00.36 hours we attended the pub with PC 1229 Large and PC 7830 McLullich. Both Officers, myself and Steve knocked on the back door, front door, front windows to the bar area and front windows to the Shisha bar area. When PC Large first knocked at the back door, we clearly saw the 5 males who were playing pool run from the bar area where they were playing pool into the Shisha area bar.

Music could be heard from the Shisha bar area and everytime the windown was knocked on the music stopped and voices would stop for a moment and then start again. Just before we left we could hear the sound of water bubbling and could also see LED lights lighting up. This led us all to believe that people were smoking shisha.

We all found it quite astonishing that no-one opened the doors to speak to us and if they had nothing to hide, they would have been willing to open the doors. The Officers knocked on the doors so hard it was not possible for them not to have heard us.

At 01.00am PC Large and PC McLullich left the area. Steve Smith then contacted Alka Singh, the DPS and left he a voicemail message to inform her of what had happened. At 01.07am the DPS contacted Steve and stated that it was the cleaner in there.

As we left the area at 01.11am we observed customers at the front of the premise who had in our view just left the pub.

Both Thames Valley Police Licensing and RBWM Licensing are very concerned about this pub, the way it is being managed and run and the continual problems.

Alka Singh, DPS, Laurence Worsfold, Site Manager, PC Hughes-Parry, Town Centre Specialist Officer, Steve Smith, Licensing Officer, RBWM and Debie Pearmain, Police Licensing Officer. Meeting arranged to discuss the recent failed test purchase and the issues Steve Smith and I found during the early hours of 18/02/17.

Laurence informed us that he had just attended a personal licence course and had passed. His application for a personal licence has not yet been submitted. He informed us that he has been at the premise since November last year and lives upstairs.

We then updated Alka of the issues and concerns from the failed test purchase on the 18/01/17 and the issues and concerns found during the early hours of 18/02/17.

We started with the failed test purchase on 18/01/17 whereby a 14 and a half and a 15 year old female had been sold alcohol (2 x bacardi and cokes) by Mryon Bains who is a non personal licence holder and the son of the DPS. Alka informed us that this was a mistake and that her son was behind the bar as Laurence was unwell and upstairs. Alka was also informed again of the issues found in the shisha area and that the fire door was once again locked and barricaded with stools. She was informed that whilst we were talking to Mr Karin Akkari who had informed us that he runs the Shisha area, that I could see smoke coming from the bin behind Karin. Karin tried to deny it was smoke and I again informed him that smoke was coming from the bin. Karin put the smoke out. He was also spoken to by Steve Smith about the door being locked. We were shown a 'ID Check Log Book' which had photographs of different types of ID. There were no entries or dates of any refusals in this log book. Alka stated that this was a mistake and it would not happen again. She informed us that her son doesn't normally work in the pub alone. At this time PC Hughes-Parry stated that he had attended the pub several times over the past year or so and each time Myron had been there on his own. Alka was reminded that this failed test purchase incident had totally undermined the Protection of Children from Harm licensing objective and also in relation to the Shisha area, the locked and barricaded door had totally undermined the Public Safety Licensing objective. Alka was again reminded that this is not the first time we had spoken about this, as Steve Smith had witnessed this twice previously and she had been told of this at our last meeting.

Alka was issued with a Police Warning in relation to the failed test purchase.

At this point, PC Hughes-Parry asked Laurence if he had been drinking, as he could clearly smell alcohol on him, he also asked if he had driven to the Police Station. Laurence stated that he had a drink last night and that was what he could probably smell, he informed the Officer that he had not driven to the Police Station. PC Hughes-Parry stated that he felt it inappropriate for the Site Manager to attend a Licensing Meeting at the Police Station, smelling very strongly of alcohol and perhaps working in the pub was not the best place for him.

Alka was then informed that at approx 00.15 hours Steve and I attended the pub and could see that the lights were on in the main bar with the curtains drawn and the lights were on and the curtains drawn in the shisha bar area. In the main bar we could see 5 males playing pool and in the Shisha area we could hear music and customers.

00.25 hours Steve Smith and I observed 3 customers leave the pub by the back door entrance. These customers were let out by someone inside the pub and these persons left the area very quickly. Due to what we had observed I made the decision to request 2 Police Officers attend the pub.



LICENSED PREMISES INCIDENT REPORT

I then read out the witness statement from PC McLullich. Alka was informed that we were very concerned as to what was happening inside the pub and whoever was inside were totally ignoring the Police Officers and us. Whoever was inside the pub certainly heard the banging made by the Police Officers as each time the Officer knocked on the Shisha bar window the people inside went quiet. Then when they thought we had gone, their voices were raised again. We also observed LED lights lighting up and could also hear the sound of water bubbling, we all believed this to be from people smoking shisha.

Alka informed us that it was the cleaner cleaning up and it may have been some of his friends. General discussion on this with TVP and RBWM Licensing stating that the people in there were in double numbers and we did not believe that it was the cleaner with his friends.

When asked if we could have CCTV to cover these timings, we were informed that the CCTV had not been working for 6 days. We were informed that there was an issue with broadband and they would try to see if there were any recordings.

Debie Pearmain concluded the meeting by informing Alka Singh that due to the ongoing serious issues found, under age children being sold alcohol and continual breaches she would be applying to review the premises licence under the public safety and protection of children from harm licensing objectives.

Steve Smith then stated he would be fully supporting Thames Valley Police at the review. The review process was then explained to Alka and Steve advised that she seek legal advice.

The meeting concluded at 12.30pm

I am a Police Community Support Officer for Thames Valley Police and work at Windsor Police Station.

On 15/03/2017 an individual who I shall refer to as PERSON A, who does not wish to be named for fear of possible reprisal, informed me of their concerns relating to drug dealing at THE COPPER HORSE pub on ALMA ROAD in WINDSOR.

PERSON A stated that they had been informed of a recent incident at the pub, occurring during MARCH 2017, whereby a relative of theirs, who I shall refer to as PERSON B, had been offered drugs. PERSON B had been having a drink at THE COPPER HORSE when they were approached by the Barman who is known to them as LAURENCE. LAURENCE is described as being IC1, aged in his mid 30's, of muscular build, approximately 5'11", with a shaven head. On approaching PERSON B LAURENCE offered to sell them Heroin and Cocaine and said that he kept the drugs upstairs in his room, situated above the pub. PERSON B said 'NO' to which LAURENCE started laughing. PERSON B is of the belief that as well as drugs being stored in LAURENCE's room, drugs are also kept behind the bar of THE COPPER HORSE.

In addition to this incident PERSON B is also aware that on a previous occasion a bag containing white powder was found in the toilets inside THE COPPER HORSE. The bag was handed to another staff member working behind the bar, not believed to be LAURENCE, who responded by saying "IT'S OK. WE CAN SELL IT ON".

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out. Arrange or participate in any irresponsible promotions in relation to the premises.

2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children a)

- games or other activities which require or encourage, or are designed to require or encourage, individuals todrink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises i. before the cessation of the period in which the responsible person is authorised to sell or supply alcohol),

 - ii. drink as much alcohol as possible (whether within a time limit or otherwise)

- the outcome of a race, competition or other event or process, or e)
- the likelihood of anything occurring or not occurring f)
- selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises g) which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without the assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- Any individual employed to carryout a security activity must be licensed by the Security Industry Authority (SIA).
- Admission of children is restricted in accordance with the recommendation by the British Board of Film Classification. If the film has not been classified the restriction of children must be approved by the Licensing Authority. (Children means any person under 18 years).



PREMISES LICENCE REVIEW

I have studied the application of the review of the Copper Horse's premises by Debie Pearmain, Police Licensing Offer, on behalf of the Chief Constable of Thames Valley Police, dated 6 March 2017.

Monitoring by Community Wardens

Since 3 March 2017 Community Wardens have been checking The Copper Horse as part of their Night Time Economy (NTE) patrols. The notes of these visits are attached.

The Copper Horse's premises licence PL050393 authorises the licensable activity, including the supply of alcohol until midnight on Friday and Saturday nights. The authorised opening hours are until half past midnight on Friday and Saturday nights. Recent monitoring shows that the hours of the licence appear to be being complied with.

REPRESENTATION OF THE RELEVANT ENFORCING AUTHORITY UNDER THE HEALTH AND SAFETY AT WORK ETC ACT 1974

Smoke Free

Under section 8 of the Health Act 2006, "It is the duty of any person who controls or is concerned in the management of smoke-free premises to cause a person smoking there to stop smoking," and an offence is committed if this duty is not fulfilled.

A smoke free environment is important to protect the health of staff and customers who are not smokers. The smoking of tobacco with a shisha falls under the smoke free legislation.

Smoking inside the Copper Horse has been witnessed on four occasions, on the 4 November 2016, 16 December 2016, 18 and 21 January 2017. On 18 February 2017 smoking inside the premises was suspected by the officers who were refused entry.

Colleagues from the Environmental Health Commercial Team visited on 3 February and were assured that smoking is no longer taking place inside. However, the incident on 18 February, where officers were refused entry believe shisha was being smoked happened after this visit.

Smoking inside the Copper Horse fails to meet the public safety licensing objective and as it is illegal so also fails to meet the prevention of crime and disorder objective.

Fire Safety

The Royal Berkshire Fire and Rescue Service now leads on Fire Safety but there is overlap with the Royal Borough as the authority responsible for Health and Safety enforcement.

Fire doors were observed locked by officers on two occasions on 16 December 2016 and 18 January 2017.

Fire door must be unlocked when the premises is open. Locked fire doors will prevent people leaving the premises in an emergency

Locked fire doors at the Copper Horse fails to meet the public safety licensing objective and as it is illegal so also fails to meet the prevention of crime and disorder objective.

REPRESENTATION OF THE LOCAL AUTHORITY WITH RESPONSIBILITY FOR ENVIRONMENTAL HEALTH

Noise Complaints

In the past 12 months Environmental Protection has received the following two noise complaints.

- 1. 16 November 2016 Noise from car revving their engines and loud conversations in the Copper Horse pub car park at midnight on 6th November 2016 and numerous times before
- 2. 03 October 2016 Noise from people hanging around back of pub, loud music, rowdy behaviour at front of pub until 1 am

The application of the review of the premises licence includes details of complaints made to Thames Valley Police including on 4 November 2016.

The Copper Horse's premises licence PL050393 authorises the licensable activity, including the supply of alcohol until midnight on Friday and Saturday nights.

On 3 occasions, on 4 and 12 November 2016 and 18 February 2017, officers found the Copper Horse trading past 1 am, after the hours authorised by the premises licence.

The noise from patrons leaving the Copper Horse past its licensed hours will cause disturbance to neighbouring residents and will explain the complaints received by Environmental Protection. This noise nuisance from patrons leaving the Copper Horse has already been acknowledged as, "Notices will be placed at exits to ask customers to leave quietly," is a condition of the licence.

The Copper Horse operating beyond its licensed hours and noise from patrons leaving late fails to meet the prevention of public nuisance licensing objective and as it is illegal so also fails to meet the prevention of crime and disorder objective.

DISCUSSION

It is the responsibility of Ms Alka Singh, as the Designated Premises Supervisor (DPS) for the Copper Horse, to ensure that the Premises Licence, its hours and conditions are adhered to.

The problems and offence at the Copper Horse are due to Ms Singh not ensuring compliance with legal requirements including the hours of the premises licence.

If the DPS ensured compliance with legal requirements, including the hours of the premises licence, it is unlikely the operation of the Copper Horse would be a problem.

Ms Singh has been given advice and spoken to by officers from the Royal Borough and Thames Valley Police.

The Licensing Committee can warn, suspend the DPS for up to 3 months or remove the permanently remove the DPS as well revoke the licence.

RECOMMENDATION

It is recommended that the Licensing Committee remove Ms Alka Singh as the DPS for the Copper Horse.

The Royal Borough's Public Health Team supports the application to review the premises licence of The Copper Horse on the grounds of 'the protection of children from harm'. This follows the alcohol sales that were made to a 14yr old and a 15yr old during a test purchase operation on 18.01.17.

Young people's brains and internal organs are not fully grown and are more easily damaged by alcohol. Alcohol can disrupt adolescent brain development, causing lasting problems with memory, attention span and reaction times. In addition, the liver is not fully grown until the age of 18 in men and 21 in women. As a result, young people who drink are more likely to damage their liver.

For these reasons in 2009 the Chief Medical Officer for England & Wales issued the following guidance in relation to young people and alcohol. He advised:

- that an alcohol-free childhood is the healthiest and best option.
 However, if children drink alcohol, it should not be until at least the age of 15.
- if 15-17 year olds drink alcohol, it should be rarely and never more than once a week. They should always be supervised by a parent or carer.
- if 15 to 17 year olds drink alcohol, they should never drink more than 3-4 units of alcohol for males and 2-3 units for females.

In conclusion, due to the risk of staff selling alcohol to minors, the Public Health Team feel a review is necessary.



Nature of Incident:

On entering premises I noticed that the door to the bar located to the left of the front entrance, now being used as an electronic Shisha lounge, was locked. We entered the "public bar" located to the right of the main entrance. All customers screen by passive dog, with no Indications. On leaving the premises I heard a noise (chair being moved) behind the locked door to the Shisha lounge. We then tried gain entry to the Shisha lounge by the back door located to rear of the premises and this was in fact locked from the inside. We finally had the rear locked door of the Shisha lounge opened by the occupants inside. On entering the room we observed approximately 35 Asian males sitting around tables, no alcohol appeared to be being consumed by these, all the customers were screened by dog with no indications. However, there was a very heavy dense cloud of thick smoke at ceiling level, with a strong smell of possibly tobacco, I could not see any evidence of non-electronic Shisha being used. Advice was given to the DPS by PS Littlewood and Steve Smith regarding fire safety and public protection. she was informed we would be submitting a Report to the fire safety officer.

Also we found the rear fire door exiting out to the rear carpark locked, in total we found three (3) locked fire doors. We ensured all doors were unlocked before we departed.

Re: Licensing Act 2003 – Review Proceedings Copper Horse, Ward Royal Parade, Alma Road, Berkshire

We act Ei Group plc. Our client is the leasehold owner of these premises and we have received a copy of the application for review of the premises licence issued by Thames Valley Police.

We would be grateful if you would accept this letter as a formal representation on behalf of our client. Ei Group plc owns around 5000 public houses in England and Wales. Over 95% of those premises are the subject of lease/tenancy agreements by which the tenant operates his/her/its own business out of our client's premises. The lease makes it clear that all operational responsibility for the premises lies with the tenant. The Copper Horse is the subject of a 30 year lease in favour of Sai Service Solutions Limited. The premises licence holder and DPS, Alka Singh is a director of Sai Service Solutions Limited.

Please note, that we take a wholly neutral stance with regard to the allegations against our client's tenant raised in the application for review. As our client has no operational responsibility for the premises, it cannot comment upon those allegations.

The representation made on behalf of Ei Group plc relates to the promotion of the licensing objectives of the prevention of crime and disorder, the protection of children from harm and public safety.

It is clear from the review papers that the cause of the issues giving rise to the review are management failures as far as existing health & safety legislation and licensing legislation is concerned. The licensing objectives can be promoted by the imposition of conditions requiring formal training of all members of staff in relation to their obligations both under Licensing Act 2003 and relevant health & safety legislation. In addition, we would respectfully submit that if training conditions were imposed together with conditions requiring a specified age verification scheme (perhaps Challenge 25) then the licensing objectives would be promoted.

The Guidance issued by the Home Office is clear. Paragraph 11.20 indicates that "In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The

remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review".

If the Committee was to determine the review on the basis of the imposition of training conditions, then this would constitute proportionate action aimed at the deficiencies that led to review.

We would respectfully submit that the revocation of the premises licence would not be a proportionate response.

At this stage, we would be grateful fi you could acknowledge receipt of this representation and advise us as to the date of the hearing as our client may seek to expand upon the issues raised within this letter of representation.
