# Agenda Item 3

#### MEMBERS' GUIDE TO DECLARING INTERESTS IN MEETINGS

#### **Disclosure at Meetings**

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a DPI or Prejudicial Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

A member with a DPI or Prejudicial Interest may make representations at the start of the item but must not take part in the discussion or vote at a meeting. The speaking time allocated for Members to make representations is at the discretion of the Chairman of the meeting. In order to avoid any accusations of taking part in the discussion or vote, after speaking, Members should move away from the panel table to a public area or, if they wish, leave the room. If the interest declared has not been entered on to a Members' Register of Interests, they must notify the Monitoring Officer in writing within the next 28 days following the meeting.

#### Disclosable Pecuniary Interests (DPIs) (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any licence to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where:
  - a) that body has a piece of business or land in the area of the relevant authority, and
  - b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body  $\underline{or}$  (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

A Member with a DPI should state in the meeting: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations on the item: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

#### **Prejudicial Interests**

Any interest which a reasonable, fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs the Member's ability to judge the public interest in the item, i.e. a Member's decision making is influenced by their interest so that they are not able to impartially consider relevant issues.

A Member with a Prejudicial interest should state in the meeting: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations in the item: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

#### **Personal interests**

Any other connection or association which a member of the public may reasonably think may influence a Member when making a decision on council matters.

Members with a Personal Interest should state at the meeting: 'I wish to declare a Personal Interest in item x because xxx'. As this is a Personal Interest only, I will take part in the discussion and vote on the matter.

# Responsible Authorities

Trading Standards has a number of conditions (attached). These have not been agreed by the applicant.

Environmental Protection and Thames Valley Police (TVP) objected to this application. If Panel Sub-Committee decided to grant this application then both responsible authorities required the suggested condition to be added to the premises licence (attached).

#### C) It is considered the following policies have a bearing upon the application.

#### **RBWM licensing policy:-**

#### 2.1 De-regulated Entertainment:-

The Legislative Reform (Entertainment Licensing) Order 2014 came into force on 6 April 2015 with the effect that the following forms of entertainment are no longer licensable –

- Performances of plays between 08.00 and 23.00 provided that the audience does not exceed 500.
- Performances of dance between 08.00 and 23.00, provided that the audience does not exceed 500

- 'Not-for-profit' film exhibition held in community premises between 08.00 and 23.00, provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events between 08.00 and 23.00, provided that those present do not exceed 1000.
- Any contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00, provided that the audience does not exceed 1000.
- Performances of unamplified live music between 08.00 and 23.00, on any premises.
- Performances of amplified live music between 0800 and 2300:
  - On premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500
  - In a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500
  - In a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises
  - At the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital
- Playing of Recorded Music between 0800 and 2300:
  - On premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500

# 7. Promoting the Prevention of Crime and Disorder

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues in relation to the crime and disorder objective:

- Measure to prevent bottles being carried from premises
- Use of drinks' promotions
- Measure to prevent binge drinking
- Participation in the Pub Watch Scheme
- Use of door supervisors
- Training staff in crime prevention measures

- Search procedures
- Use of close circuit television
- Lighting
- Where premises are new, designing out crime
- Quality of surveillance of premises

#### Drugs

The Licensing Authority recognises that drug use by young people in club environment is not something that is relevant to all licensed premises. However, it is also recognised that special conditions will need to be imposed for certain types of venues to reduce the sale and consumption of drugs.

In addition to meeting the requirements of the licensing objectives, licensees have a social responsibility not to sell drug paraphernalia and other products that promote drug use.

Officers of the Licensing Team will engage in the following activities:

- Provide clear information on the Council's policy on safer clubbing in its local statement of police
- Provide clear information on how to apply for a Premises Licence or Club Premises Certificate
- Provide induction training to Councillors serving on Licensing Panels
- Advise venue owners on how to establish and maintain a safe environment
- Advise venue owners, in partnership with the Thames Valley Police, on developing a venue drugs policy
- Ensure that sufficient medical staff is always present and are trained to a high standard
- Liaise with Police and other officers to ensure good communication about potentially dangerous venues
- Encourage venues to use outreach services
- Encourage venues to provide safe transport home
- Monitor the operation of clubs at times of peak occupancy
- Ensure that door supervisors are properly trained and registered with the Security Industry Authority
- Offer to assist with detecting drugs with the use of sniffer dogs and the "itemiser" drugs detention equipment

#### **Door Supervisors**

Whenever any persons are employed at licensed premises to carry out any security activity, all such persons must be licensed with the Security Industry Authority. Where relevant representations are made the Licensing Authority may consider that certain premises require strict supervision for the purpose of promoting the reduction

of crime and disorder. In such cases, the Licensing Authority may impose a condition that licensed door supervisors must be employed at the premises either at all times or such times as certain licensable activities are being carried out.

### 8. Promoting Public Safety

Where relevant representation have been made, the Licensing Authority will have particular regard to the following issues in relation to the public safety objective:

- The use of shatterproof glasses
- The promotion of sensible drinking
- Measures taken to prevent drug spiking
- Drugs policies
- Safe capacities

In appropriate cases, the following conditions may be imposed on premises 'licences to ensure the safety of those attending the premises:

- That a personal licence-holder shall be present at all times when the premises are open for the sale of alcohol
- Suitably qualified first-aiders will be required

# 9. Promoting the Prevention of Public Nuisance

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues in relation to the public nuisance objective:

- The disposal of waste, particularly glass
- The use and maintenance of plant, including air extraction and ventilation systems
- Litter in the vicinity of the premises
- Noise from deliveries / collections to and from the premises
- Measures to control behaviour and queues
- Whether door supervisors are able to stay at the entrance to encourage quiet departure
- The provision of Hackney Carriage / Private Hire services at the premises
- Signs on doors and on tables encouraging consideration to the neighbours

#### Noise

Where relevant representations are made the Licensing Authority will impose conditions in relation to licensed premises to prevent unnecessary noise and disturbance to local residents where relevant representations are made. This may include restrictions on times when music or other licensable activities may take place and may impose technical restrictions on levels of sound at premises. Conditions may also be imposed requiring licensees to display signs at all exits from premises

reminding customers to leave premises quietly and to respect the rights of nearby residents.

- 10. Promoting the Prevention of Children from Harm
- 10.1 The Royal Borough recognises that the protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms directly associated with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). The Licensing Authority will also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 10.2 The Royal Borough will give considerable weight to representations about child protection matters. In addition to the local Safeguarding Children Board, the Director of Public Health may also have access to relevant evidence to inform such representations. There representations may include, amongst other things, the use of health data about harms that alcohol can cause to underage drinkers. In relation to applicants for the grant of a licence in areas where evidence is presented on high levels of alcohol-related harms in persons age under 18, the Licensing Authority will have particular regard to ensure that conditions are imposed to ensure that this objective is effectively promoted. Applicants are therefore expected to provide a robust Operating Schedule outlining in particular how they will address the prevention of children from harm objective.
- 10.3 Alcohol is often a factor in child sexual exploitation, where young people may be encouraged or coerced to drink; alcohol may also be a factor in risk taking behaviour by young people who drink irresponsibly and then get involved in activities that otherwise they would not. Nationally, evidence has been found of the sexual exploitation of children taking place on licensed premises, or licenced premises being used for the purposes of grooming and enticement.
- 10.4 The Windsor and Maidenhead Local Safeguarding Children Board (LSCB) works with other statutory authorities and the licensing trade to promote risk management and safeguarding in relation to child sexual exploitation. The LSCB can provide advice to assist licensees to identify risk and report concerns at different types of licensed premises so that children remain safe and businesses operates responsibly.
- 10.5 The Licensing Authority encourages license holders and operators of licensed premises:
- 1) To ensure that they are fully aware of the signs of child sexual exploitation and to understand that the sexual exploitation of a child is sexual abuse and a criminal offence and

- 2) To raise the awareness of their staff about child sexual exploitation and provide intelligence to the appropriate authorities about concerns and about perpetrators who may be operating in their areas.
- 10.7 All applicants need to demonstrate how children and young people will be safeguarded if attending the licensed premises, or how it will be ensured that they do not gain access to the premises if not appropriate. Where relevant representations are made in relation to the protection of children from harm the Licensing Authority may impose conditions restricting the access of children or excluding them altogether from licensed premises. Such conditions will be imposed from the prevention of harm to children objective. Examples of premises which may be included are:
  - Where there have been convictions for serving alcohol to minors or with a reputation for under-age drinking
  - With a known association with drug taking or dealing
  - Where there is a strong element of gambling on the premises
  - Where entertainment of an adult or sexual nature is commonly provided
  - Where there is concern or evidence that young people are being exploited

### Options will include:

- o Limitations on the hours when children may be present
- Age limitations below 18
- Limitations or exclusions when criteria when certain activities are taking place
- Requirements for accompanying adults
- Full exclusion of people under 18 from the premises when any licensable activities are taking place.
- The provision of a full range of non-alcoholic drinks

## 6. Key Strategies for 2016 - 2021

#### 6.1 Framework Hours

The current staggered closing times of licenced premises, that has developed since 2005 in the Royal Borough, has helped to reduce the problems associated with large numbers of people leaving premises at the same time and reduced congestion at taxi ranks and fast food outlets. However, the later opening hours have brought increased levels of crime, disorder and nuisance. Responsible Authorities, local residents and local Councillors have reported many issues, including noise, antisocial behaviour and litter, which are having an adverse impact on their quality of life. In particular, there has been an increase in violent crime in Windsor town centre between the hours of 00:00 and 04:00.

Having considered the evidence of alcohol related crime, disorder and anti-social behaviour, the number of late night premises and, in particular, the social, practical

and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours are: Premises Type:	Commencement Hour for Licensable Activities No earlier than:	Terminal Hour for Licensable Activities No later than:
Off licence	• 09:00am	• 11:00pm
<ul> <li>Restaurant</li> </ul>	• 09:00am	• 01:00am
<ul> <li>Pub/Bars/Night Clubs</li> </ul>	• 10:00am	• 02:00am
<ul> <li>Takeaways</li> </ul>	• n/a	• 02:00am

Have greater freedom to operate outside framework hours. Such venues are predominantly seated. Examples include:

- Theatres
- Cinemas
- Qualifying Clubs

For the purpose of this policy, premises shall be considered as a restaurant or café if the sale of alcohol is made only to seated customers who are also dining and where this is a condition of the licence, or a condition volunteered in the Operating Schedule for the premises. Where such conditions have not been offered, the premises will be treated as a public house.

Framework Hours are intended to guide applicants on the Licensing Authority's expectations when preparing their Operating Schedule. However, if no relevant representations are received, the application will be granted by the Licensing Authority under delegated powers.

Any conditions setting out hours of premises refers, unless otherwise stated, to the hours during which licensable activities may take place pursuant to the Premises Licence or Club premises Certificate. The Licensing Authority expects the premises to close thirty minutes after the terminal hour for the latest licensable activity.

#### Music, Dance and Similar Venue

The Licensing Authority recognises the cultural importance and significance of premises providing live music, dance and similar entertainment. The Royal Borough is keen to encourage diverse forms of entertainment throughout the borough, but at the same time recognises that this can, if not properly managed, give rise to public nuisance concerns that impact adversely on persons living and working in the vicinity of licensed premises. It is important that entertainment operators pay particular regard to the prevention of public nuisance objective when preparing their Operating Schedules.

Statistics show that nightclubs and late night dance venues generally contribute far higher levels of alcohol related violence per premises than other licensed venues. As a result, nightclub and late night dance venue operators should pay particular regard to the prevention of crime and disorder objective when preparing their Operating Schedules.

The operational hours of existing licensed premises will remain unchanged. On any application for a review of an existing licensed premises, the Framework Hours Policy may be a valid consideration depending upon the circumstances of the application. On any review application the licensing authority are not bound to maintain and apply the Framework Hours. Hours of operation and commencement and terminal hours for licensable activities will need to be considered in light of the promotion of the licensing objectives and the hours that are reasonably acceptable in the particular location.

Framework Hours are intended to guide applicants on the Licensing Authority's expectations when preparing their Operating Schedule. However, if no relevant representations are received, the application will be granted by the Licensing Authority under delegated powers.

Any conditions setting out hours of premises refers, unless otherwise stated, to the hours during which licensable activities may take place pursuant to the Premises Licence or Club premises Certificate. The Licensing Authority expects the premises to close thirty minutes after the terminal hour for the latest licensable activity.

#### 6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the licensing authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to:

- The nature of the activities
- The character of the surrounding area
- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas
- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours
- Winding down periods, particularly in public houses and nightclubs etc.

## D) 182 National Guidance April 2017

#### Crime and Disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority ("SIA") as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.
- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.
- 2.4 The inclusion of radio links and ring-round phone systems should be considered an appropriate condition for public houses, bars and nightclubs operating in city and town centre leisure areas with a high density of licenced premises. These systems allow managers of licensed premises to communicate instantly with the police and facilitate a rapid response to any disorder which may be endangering the customers and staff on the premises.
- 2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key

person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular premises, poor management competency could give rise to issues of crime and disorder and public safety.

2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in the licensed premises might include requiring a premises licence holder to undertake right to work check on all staff employed at the licensed premises or requiring that a copy of any documents checked as part of a right to work check are retained at the licensed premises.

## **Public Safety**

2.7 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather public health which is addressed in other legislation.

Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.

2.8 A number of matters should be considered in relation to public safety. These may include:

- Fire safety
- Ensuring appropriate access for emergency services such as ambulance
- Good communication with local authorities and emergency services, for example communication networks with the police and signing up for local incidents alerts. (See paragraph 2.4 above)
- Ensuring the presence of trained first aiders on the premises and appropriate first aid kits
- Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation)

- Ensuring appropriate limits on the maximum capacity of the premises (See paragraphs 2.12-2.13)
- Considering the use of CCTV in and around the premises (See paragraph 2.3 above)
- 2.9 The measures that are appropriate to promote public safety will vary between premises and the matters listed above may not apply in all cases. Applicants should consider when making their application which steps it is appropriate to take to promote the public safety objectives and demonstrate how they achieve that.

Ensuring safe departure of those using the premises

- 2.10 Licence holders should make provision to ensure that premises users safely leave their premises. Measures that may assist include:
  - Providing information on the premises of local taxi companies who can provide safe transportation home and
  - Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks.

#### Public nuisance

- 2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
- 2.17 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be

appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 16). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.

- 2.18 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.
- 2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the 10 | Revised Guidance issued under section 182 of the Licensing Act 2003 early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.
- 2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

#### Protection of Children from harm

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly to alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

- 2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered. Moreover, conditions restricting the access of children to premises should be strongly considered in circumstances where:
  - Adult entertainment is provided
  - A member or members of the current management have been convicted for serving alcohol to minors or with a reputation for allowing underage drinking (other than in the context of the exemption in the 2003 Act relating to 16 and 17 year olds consuming beer, wine and cider when accompanied by an adult during a table meal);
  - It is known that unaccompanied children have been allowed access;
  - There is known association with drug taking or dealing; or
  - In some cases, the premises are used exclusively or primarily for the sale of alcohol for consumption on the premises
- 2.24 It is also possible that activities, such as adult entertainment, may take place at certain times on premises but not at other times. For example, premises may operate as a café bar during the day providing meals for families but also provide entertainment with a sexual content after 8.00pm. It is no possible to give an exhaustive list of what amounts to entertainment or services of an adult or sexual nature. Applicants, responsible authorities and licensing authorities will need to consider this point carefully. This would broadly include topless bar staff, striptease, lap-, table- or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong and offensive language.
- 2.25 Applicants must be clear in their operating schedules about the activities and times at which the events would take place to help determine when it is not appropriate for children to enter the premises. Consideration should also be given to the proximity of premises to schools and youth clubs so that applicants take appropriate steps to ensure that advertising relating to their premises, or relating to events at their premises, is not displayed at a time when children are likely to be near the premises.
- 2.26 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.
- 2.27 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:
  - Restrictions on the hours when children may be present;

- Restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
- Restrictions on the parts of the premises to which children may have access;
- Requirements for an accompanying adult (including for example, a combination of requirements which provide that children under a particular age must be accompanied by an adult); and
- Full exclusion of people under 18 from the premises when any licensable activities are taking place.

2.28 Please see also Chapter 10 for details about the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

2.29 Licensing authorities should give considerable weight to representations about child protection matters. In addition to the responsible authority whose functions relate directly to child protection, the Director Public Health may also have access to relevant evidence to inform such representations. These representations may include, amongst other things, the use of health data about the harms that alcohol can cause to underage drinkers. Where a responsible authority, or other person, presents evidence to the licensing authority linking specific premises with harms to children (such as ambulance data or emergency department attendances by persons under 18 year old with alcohol-related illness or injuries) this evidence should be considered, and the licensing authority should also consider what actin is appropriate to ensure this licensing objective is effectively enforced. In relation to applications for the grant of a licence in areas where evidence is presented on high levels of alcohol-related harms in persons aged under 18, it is recommended that the licensing authority considers what conditions may be appropriate to ensure that this objective is promoted effectively.

2.30 The 2003 Act provides that, where a premises licence or club premises certificate authorises the exhibition of a film, it must include a condition requiring the admission of children to films to be restricted in accordance with recommendations given either by a body designated under section 4 of the Video Recordings Act 1984 specified in the licence (the British Board of Film Classification is currently the only body which has been so designated) or by the licensing authority itself. Further details are given in Chapter 10.

#### E) Observations.

The Sub Committee is obliged to determine this application with a view to promoting the licensing objectives which are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy. Of course, the Committee must have regard to all of the representations made and the evidence it hears.

The Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant the application as asked.
- Modify the conditions of the licence, by altering or omitting or adding to them.
- Reject the whole or part of the application.





### Evidence from Thames Valley Police objection to application to vary private licence at The Boom Boom Bar, Goswell Hill, Windsor, Berkshire

The above licence variation was received from the licensee Vik Maharat, at The Boom Boom Bar. The variation is requesting an alteration to the licensable hours of operation on almost all aspects of licensed activity every night of the week. I would like to bring to attention that this variation is NOT supported by Thames Valley Police – Windsor and Maidenhead local policing area (LPA) on the following grounds.


Boom Boom Bar is located on Goswell Hill, which is a narrow dark cobbled hill, the length of the hill is lined with railway arches owned by Network Rail. The top of the hill meets The Royal Shopping Centre to one side, and the other side is Peascod Street. Both of these locations are thronging with bars, restaurants and late night establishments, all of which have a huge impact on the high levels of footfall feeding into Goswell Hill, this makes it a busy and thriving area for the night time economy.

#### Demand and Vulnerability


The prevention of crime and disorder

Goswell Hill causes an extremely significant amount of demand for Thames Valley Police, the 'usual night' for officers policing Goswell Hill has now changed if compared to that of 2-3 years ago. The weekends for the night time economy are graded through intelligence as to how busy they are going to be. This is now an extremely unpredictable process to undertake. It is common place to see a large amount of alcohol fuelled disorder take place on a midmonth weekend. Over the course of the past month, officers covering the night time economy have been assaulted on numerous occasions and dealt with serious injuries to members of the public through assaults from the night time economy. This is all concentrated on Goswell Hill, which week on week gives a disproportionate amount of demand. I can demonstrate this by the following illustration —

The list below is the top 10 highest demand locations for the night time economy across the entire LPA, this includes all areas of Windsor, Maidenhead and Ascot. N.B I have sanitised some information to protect identities.



I have also added a screenshot for the top 10 with all days of the week selected-



Additional to the above I have drilled the information down further, I would like to clarify that in the top 50 locations, Goswell Hill addresses are listed 5 times. I have selected all of these locations and transferred the data to a spreadsheet, the first capture illustrates the demand caused by time of the day, by way of a traffic light system:-

It is important to note that the RED demand listed above is directly linked to the times that The Boom Boom Bar are requesting an extension of hours for. This extension will only add to the high levels of crime and disorder already present.

The following table shows the incident type by grading, as you can see the vast majority of the incidents being an immediate (highest level of emergency):-

It is evident from the above that almost all of the recorded incidents are related to violence of some kind.

I appreciate that none of the data above directly corresponds to The Boom Boom Bar. However, from working numerous years on the night time economy in Windsor as a front line Police officer, the majority of the incidents that a Police officer will deal with, are after the venue has ejected the individual. It is very often at this point that the incident is then recorded on Police databases, in almost all of these instances, this means the location that the

officer is with the subject at that given moment is recorded, not necessarily the venue they have been ejected from.

This demand, risk and vulnerability relates directly into the following licensing objectives:

- The prevention of crime and disorder
- Public safety
- Prevention of public nuisance

The LPA cannot cope with this level of demand as it currently stands, to add the addition of longer trading hours, it is my submission that a further extension of the licensing hours for Boom Boom Bar may cause further crime and disorder. In October 2018 the LPA is undergoing a mandatory change in the way the night time economy is Policed. This includes the reduction of officers directly covering the night time economy across the LPA. The reduction equates to almost 60%.

#### Incidents linked directly to The Boom Boom Bar

The prevention of crime and disorder

11<sup>th</sup> August 2018, 02.00 – 02.26 hours, crime reference number 43180245916 Assault.

Officers were contacted by the town centre CCTV operator who had received a call for assistance from The Boom Boom Bar. Officers attended the scene and was directed by security to a male outside the venue. The male was walking away so stopped by Police. Another male was also spoken to inside the venue who confirmed that he did not want to do anything about the incident. It became apparent there was a disorder inside the premises and a possible assault. Due to the aggrieved party not supporting proceedings the suspect was sent on his way and no further action taken.

15<sup>th</sup> July 2018, 01.39 hours – Unique Reference Number (URN) 160, crime reference numbers 43180215012 Assault, 43180215020 Assault, 43180215023 possession of class A drugs.

Request for assistance received from The Boom Boom Bar, for a report of aggressive males at the location. A member of door staff was alerted to a fight breaking out inside the venue between two groups. The security officer attended the location to deal with the incident, he was ejecting a group of males and was subsequently assaulted by two members of the same group. At the Police station the males were searched, a snap shut bag of cocaine was located on one of the males who had been in The Boom Boom Bar.

8th July 2018, 01.38 hours – URN 159.

Police officer covering the night time economy called for assistance due to a fight in progress on Goswell Hill directly outside Boom Boom Bar. This incident was a large scale disorder immediately outside the front doors. A very large and extremely volatile group of individuals were fighting eachother. Officers attended and dealt with numerous outbreaks of related disorder. One male sustained a broken ankle, numerous officers were assaulted by being punched, pushed and kicked. 3 arrests made of very volatile individuals.

Several related GEN40A licensing reports added to this bundle.

9th June 2018, 01.33 hours – URN 107.

Male and female outside Boom Boom Bar being volatile and aggressive, Police attend and the focus of aggression is directed towards Police instead. No action taken apart from strong words of advice. This is due to officers being dispatched to a different location on immediate.

27th May 2018, 03.11 hours - URN 250.

CCTV operators make Police aware of altercation at Boom Boom Bar. Officers attend to find that a male was detained on the floor by door staff and subsequently released. Could not take further action as officers dealing with dispersal issues.

5<sup>th</sup> April 2018, 21.28 hours – URN 1517.

Town centre CCTV operator called for Police assistance to attend Boom Boom Bar due to an assault just taken place at the venue. CCTV operator stated that the suspect is leaving the location and walking up Goswell Hill. No officers available at the time to attend and deal.

13<sup>th</sup> January 2018, 02.03 hours – URN 132.

Officer on scene at Boom Boom Bar called for assistance due to an incident whereby a male was assaulted by being punched to the face inside the premises. The victim walked away and would give full account to Police.

1<sup>st</sup> January 2018, 02.51 hours – URN 388.

Officer reports a fight breaking out at the venue. Officers moved the individuals on and incident closed.

1st January 2018, 01.31 hours – URN 197.

Officers called to Boom Boom Bar at the the report of an assault to the level of Grievious Bodily Harm (GBH) lifechanging injuries. There was an incident inside the venue between 2 females. Others became involved and a fight ensued. One female took her shoe off and hit the other in the forehead causing a deep laceration through the skin and to the skull. Several arrests made of individuals some of whom had fled the scene.

#### Other evidence

Along with this document, I have also added all GEN40A (licensed Premises Incident Report) documents held on file.

I have also added all URN's mentioned above.

I have sanitised all documentation where necessary to protect the identity of individuals and businesses. I can however confirm that the integrity of these sanitised documents has not been altered in any way.

#### **Thames Valley Police Objections**

Thames Valley Police object to the variation of licence and appeal for all current times of all licensable activities to remain the same as listed in activities:- B, E, F, G, H, L and M of licence PL 106992.

For all current active conditions listed in ANNEXES 1 to 4 to remain on the Premises Licence PL 106992 or any subsequent licence that may be issued.

Upon review of this licence application, if the panel was to agree the requested varied conditions, or any agreed variation of those conditions. Thames Valley Police request that the following conditions are added as additions to the current conditions already on the licence.

The prevention of crime and disorder

- The premises must operate a working ID scanner machine and every person who enters the premises should be scanned and their details obtained <u>as a condition of entry</u>.
- The premises will have a last entry time of 0100 hours on every Friday until close of trade and Saturday until close of trade.
- The premises must have, and utilise a working town link radio.
- SIA door staff to be on duty 1 from 21:30 hours on Friday and Saturday evenings and 2 further door staff must come on duty from 22:30 hours on Friday and Saturday evenings, door staff must remain on duty for the duration of trading hours and assist with the dispersal of customers.
- All SIA door staff must wear hi-visibility tabards or coats.

Vik and his team have always been accommodating to the requests and enquiries of the licencing team, as well as working in partnership with the Police. This objection is made by me on behalf of Thames Valley Police, the information I have disclosed is true to the best of my knowledge and belief.

Community Protection wishes to raise an objection to this application on the grounds of prevention of public nuisance and crime and disorder as an interested party.

PC Kevin Horsley (The Problem Solving PC), Thames Valley Police has asked for the assistance of Community Protection Team to reduce crime & disorder and public nuisance in Goswell Hill. This work includes improving the street lighting.

At 02:00 on Saturday 4 August 2018 I patrolled Goswells Hill with the Community Wardens on Duty. I observed about 200 people outside the clubs on Goswell Hill. There was considerable noise from the crowd as well as litter. There was a number of private cars and taxis driving around under the service road. I observed rowdy patrons leaving under the arches towards Bridgewater Terrace.

There was a considerable police presence of a Sergeant and 10 PCs. We left after about 15 minutes as a Community Warden felt concerned for their safety.

Environmental Health / Community Protection currently has three complaints from residents of Bridgewater Terrace about disturbance linked to the night time economy in Windsor town centre including from the premises in Goswells Hill.

To monitor and deal problems linked to the NTE Community Wardens patrol from 19:00 on Friday night until 03:00 Saturday morning and from 19:00 Saturday night until 03:00 Sunday morning. However, patrols finish at about 02:15 to enable the Community Wardens to return to base. complete reports and return equipment. Community Wardens patrols monitor the NTE including pubs, clubs and taxis and report back to the responsible authorities including Environmental Health, Licensing and Thames Valley Police.

If this extension is granted the premises will close after the Community Warden NTE patrols finish, this will make the investigation of problems reported by residents difficult.

Extending the hours of the premises will extend the period that residents experience disturbance from patrons leaving the area.

This variation has not been tested, such as by the use of temporary event notices, to demonstration that there will be no negative impact.

#### **RECOMMENDATION**

Refuse due to unacceptable public nuisance and crime & disorder.

At 02:00 on Saturday 4 August 2018 I patrolled Goswells Hill with the Community Wardens on Duty. I observed about 200 people outside the clubs on Goswell Hill. There was considerable noise from the crowd as well as litter. There was a number of private cars and taxis driving around under the service road. I observed rowdy patrons leaving under the arches towards Bridgewater Terrace.

There was a considerable police presence of a Sergeant and 10 PCs. We left after about 15 minutes as a Community Warden felt concerned for their safety.

Environmental Health currently has three complaints from residents of Bridgewater Terrace about disturbance linked to the night time economy.

2 residents are reporting noise late at night from vehicles linked to the NTE in Windsor town centre including from the premises in Goswells Hill.

1 resident is reporting noise late at night from rowdy pedestrians and litter including vomit linked to the NTE in Windsor town centre including from the premises in Goswells Hill.

From what I saw the complaint about noise from rowdy pedestrians linked to the NTE from premises in Goswell Hill is justified. Increasing the hours of the premises in the area will increase the disturbance the residents will experience.

#### RECOMMENDATION

Refuse due to unacceptable public nuisance

#### **CONDITIONS**

The following conditions are suggested in the event that the Licensing Committee is unable to follow the recommendation.

- 1. **EPL14** Beverages in open containers purchased from the premises will not be taken outside of the premises.
- 2. **EPL16** The premises supervisor, manager or other competent person shall manage any outdoor area to ensure that customers do not behave in a noisy, rowdy or offensive manner.

I know that he has an ID scanner which he advised he does not want listed as part of the licensing conditions therefore Challenge 25 to apply throughout including point of sale.

I would like to lodge an objection regarding the application to extend the license at the above premises to 7 days a week <u>until 3am</u>.

I am a resident of Bridgewater Terrace which is blighted by the nightclubs under the arches <u>from Thursday - Sunday</u>, therefore I am strongly against The Boom being able to operate 7 days a week should it choose to <u>until 3am</u>, allowing customers to leave <u>at 3:30am</u>.

Myself and my husband have had to make several complaints to both the police and to the licensing committee before regarding the issues caused as a direct consequence of the nightclubs under the arches. These include -

- threatening behaviour
- people urinating and being sick on our road
- throwing of glass
- people being dropped off and collected at all hours and playing loud music/shouting
- club members of staff parking their cars on our road leaving residents no where to park
- damage to our cars eg. Knocking of wing mirrors/scratching

The list is endless.

I believe all the other clubs have restrictions on their hours therefore granting this application will only prompt the other to follow suit and also apply to extend their license.

These clubs are not for residents of Windsor, having grown up in Windsor I would not go to these clubs as there is often trouble and the majority of revellers come from outside of the area. I am aware of a number of incidents where serious injury has occurred due to fights breaking out by the clubs and I understand one young man was even killed a few years ago by Alexandra gardens who has been in one of these premises and followed out. I would like to object to this licensing application and ask for it to be rejected because if granted it will result in creating a public nuisance, disturbance and prevent a decent nights sleep.

The reasons are as follows:

Due to The Boom Boom Bar being in close proximity to Bridgewater Terrace, Windsor, SL4 1RB. Our back-yards, which are less than 3 metres long, back onto the Arches. Club staff and customers park, drive, walk and talk (& shout and shreak) along the arches when leaving The Boom Boom Bar (and similar establishments).

Already, with license to serve alcohol and play music until 2pm on Friday and Saturday, there is:

- much noise (shouting and shreaking from departing customers) and disturbance until 3pm, sometimes later.
- loud noises from car stereos, car doors slamming and being highly revved when being driven away after the establishments close until 3am.

Should the license be granted, we will suffer the public nuisance and disturbance of noise and disorderly behaviour as described above until 4am-4.30am every night.

Furthermore, should The Boom Boom Bar be granted the license until 3am, then this precedent may mean that all the other nightclubs in the immediate vicinity, e.g. Charleys Horse, Fuzzy Bear, Scotch, Yello, etc, will also have the opportunity to open until 3pm - leaving the way open for more disorderly noise and disturbance causing more public nuisance in the immediate vicinity of our houses, in the Royal Borough.

During the working week (Sunday - Thursday) The Boom Boom Bar's current licenses to serve alcohol and play music is until 1am. I have only just today had sight of this undated, Application Notice. It was forwarded to me by a neighbour who only received it when an anonymous person put it through his letterbox!

There are valid reasons why our objections always appear to be so limited. This is primarily due to the lack of information provided to the public. The Council instruct the applicant to display the statutory notice of the Application on their premises, but are not lawfully obliged to post that notice to local residents. Such Notices are normally displayed on the inside of grubby glass doors and are clearly not intended to be visible or readable by the residents it should concern. Apart from seeing it in a local paper (few people buy or read them on a regular basis), or for those with some prior knowledge who can negotiate their way through the assault course that is the RBWM website, the relevant information is not easily obtained. How simple is to post this notice to all homes in the Mantra 'catchment' area, but Councils are not lawfully obliged to do this.

However, in brief, my objections are below

#### Prevention of Crime and Disorder

During nightclub opening hours and long after turning out time, continuous Traffic and Parking violations cause excessive noise disturbance in Bridgewater Terrace and Goswell Road. Motorbikes speed up and down and around the town centre with loudly revving motors particularly enhanced by the acoustics through the railway arch. This is in deliberate breach of traffic laws. How on earth do they get away with it?

#### **Public Safety**

I and many of my neighbours find it stressful and intimidating to arrive home late at night on a weekend, e.g. after midnight. I feel deterred from driving home alone any more, as it is not safe for me to get out of the car to negotiate our manually key operated car park gates. I have learned from experience, on the weekend occasions I am out socially and club nights are in session, to take a taxi home with friends who then ensure that I am through the front entrance of Castleview House before they drive away. A pretty disgraceful state of affairs.

#### **Prevention of Public Nuisance**

The situation here has become untenable and has developed rapidly over the past 10 years, due to unjustifiable planning and licensing directives, in what is supposed to be a small historic Market Town! Bearing in mind that in this particular area where 6 nightclubs are concentrated within the Railway Arches, in a small cobbled street, there is no authoritive police presence to prevent anti-social behaviour at this most disruptive time. A time when many

clubbers are leaving the clubs having spent hours topping up their alcohol content, and then leaving through Arch 21 to pick up cars and taxis packed in the Lavender Green private Car Park right outside our front doors.

In short, the residents of Castleview House and Bridgewater Terrace are still being driven to distraction by the continued late night disruption and bad behaviour inflicted by nightclub customers throughout Friday evenings and Saturday until 4am and Saturday evenings through Sunday early mornings. Many people suffer from sleep deprivation.

Unfortunately I have now run out of time although there is more to be said.

#### The Boom Boom Bar - Full Variation to Extend current hours of licensable activities

I herewith submit my objections to the above licensing variation made by the above applicant in accordance with the following Licensing Objectives:

- The prevention of crime and disorder
- Public Safety
- The prevention of public nuisance
- The protection of children from harm

The following is just further reiteration of the constant and decade long protests to the RBWM Licensing Panel concerning the unacceptable behaviour of patrons of the Goswell Hill clubs when the have left the clubs in the early hours of the morning. The later the licenses are allowed the longer the local residents have to suffer, many of whom have come to dread what they know will ensure more sleepless nights in the Friday through Sunday weekend period.

My main objection to this application is that the proposed additional hours of use proposed by this particular Central Windsor premises will create an even longer period for the consumption of alcohol resulting in an even greater increase of public nuisance and extreme anti-social behaviour which is known to have led to crimes of violence and threatening behaviour toward others. These events take place during the late evening and early hours of the morning in a location where residents of Bridgewater Terrace and Goswell Road are subjected to the most unacceptable behaviour on their literal doorsteps. Considering its presence in close proximity to Windsor Castle, Windsor Royal Station, businesses and residences in Bridgewater Terrace and Goswell Road, and the noticeable lack of police presence as a deterrent, I believe that these are solid reasons for the licensing panel to refuse this application.

It is a known fact that these very late licenses attract undesirable elements from all over the south-east rather than Windsor residents. Whilst not all the nightclubs are run irresponsibly, I refer to Bar Yello in particular, there are those that do not discourage bad behaviour or excessive drinking and have no consideration for the local residents, and this is reflected in their patrons' bad behaviour in the public domain. The selective opinion of certain people endorsing Windsor's 'vibrant night life' is unfortunately a misrepresentation of the true state of affairs. Sadly, for Windsorians and their visitors, night time in the town is fast becoming a 'No go area'.

The steady increase of licencing hours over the past few years has created an untenable problem of anti-social behaviour and public disorder, and is also a cause of justifiable concern for the safety of residents arriving home late on weekends from their own social events. Castleview House still has manual, key operated gates to our private car park. I and other residents feel threatened and unsafe entering this car park, or our front entrance door, without the presence of a friend or family member to ensure we enter our homes without experiencing harassmen or are subjected to the shouting, screaming and drunken, abusive behaviour of the patrons who converge through the Bridgewater Way Arch (private land) and the parking area leased by Lavender Green Flowers directly opposite Castleview House.

I am aware that that the rules governing objections to these proposals are of a very restrictive format, unfortunately, the fact is that Boom Boom Bar is only one of 5 separate late night/early morning drinking establishments accumulated along an historic, narrow, cobbled hill. To my knowledge access and exit is only available from and into Goswell Hill. At the close of business each morning, there is absolutely no police presence to monitor the overly inebriated patrons turning out between the hours of 2am and 4.30am on Friday/Saturday and Saturday/Sunday.

Under the circumstances one would expect the TVP to monitor the behaviour of club patrons and ascertain which clubs encourage the most problematic patrons. However, during a recent meeting (concerning serious traffic issues in Goswell Road) held at my flat with PC 1446 Peter Bullett TVP of the Central Windsor Neighbourhood Team & Daniel S J Bayles, RBWM Community Protection Lead Communities, Partnerships & Enforcement Service, we learned that even given the excessive number of clubs in Goswell Hill, and elsewhere throughout the town, the only police resources available are deployed to the Atik nightclub in William Street on weekends. I understand that Atik has extensive resources to deal with its own patrons, which begs the question: Why are the only police available deployed at Atik and not in Goswell Hill?

It is noted that the Licensing panel have already set a precedent for a 4am + half hour license with The Scotch Bar in the knowledge that Windsor TVP are completely undermanned and unable to cope with disruptive situations as they occur, therefore, this must surely add weight to refusing this particular licence variation.

Arch 21, Goswell Road, Bridgewater Terrace and Bridgewater Way are the main points of congregation for the weekend clubbers who disembark loudly and en masse various vehicles directly in front of the doorstep properties on Bridgewater Terrace when arriving. Also, the Lavender Green Flower car park opposite (owned by Network Rail as was) is *still* being illegally used by out of town taxis, minicabs and private cars all night/morning long. Private cars are also parked illegally along Bridgewater Terrace until the following day.

I'm sure the Licensing Panel are well versed in the licensing hours already permitted, but below is a quick reference to add emphasis to the lack of need for further variations.

Incidentally, fact that The Scotch bar was permitted a 4am variation without any local knowledge of the application leads me to my final comments, and I am aware this is not in line with the four objectives. The requirement regarding the display of licensing/planning applications is completely biased in favour of the applicant, i.e:

1) <u>Club Doors:</u> These Notices are generally placed behind on the front or to the rear of a club entrance door. If it is behind glazing, it is virtually impossible to read or photograph without putting your nose against the door, the dark blue colour of the Notice ensures it is difficult to read in any case. Few people walk up and down Goswell Hill, and even if they do they are on the proposite pavement and probably only glance at the club doors.

2) <u>Local Press:</u> Few people purchase or even thoroughly read the local papers these days as most people look for news and a wider base of opinion in the nationals and online.

With this in mind, although there is no legal reason for them to do so, it would be considerate of RBWM Licensing to at least inform, via email or post, the residences within the immediate catchment area of the applicant's premises. After all the Licensing Panel should be well aware by now who the objections are coming from.

Finally, I would like it noted that the all-encompassing objection letter sent in by Julian Gill owner of Yello Bar has mine and my fellow residents' 100 per cent endorsement.

Dear Licensing Panel,

I write to object to the application for 3am licence by Boom Boom Bar Itd of Railway Arch 3 Goswell Hill Windsor SL41RH. This objection is based on the Licensing objectives, in particular the Prevention of Crime and Disorder and the Prevention of Public Nuisance.

and I Goswell Hill for 20 years and as such are interested parties to this application.

It is a family business and one of my many roles over the years has been liaising with the local residents and community to ensure that Yello Bar operates as part of that community and to address any issues that may arise within that community.

The residents of Bridgewater Terrace are only metres away from the rear of 5 Licensed premises, all in the Railway Arches and all of which operate until 2am on Fridays and Saturdays.

I am extremely concerned by the application by Boom Bar to open until 3am 7 days a week (or indeed any day of the week). This shows total dis-regard for all the local residents and the wider community. With 20 years of experience at this location and considerable knowledge of all the problems associated with it, I have to object to this application which, by its very nature and the location of the applicant business simply is unable to promote two of the four licensing objectives: namely Prevention of Crime and Disorder and Prevention of Public Nuisance.

There are 5 bars and clubs in the Goswell Hill Arches. Every single one has planning consents which restrict their hours of operation until 2am plus 30 minutes 'drinking up time' until 230am on Fridays and Saturdays. (please see planning consents which are attached, for Boom Bar {3 Goswell Hill} and the other 4 premises namely Scotch Bar {1 Goswell Hill} Fuzzy bear {2 Goswell Hill} Charleys Horse {4 Goswell Hill} and Yello Bar {11 Goswell Hill}).

Weekdays and Sundays, vary from premise to premise but the latest is Boom Bar (until 1am), the rest are 11pm and 12 midnight. This is for a very good reason which is to protect the amenity of the local residents in Bridgewater Terrace. The protection of amenity in planning terms, in this situation, refers to the ability of residents to get a decent uninterrupted night's sleep by closing the bars and clubs and dispersing the customers at a time that is not so late that it is almost morning and time for residents to get up and start their day. It is also The interruption of sleep is cause by many things to do with the bars and clubs. Such as general and drunken disorder, shouting and screaming of people in high spirits, urinating in the street and railway arches, engine noise from cars driving and engines revving, car stereos blaring and car doors slamming as customers and staff leave the parking areas at the back of the arches and the road tunnel (Bridgewater Way that links Bridgewater Terrace to Goswell Hill).

There are 21 houses and flats in Castleview House (at the start of Bridgewater Terrace) many of these are occupied by elderly members of our community as they are old people's flats. There are 21 houses (1-13 & 19-26 Bridgewater Terrace) occupied by different groups including families with young children, young couples and elderly people. There are 16 flats in Bridgewater Lodge at the end of Bridgewater terrace. This is a total of 58 residential units providing homes to many people.

The clubs and bars generate a large number of customers between them (total licence capacity across the 5 venues is approximately 1,200 people) and they mainly trade as 'free entry' venues. This means that customers of one venue are customers of the others as they move between venues over the course of a night. We all share customers.

None of the 5 venues has any form of private secure smoking area. All customers smoke outside the venues on the pavement. This encourages people to hang around outside which generates noise as does the customers walking from the car park behind the arches on Bridgewater Terrace and customers going to the taxi rank, noise from this taxi rank area is amplified down the tunnel (Bridgewater Way) onto the back of the houses. This area is also undercover as it is part of the shopping centre servicing under croft. So the customers are never exposed to the elements (as they are outside the bars and clubs in the smoking areas. So when it is cold and rains in the winter, they will inevitably move under cover to smoke and head to the taxi area and under croft area making it a busy noisy area. Not forgetting of course, the noise generated by the taxis which amplifies down the tunnel and the drivers who stand around talking. Again, if this licence is extended to 3am then the taxis will also start to operate later to get the trade and that noise will be continuing for an extra hour.

The smoking areas generate noise issues because customers are generally in high spirits enjoying a night out and talk loudly and often scream and shout. They also come outside to make phone calls as it is noisy in the bars and clubs and the Railway Arches have very poor mobile phone reception due to their solid construction. These smoking areas are also a potential source of conflict where arguments and sometimes fights break out.

At the present time, all venues are legally obliged to close their doors having removed all customers at 230am. Customers generally start to leave from 2am onwards until 230am. These customers are then outside and focus on leaving the area and going home. Most customers have gone home by 3am. However, the staff from each venue don't leave until 3am to 330am having cleaned up the venue, filled fridges with stock and cashed up tills etc. Lots of customers and staff park behind the arches and in Bridgewater Way tunnel so when they leave, the residents have the noise of cars running and revving engines, doors slamming, stereos playing and people talking. Everything quietens down from 3am to 330am. Yello Bar has on each night (Friday and Saturday) 10 barstaff, 3 management and 5 security, that is 18 staff. I presume Boom Bar has a similar number. All leaving between 3am and 330am. If you add all the staff from all 5 venues together, that means there are around 80 / 90 staff leaving between 3am and 330am.

If Boom is granted a 3 am licence then the residents will be subjected to the same as above but instead of everything quietening down by 3am - 330am, it won't be until 4am - 430am.

This will also subject residents to the increased noise levels twice each night. Once when the other venues close at 2am - 230am and then again when Boom would close at 3am - 330am.

This is a public nuisance and unfair to residents and hotel guests. All customers from all the venues contribute to this elevation of noise so granting a licence until 3am would absolutely increase public nuisance from noise of customers and their vehicles and staff and their vehicles, it is not possible for any venue to prevent or control this.

There is no way Boom can control this so granting a later licence guarantees it will happen and therefore goes against the licensing objective 'the prevention of public nuisance'.

It must also be noted that from a cumulative point of view, at present, all the Clubs and Bars operate on an even business playing field, closing at 2am. If Boom is granted a licence to 3am then the rest of the venues will follow suit as to remain competitive, business owners will want the same as the next door neighbour so it will end up with all 5 venues being licensed until 3am. This is absolutely what will happen. If you look at the arches historically over the last 20 years you will see that originally the premises all had 11pm licenses. Then they went to 12 midnight. Next, a new operator arrived and went until 1am and the others followed suit. Finally, with the licensing act 2003, a couple of operators went to 2am and everyone followed suit. So you can totally guarantee that granting one 3am licence will see everyone following suit.

This will certainly increase public nuisance and also will increase disorder from drunken customers and people refused entry and potentially higher levels of crime.

Another issue with 3am is that people leaving premises at 2am who have probably had enough to drink by that time then proceed to the later licensed premises and hang around causing problems such as noise, public disorder and possibly crime. Of course no venue will admit entry to people who are intoxicated or might cause trouble but refusing them entry usually results in them hanging around outside and making a nuisance of themselves. It really is important in the interests of upholding the licensing objectives of preventing crime and disorder and preventing public nuisance that this application is refused and all Goswell Hill premises continue to trade within their legal planning hours which are 2am Friday and Saturday and whatever they have the rest of the week.

There is already a later licence venue in Windsor namely Attik nightclub. However this is a very different operation. You cannot come and go as you please (like in the arches). It is pay entry and it has a smoking area roof terrace accessed inside the building. There is no smoking area on the street / pavement. This means that customers cannot hang around outside the club smoking and making phone calls or go back to their cars to drink or take illegal substances. If you are refused entry there are not people outside smoking to hang out with so most will accept it and go home. It is a fully controlled and contained environment, minimising external problems outside.

I also note that this application to 3am goes against the RBWM licensing 'Framework Hours' (copy attached) which forms part of the 'Key Strategies for 2016-2021' It is comprehensive, factual and should be given full considered weight with any licence application but especially this one which wants to trade later than the 2am Framework Hours which it already has. It is stated in the Framework Hours policy that 'late openings have brought an increased level of crime, disorder and nuisance'. 'In particular there has been an increase in violent crime in Windsor town centre between the hours of 00.00 and 04.00'. Taking the above and the Framework Hours policy as a whole into full consideration, this application should, in my opinion, be refused.

Finally, having spoken with our nearest residential neighbour (who is 10 metres from our rear fire escape) who occupies Bridgewater terrace and owns which he rents out. He is really annoyed and concerned by this application for all the reasons above. The noise intrusion is such at number (which backs on to the Bridgewater Way road tunnel) that his tenants never stay very long because of all the shouting and car noise, fighting and general public order and

disturbance. Bridgewater Terrace who also suffers with the late night noise disturbances.

Unfortunately, this application has been submitted in August when many residents are on holiday. That combined with the fact that the only legal requirement of notification is a newspaper advert (which is somewhat outdated as not many people read them anymore) and a notice attached to the front of the premises which unless you actually frequent Boom bar you would never see. This almost guarantees that no one knows anything about it.

They only know about the application because I brought it to their attention.

They have both given me permission ad asked that I include them in this objection as local residents who along with others on the street suffer broken sleep every weekend and do not want it to be any later and not 7 days a week which is totally unreasonable and show absolute disregard for the local community.

From my perspective, allowing this application will guarantee to have a serious negative effect on the residents of Bridgewater Terrace with whom we work so hard to maintain a good community relationship. It will result in the other operators (ourselves included) applying for the same extended hours in order to maintain a level business playing field. This will guarantee to go against the licensing objectives of preventing crime and disorder and preventing public nuisance. The granting of this application will, absolutely guaranteed, generate more public nuisance, disorder and possibly crime as simply by being open longer hours will result in this.

I would ask that the panel reject the application on the basis that it goes against the Framework Hours and cannot by its very nature promote the prevention of crime and disorder or the prevention of public nuisance, both of which are licensing objectives. This application is completely to the detriment of the local residents and as the Motto of the Royal Borough of Windsor and Maidenhead is <u>'Residents First'</u> would, if granted, go against that too.

## 5. Conditions

Standardised conditions will be avoided but selection may be made from the pool of conditions annexed to this report. Conditions will be tailored to the individual style and characteristics of the premises. So far as possible, conditions will reflect local crime reduction strategies.

The Council maintains that licensing is about the control of licensed premises, qualifying clubs and temporary events within the terms of the 2003 Act and any terms and conditions attached to licences will be focused on matters which are within the control of individual licensees and others granted relevant permissions, centring on the premises and their vicinity.

## 6. Key Strategies for 2016 - 2021

### 6.1 Framework Hours

The current staggered closing times of licenced premises, that has developed since 2005 in the Royal Borough, has helped to reduce the problems associated with large numbers of people leaving premises at the same time and reduced congestion at taxi ranks and fast food outlets. However, the later opening hours have brought increased levels of crime, disorder and nuisance. Responsible Authorities, local residents and local Councillors have reported many issues, including noise, antisocial behaviour and litter, which are having an adverse impact on their quality of life. In particular, there has been an increase in violent crime in Windsor town centre between the hours of 00:00 and 04:00.

Having considered the evidence of alcohol related crime, disorder and anti-social behaviour, the number of late night premises and, in particular, the social, practical and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours Policy is not an entitlement. An applicant will still need to demonstrate that, for the terminal hour of 02:00 to apply, it can operate so as to promote the licensing objectives and that the application and proposed operation is reasonably acceptable in the particular location.

Subject to any relevant representations that may be made to the contrary in individual cases, certain types of licenced premises are not considered to make a significant contribution to the problems of late night crime and disorder and anti-social behaviour and, as such, these premises will generally

Framework Hours are intended to guide applicants on the Licensing Authority's expectations when preparing their Operating Schedule. However, if no relevant representations are received, the application will be granted by the Licensing Authority under delegated powers.

Any conditions setting out hours of premises refers, unless otherwise stated, to the hours during which licensable activities may take place pursuant to the Premises Licence or Club premises Certificate. The Licensing Authority expects the premises to close thirty minutes after the terminal hour for the latest licensable activity.

## 6.2 Promoting food-led and seated entertainment venues

The Licensing Authority wishes to encourage applications for food-led and other predominantly seated entertainment venues. Nationally, it has been demonstrated that restaurants and similar establishments have a lower impact on crime, disorder and nuisance; this national observation has been experienced locally within the Royal Borough. In order to encourage food-led and other predominantly seated entertainment venues, the Royal Borough has determined to adopt a Framework Hours Policy (see above) with a terminal hour of 01:00 being set for such premises.

The Framework Hours Policy is not an entitlement, an applicant will still need to demonstrate that, for the terminal hour of 01:00 to apply, it can operate so as to promote the licensing objectives and that the application and proposed operation is reasonably acceptable in the particular location.

## 6.3 Licensing and Planning Protocol

## 6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the licensing authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to:

- The nature of the activities
- The character of the surrounding area
- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas
- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours
- Winding down periods, particularly in public houses and nightclubs etc.



The Boom, 3, The Arches, Goswell Hill, Windsor Application for Extension of Licensing Hours

I refer to the application by Boom Boom Bar Ltd for the extension of the licensing hours of their premises at 3, The Arches, Goswell Hill, Windsor, until 0300hrs <u>seven days a week.</u>

As a local resident living within a few yards of these premises, I wish to register my **strong objections** to this application.

There are no fewer than six bars or nightclubs operating from addresses next door to one another in the Arches. Most of them, including The Boom, have extremely loud sound systems which they play during their opening hours for the pleasure of their customers. The effect of these sound systems is such that even when the music cannot be heard, the vibrations can be *felt* in my apartment, and I am informed, in the whole of Bridgewater Terrace.

I live in a newly built apartment with double glazing and good sound insulation, but the noise and vibration from

the clubs in the Arches still make it difficult for me to sleep. The effect on the residents of the older houses in Bridgwater Terrace must be much worse. The noise and vibration are worst on Friday and Saturday nights when the clubs are busier and sound systems are cranked up to full blast to entertain them.

The present situation where the clubs close at midnight is just about bearable, but an extension to 0300hrs will make a good night's sleep impossible for the residents of this area.

Should this extension of licensing hours be granted to The Boom it is inevitable that the other clubs in the Arches will make similar applications, and these will be difficult to refuse if they have the precedent of The Boom to rely on. The result will be a greatly increased level of disturbance for local residents.

Even with the present restricted licensing hours persons leaving the clubs in the Arches are frequently noisy and sometimes violent. It is not unusual to find litter and vomit on the adjacent streets in the morning. Such behaviour is unlikely to improve if club patrons are given an additional three hours drinking time.

Extending the licensing hours of The Boom to 0300hrs will cause an intolerable degree of nuisance and disturbance to local residents. It should **not** be approved.

Residents of Bridgewater terrace/Castleview house endure drunken disorderly behaviour right outside their doors and windows this is a public nuisance.

There have been fights, shouting urinating on the doorsteps banging on residents windows causing stress and sleep depravation this is health and safety. Dear Sirs, I write to Object to the above application for an extension to operating hours by Boom Boom Bar Ltd. We have recently moved to the area and are appalled by the noise and disruption caused by the Night Clubs which back onto the Railway Arches at Goswell Hill. The Shanly Flats that we have bought are beautifully built top of the market properties and it was only after we had moved in that we realised what disruption is caused by the various Clubs when they let out their Clients at 2.00 in the morning! Our bedroom backs onto the said backs of the Clubs, in the extreme hot nights that we experienced in July and August it is impossible to sleep at night with the windows closed. We are therefore woken by the rowdy revellers emerging from the Clubs, the Staff shouting to each other from the back doors of their Clubs, the glass bottles being emptied out into bins and the early pick up of glass by the re-cycling collectors very early in the morning. To have an additional application for an extension to an operating License until 3.00 a.m. for 7 days per week is completely unacceptable. We also have to put up with shouting and screaming as the Revellers leave the Clubs and the bottles, glasses and other rubbish that is left to litter the Bridgewater Terrace road is absolutely appalling! I am also afraid that in their drunken state many of the patrons of these clubs participate in all sorts of illegal pursuits including damage to property. ## The Boom Boom Bar – Extension of hours until 3.00am etc

I write to object in the strongest possible terms to the above application for seven days a week operation until 3.00am.

I bought my apartment in Bridgewater Lodge last year, moving in during October with my partner. It is on the top floor of the building with the opening windows of both bedrooms facing the rear of Goswell Hill at close quarters. I was aware of the late-opening bars in the Goswell Hill Arches - til 2.00am on Fridays and Saturdays - but considered this liveable with even though we have often been woken up by noise in the small hours of the morning. However this became much more of a problem during the hot summer months, when bedroom windows needed to be open. Our flat is directly behind the Boom Boom bar itself.

This application therefore underlines how residents are extremely vulnerable to the kind of endemic nuisances created by a cluster of night time economy businesses operating at close proximity in a sensitive, residential environment. In his letter to the Licensing Panel, Mr Julian Gill of Yello Bar has provided important and comprehensive detail to substantiate his objections to Boom Boom's application, and we wish both to endorse and to be associated with these. Rather than preventing public nuisance, a consent to the application would significantly INCREASE public nuisance for Bridgewater residents to a quite unacceptable degree.

Moreover, the noise is not just that of 'high spirited' customers, but also mechanical noise from roof and wall mounted air conditioning and extraction plant, which in unremitting.

If yourselves are minded to make a site inspection we (my fellow residents and I) would welcome the opportunity to meet with you here to discuss in more detail.

To who it may concern,

I strongly object to the application by The Boom Boom Bar to extend the hours for licensable activities. I live in Bridgewater Terrace and we already suffer from late night and early morning noise and anti social behaviour from customers leaving nearby clubs. Customers leaving the clubs collect outside our homes; shouting, urinating in the street, slamming car doors, leaving behind empty bottles and fast food packaging. I do not feel safe in my own home in the early hours of the morning especially when woken up by noisy and drunken groups of people, shouting and banging on your doors and windows.

I believe that an extension of the licensing hours will aggravate the present situation resulting in more drunken antisocial behaviour and more cars coming and going with loud stereos and car doors banging in the early hours of the morning. 
I object on the grounds of public safety, public nuisance, crime and disorder, anti-social behaviour, noise nuisance.
