MEMBERS' GUIDE TO DECLARING INTERESTS IN MEETINGS

Disclosure at Meetings

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a DPI or Prejudicial Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

A member with a DPI or Prejudicial Interest may make representations at the start of the item but must not take part in the discussion or vote at a meeting. The speaking time allocated for Members to make representations is at the discretion of the Chairman of the meeting. In order to avoid any accusations of taking part in the discussion or vote, after speaking, Members should move away from the panel table to a public area or, if they wish, leave the room. If the interest declared has not been entered on to a Members' Register of Interests, they must notify the Monitoring Officer in writing within the next 28 days following the meeting.

Disclosable Pecuniary Interests (DPIs) (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any licence to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where:
 - a) that body has a piece of business or land in the area of the relevant authority, and
 - b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body \underline{or} (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

A Member with a DPI should state in the meeting: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations on the item: 'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Prejudicial Interests

Any interest which a reasonable, fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs the Member's ability to judge the public interest in the item, i.e. a Member's decision making is influenced by their interest so that they are not able to impartially consider relevant issues.

A Member with a Prejudicial interest should state in the meeting: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Or, if making representations in the item: 'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'

Personal interests

Any other connection or association which a member of the public may reasonably think may influence a Member when making a decision on council matters.

Members with a Personal Interest should state at the meeting: 'I wish to declare a Personal Interest in item x because xxx'. As this is a Personal Interest only, I will take part in the discussion and vote on the matter.

A) The Application

The application relates to an application for a new Premises Licence.

A summary of the application is as follows:-

The application is for 5 events to be held at the location per year for up to 3000 attendees. The main event being Fi-Fest, a family oriented event over 2 days which is planned for 13th and 14th of July 2019.

- Plays: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.
- Films: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.
- Live Music: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.
- Recorded Music: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.
- Performance of dance: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.
- Retail Sale of alcohol both on and off the premises: Friday and Saturday 11:00hrs until 23:00hrs, Sunday 11:00hrs until 22:00hrs.

Opening hours: Friday and Saturday 10:00hrs until 23:00hrs, Sunday 10:00hrs until 22:00hrs.

Environmental Heath have requested a number of conditions relating to the prevention of public nuisance which are attached, however, these have been agreed by the applicant. Trading Standards have also requested that conditions be attached to the licence which have also been agreed by the applicant.

C) It is considered that the following policies have a bearing upon the application.

RBWM Licensing Policy:-

6. Key Strategies for 2016 – 2021

6.1 Framework Hours

The current staggered closing times of licensed premises, that has developed since 2005 in the Royal Borough, has helped to reduce the problems associated with large numbers of people leaving premises at the same time and reduced congestion at taxi ranks and fast food outlets. However, the later opening hours have brought increased levels of crime, disorder and nuisance. Responsible Authorities, local residents and local Councilor's have reported many issues, including noise, anti-social behaviour and litter, which are having an adverse impact on their quality of life. In particular, there has been an increase in violent crime in Windsor town centre between the hours of 00:00 and 04:00.

Having considered the evidence of alcohol related crime, disorder and anti-social behaviour, the number of late night premises and, in particular, the social, practical and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours are: Premises Type:	Commencement Hour for Licensable Activities No earlier than:	Terminal Hour for Licensable Activities No later than:
Off licence	• 09:00am	• 11:00pm
 Restaurant 	• 09:00am	• 01:00am
Pub/Bars/Night Clubs	• 10:00am	• 02:00am
 Takeaways 	• n/a	• 02:00am

Have greater freedom to operate outside framework hours. Such venues are predominantly seated. Examples include:

- Theatres
- Cinemas
- Qualifying Clubs

For the purpose of this policy, premises shall be considered as a restaurant or café if the sale of alcohol is made only to seated customers who are also dining and where this is a condition of the licence, or a condition volunteered in the Operating Schedule for the premises. Where such conditions have not been offered, the premises will be treated as a public house.

Framework Hours are intended to guide applicants on the Licensing Authority's expectations when preparing their Operating Schedule. However, if no relevant representations are received, the application will be granted by the Licensing Authority under delegated powers.

Any conditions setting out hours of premises refers, unless otherwise stated, to the hours during which licensable activities may take place pursuant to the Premises Licence or Club premises Certificate. The Licensing Authority expects the premises to close thirty minutes after the terminal hour for the latest licensable activity.

6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the licensing authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to:

- The nature of the activities
- The character of the surrounding area
- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas
- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours
- Winding down periods, particularly in public houses and nightclubs etc.

7. Promoting the Prevention of Crime and Disorder

Approved by Full Council December 2015 Final Version Page 8 of 26 Where relevant representations have been made, the Licensing Authority will have particular regard to the following issues in relation to the crime and disorder objective:

- Measures to prevent bottles being carried from premises
- Use of drinks' promotions
- Measures to prevent binge drinking
- Participation in the Pub Watch Scheme
- Use of door supervisors
- Training staff in crime prevention measures
- Search procedures
- Use of close circuit television
- Lighting
- Where premises are new, designing out crime
- Quality of surveillance of premises

Drugs

The Licensing Authority recognises that drug use by young people in a club environment is not something that is relevant to all licensed premises. However, it is also recognised that special conditions will need to be imposed for certain types of venues to reduce the sale and consumption of drugs. Where relevant representations are made by the Police, the conditions to be imposed in such cases are set out in Annexe 1 – Pool of Conditions, although further conditions may be imposed from time to time. These conditions take into account the "Safer Clubbing guidance" issued by the Home Office. In all cases where these conditions are to be imposed, advice will be taken from the local Drugs and Alcohol Action Team and the Police.

In addition to meeting the requirements of the licensing objectives, licensees have a social responsibility not to sell drug paraphernalia and other products that promote drug use.

Door Supervisors

Whenever any persons are employed at licensed premises to carry out any security activity, all such persons must be licensed with the Security Industry Authority. Where relevant representations are made the Licensing Authority may consider that certain premises require strict supervision for the purpose of promoting the reduction of crime and disorder. In such cases, the Licensing Authority may impose a condition that licensed door supervisors must be employed at the premises either at all times or at such times as certain licensable activities are being carried out.

8. Promoting Public Safety

Where relevant representation have been made, the Licensing Authority will have particular regard to the following issues in relation to the public safety objective:

- The use of shatterproof glasses
- The promotion of sensible drinking
- Measures taken to prevent drug spiking
- Drugs policies
- Safe capacities

In appropriate cases, the following conditions may be imposed on premises licences to ensure the safety of those attending the premises:

- That a personal licence-holder shall be present at all times when the premises are open for the sale of alcohol
- Suitably qualified first-aiders will be required

9. Promoting the Prevention of Public Nuisance

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues in relation to the public nuisance objective:

- The disposal of waste, particularly glass
- The use and maintenance of plant, including air extraction and ventilation systems
- Litter in the vicinity of the premises
- Noise from deliveries / collections to and from the premises
- Measures to control behaviour and queues
- Whether door supervisors are able to stay at the entrance to encourage quiet departure
- The provision of Hackney Carriage / Private Hire services at the premises Approved by Full Council December 2015 Final Version Page 10 of 26
- Signs on doors and on tables encouraging consideration to the neighbours

Noise

Where relevant representations are made the Licensing Authority will impose conditions in relation to licensed premises to prevent unnecessary noise and disturbance to local residents where relevant representations are made. This may include restrictions on times when music or other licensable activities may take place and may impose technical restrictions on levels of sound at premises. Conditions may also be imposed requiring licensees to display signs at all exits from premises reminding customers to leave premises quietly and to respect the rights of nearby residents.

10. Promoting the Prevention of Children from Harm

10.1 The Royal Borough recognises that the protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes

not only protecting children from the harms directly associated with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). The Licensing Authority will also consider the need to protect children from sexual exploitation when undertaking licensing functions.

- 10.2 The Royal Borough will give considerable weight to representations about child protection matters. In addition to the Local Safeguarding Children Board, the Director of Public Health may also have access to relevant evidence to inform such representations. These representations may include, amongst other things, the use of health data about harms that alcohol can cause to underage drinkers. In relation to applications for the grant of a licence in areas where evidence is presented on high levels of alcohol-related harms in persons aged under 18, the Licensing Authority will have particular regard to ensure that conditions are imposed to ensure that this objective is effectively promoted. Applicants are therefore expected to provide a robust Operating Schedule outlining in particular how they will address the prevention of children from harm objective.
- 10.3 Alcohol is often a factor in child sexual exploitation, where young people may be encouraged or coerced to drink; alcohol may also be a factor in risk taking behaviour by young people who drink irresponsibly and then get involved in activities that otherwise they would not. Nationally, evidence has been found of the sexual exploitation of children taking place on licensed premises, or licensed premises being used for the purposes of grooming and enticement.
- 10.4 The Windsor and Maidenhead Local Safeguarding Children Board (LSCB) works with other statutory authorities and the licensing trade to promote risk management and safeguarding in relation to child sexual exploitation. The LSCB can provide advice to assist licensees to identify risk and report concerns at different types of licensed premises so that children remain safe and businesses operate responsibly.
- 10.5 The Licensing Authority encourages license holders and operators of licensed premises: 1) To ensure that they are fully aware of the signs of child sexual exploitation and to understand that the sexual exploitation of a child is sexual abuse and a criminal offence and 2) To raise the awareness of their staff about child sexual exploitation and provide intelligence to the appropriate authorities about concerns and about perpetrators who may be operating in their areas.
- 10.6 The LSCB, the NWG and the Royal Borough websites contain more information about child sexual exploitation matters and can be found here: http://www.wamlscb.org/http://www.nwgnetwork.org/ Approved by Full Council December 2015 Final Version Page 11 of 26 http://www.rbwm.gov.uk/web/social_child_protect.htm
- 10.7 All applicants need to demonstrate how children and young people will be safeguarded if attending the licensed premises, or how it will be ensured that they do not gain access to the premises if not appropriate. Where relevant representations are made in relation to the protection of children from harm the Licensing Authority may $Page \mid 6$

impose conditions restricting the access of children or excluding them altogether from licensed premises. Such conditions will be imposed for the prevention of harm to children objective. Examples of premises which may be included are:

- Where there have been convictions for serving alcohol to minors or with a reputation for under-age drinking
- With a known association with drug taking or dealing
- Where there is a strong element of gambling on the premises
- Where entertainment of an adult or sexual nature is commonly provided
- Where there is concern or evidence that young people are being exploited

Options will include:

- Limitations on the hours when children may be present
- Age limitations below 18
- Limitations or exclusions when certain activities are taking place
- Requirements for accompanying adults
- Full exclusion of people under 18 from the premises when any licensable activities are taking place
- The provision of a full range of non-alcoholic drinks
- 10.8 Where cinemas are concerned, the Council will impose conditions that children will be restricted from viewing age-restricted films classified according to the recommendations of the British Board of Film Classification or the Local Authority itself.
- 10.9 Conditions may be imposed on licences for premises where unaccompanied children will be present at places of public entertainment to the effect that adult staff must be present to control the access and egress of children and to ensure their safety.
- 10.10 On the receipt of any application the licensing officers of the Licensing Authority will undertake a preliminary assessment as to whether Child Protection issues arise. Where it is considered that such issues are engaged the licensing officers will mark the application for the immediate attention of the Local Safeguarding Children Board with a request that any relevant representations, if required, should be made to the licensing authority within the relevant time period for the submission of relevant representations.

D) 182 National Guidance April 2017

Crime and Disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority ("SIA") as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important

role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.

- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.
- 2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular premises, poor management competency could give rise to issues of crime and disorder and public safety.
- 2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in the licensed premises might include requiring a premises licence holder to undertake right to work check on all staff employed at the licensed premises or requiring that a copy of any documents checked as part of a right to work check are retained at the licensed premises.

Public Safety

2.7 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of

people using the relevant premises rather public health which is addressed in other legislation.

Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.

2.8 A number of matters should be considered in relation to public safety. These may include:

- Fire safety
- Ensuring appropriate access for emergency services such as ambulance
- Good communication with local authorities and emergency services, for example communication networks with the police and signing up for local incidents alerts. (See paragraph 2.4 above)
- Ensuring the presence of trained first aiders on the premises and appropriate first aid kits
- Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation)
- Ensuring appropriate limits on the maximum capacity of the premises (See paragraphs 2.12-2.13)
- Considering the use of CCTV in and around the premises (See paragraph 2.3 above)

2.9 The measures that are appropriate to promote public safety will vary between premises and the matters listed above may not apply in all cases. Applicants should consider when making their application which steps it is appropriate to take to promote the public safety objectives and demonstrate how they achieve that.

Ensuring safe departure of those using the premises

- 2.10 Licence holders should make provision to ensure that premises users safely leave their premises. Measures that may assist include:
 - Providing information on the premises of local taxi companies who can provide safe transportation home and
 - Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks.

Public nuisance

- 2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
- 2.17 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 16). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.
- 2.18 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.
- 2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the 10 | Revised Guidance issued under section 182 of the Licensing Act 2003 early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping.

This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.

2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

Protection of Children from harm

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly to alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered. Moreover, conditions restricting the access of children to premises should be strongly considered in circumstances where:

- Adult entertainment is provided
- A member or members of the current management have been convicted for serving alcohol to minors or with a reputation for allowing underage drinking (other than in the context of the exemption in the 2003 Act relating to 16 and 17 year olds consuming beer, wine and cider when accompanied by an adult during a table meal);
- It is known that unaccompanied children have been allowed access;
- There is known association with drug taking or dealing; or
- In some cases, the premises are used exclusively or primarily for the sale of alcohol for consumption on the premises

2.24 It is also possible that activities, such as adult entertainment, may take place at certain times on premises but not at other times. For example, premises may operate as a café bar during the day providing meals for families but also provide entertainment with a sexual content after 8.00pm. It is no possible to give an exhaustive list of what amounts to entertainment or services of an adult or sexual nature. Applicants,

responsible authorities and licensing authorities will need to consider this point carefully. This would broadly include topless bar staff, striptease, lap-, table- or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong and offensive language.

- 2.25 Applicants must be clear in their operating schedules about the activities and times at which the events would take place to help determine when it is not appropriate for children to enter the premises. Consideration should also be given to the proximity of premises to schools and youth clubs so that applicants take appropriate steps to ensure that advertising relating to their premises, or relating to events at their premises, is not displayed at a time when children are likely to be near the premises.
- 2.26 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.
- 2.27 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:
 - Restrictions on the hours when children may be present;
 - Restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
 - Restrictions on the parts of the premises to which children may have access;
 - Requirements for an accompanying adult (including for example, a combination
 of requirements which provide that children under a particular age must be
 accompanied by an adult); and
 - Full exclusion of people under 18 from the premises when any licensable activities are taking place.
- 2.28 Please see also Chapter 10 for details about the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.
- 2.29 Licensing authorities should give considerable weight to representations about child protection matters. In addition to the responsible authority whose functions relate directly to child protection, the Director Public Health may also have access to relevant evidence to inform such representations. These representations may include, amongst other things, the use of health data about the harms that alcohol can cause to underage drinkers. Where a responsible authority, or other person, presents evidence to the licensing authority linking specific premises with harms to children (such as ambulance data or emergency department attendances by persons under 18 year old with alcohol-related illness or injuries) this evidence should be considered, and the licensing authority should also consider what actin is appropriate to ensure this licensing objective is effectively enforced. In relation to applications for the grant of a

licence in areas where evidence is presented on high levels of alcohol-related harms in persons aged under 18, it is recommended that the licensing authority considers what conditions may be appropriate to ensure that this objective is promoted effectively.

2.30 The 2003 Act provides that, where a premises licence or club premises certificate authorises the exhibition of a film, it must include a condition requiring the admission of children to films to be restricted in accordance with recommendations given either by a body designated under section 4 of the Video Recordings Act 1984 specified in the licence (the British Board of Film Classification is currently the only body which has been so designated) or by the licensing authority itself. Further details are given in Chapter 10.

E) Observations.

The Sub Committee is obliged to determine this application with a view to promoting the licensing objectives which are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy. Of course, the Committee must have regard to all of the representations made and the evidence it hears.

The Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant the application as asked.
- Modify the conditions of the licence, by altering or omitting or adding to them.
- Reject the whole or part of the application.







FI.FEST NOISE MANAGEMENT PLAN 2019

Event Summary

The event will take place on SATURDAY 13th & 14th July 2019 with all activities (taking place in a field under SL6 2NS postcode on Paul Rinders Farm). The event consists of:

Saturday 13th July: Live bands on stage with an alternative kid's entertainment area running until 6pm. There will also be beer and food stalls set up in the field during the day. This day runs from 11am until 11pm. An hour from 10am - 11am will be used for sound checks.

Sunday 14th July: Open air cinema on stage showing a kids film from 1pm then switching over to Wimbledons Mens Finals followed by another film in the evening. This day will run from 12 noon until 9pm

The event is aimed at the family age group and hopes to attract a cross section of the community.

Noise Management at Festival 2019:

- Sound level meters will be on site and measured from two key points of the Festival so to measure noise levels.
- Sound levels will not be allowed to go above 107Db over a 15 minute period, close to sound sensitive areas.
- Sound levels will be checked throughout the event by the Festival security team

PREMISES LICENCE.

Events to be held

There will be a maximum of 5 events per calendar year held on the premises. The event will be aimed at all ages and will be restricted to Friday's and Saturday's between 11am and 11pm and Sunday's from 11am – 10pm.

We are experienced licensees and event managers who have a proven track record of running a well-managed town centre venue.

In 2018 the first Fi-Fest family festival was held on the site under a temporary event licence. The event was a great success and demonstrated that we have experience of running an outdoor event that is well organised and not disruptive to residents.

Location and Planning the Site

Planning and Contact with Relevant Authorities

Each event held at the venue will be submitted to the RBWM Safety Advisory Group and the following documents will be completed:

- 1. Event Plan
- 2. Risk Assessment
- 3. Fire Risk Assessment
- 4. Noise Management Plan
- 5. Emergency Plan.

Crowd Management and safety

Open field bounded by hedgerow on all 4 sides with **32 metres of marshaled open entrances and exits**. The area is private land. As the venue is outdoors the risk associated with fire is lowered. The site has multiple exits. (shown on plan in Appendix 1)

The capacity of the licensed area will be capped at **3000 persons**, this will be controlled via advance ticketing.

The capacity has been based on the number amount of space available on site, minus the amount of space needed for infrastructure such as stage, concession and bars. The capacity area has been measured to be **10000 metres**². This allows **1694metres**² for event infrastructure

The amount of exits required on site for this number of people has been calculated using the the formula from the HM Government Fire Safety Risk Assessment guide for open air events and venues. The result of the calculation shows that the fire exits are more than suitable for the amount of people in attendance.

All exits will be clearly signed and at night will be fully lit to ensure safe egress for public attending the event. All exits will be stewarded by SIA trained staff.

All staff at events will be provided with a full briefing of the site layout and emergency procedures to ensure a swift response to any incident.

There will be a strict no glass policy at all events for vendors and members of the public. Bag searches will be carried when entering the venue and no alcohol will be permitted to be brought onto the site so that the organisers can manage consumption at point of purchase.

A dedicated children's area will be set up at events with professional children's entertainers managing the space. Children must be accompanied by an adult at all times. A lost child point will be set up at the event and all staff will be briefed on lost child procedure.

Infrastructure / Facilities

Main structures erected in the site will include a stage, marquees, fairground rides, and toilets. These will be set up by competent operators and adequate insurances will be in place.

Exits will be kept clear of any infrastructure to allow unimpeded egress from the site.

Public access and parking

The venue has on-site parking and will have a dedicated taxi drop of zone within the venues boundaries. This reduces traffic around the venue and ensures that there is no disruption to the residents in the area. The venue has **27650metres**² of parking.

The parking zone will be well lit and marshalled at all times.

Emergency Access

Emergency access to the site will be maintained at all times. Emergency access to the site is highlighted on the site plan in Appendix 1.

Insurance

Public liability insurance is in place for events held at the venue.

Litter

There will be a dedicated litter collection team during and after any events. Bins will be located around the site and monitored and emptied once full. A full litter sweep of the area outside the venue will also be carried out post events. The team will cover 100m outside of the perimeter of the event site to ensure there is no impact on the surrounding area.

I refer to the application under the provisions of the above legislation for the existing licence relating to the above premises and would advise that the Environmental Protection Unit of the Council has no objection to the application subject to the following condition (s):

EPL01 Noise arising from any PA or amplified or live music, vocalisation, live or recorded event transmission, film or video display, gaming machine or any other source shall not be played at a levels which give rise to a public nuisance to the occupants of any properties in the vicinity.

EPL02 The applicant or their appointed representatives shall notify the Licensing, not less than 4 weeks prior to a concert/music event taking place. A detail plan of the proposed event shall include details regarding to proposed sound checks, risk assessment on the potential for public nuisance, details of the location of the concert/live music event, stage configuration, times and duration of concert/live music event and predicted number of attendees and a noise, management plan shall be submitted not less the (4) weeks prior to a concert/live music event taking place.

EPL03 The Licensee shall appoint a suitably qualified and experienced noise control consultant e.g. member of the Institute of Acoustic (MIOA) or other person agreed with the Royal Borough of Windsor and Maidenhead, to the approval of the Licensing Authority, no later than 6 weeks prior to the event. The noise control consultant, shall liaise between all parties including the Licensee, Promoter, Sound System Supplier, Sound Engineer and the licensing authority on all matters relating to noise control prior to and during the event.

EPL04 A noise propagation test shall be undertaken at least 4 hours prior to the start of the event in order to set appropriate control limits at the sound mixer position. The sound system shall be configured and operated in a similar manner as intended for the event. The sound source used for the test shall be similar to the music likely to be produced during the event. If the noise is found to be excessive it shall be reduced.

EPL05 The control limits set at the mixer position shall be adequate to ensure that the Music Noise Level (MNL) shall not at any noise sensitive premises measured at 1m from the facade exceed the background noise level by more than 15dB(A) over every 15 minute period throughout the duration of the concert before 23:00 hours. This condition shall also apply throughout any rehearsal or sound checks for the events.

EPL06 The Licensee shall ensure that the promoter, sound system supplier, DJ and all individual sound engineers are informed of the sound control limits and that any instructions from the noise control consultant regarding noise levels shall be implemented.

EPL07 The appointed noise control consultant shall continually monitor noise levels at the sound mixer/DJ position and advice the sound engineer accordingly to ensure that the noise limits are not exceeded. The Licensing Authority shall have access to the results of noise monitoring at any time. In any case a print out of the noise levels at the mixer/DJ positions, and the noise levels recorded at residential locations during the event shall be submitted within 1 week of the concert/live music event, taking place.

EPL08 The number of music events any one-calendar year should not exceed (5) events.

EPL09 Details of the time, date and duration of set up and dismantling of the stage and other associated noise generating activities (refuse disposal, provision and emptying of toilets, generators etc.) outside the times of the performances shall be submitted to, and approved by the Licensing Authority no later than 10 working days before the events.

EPL10 All local residents likely to be affected by noise from the event shall be informed in writing as to:

- (i) The exact times of all performances and sound checks.
- (ii) A contact name and telephone number should they wish to make a complaint of noise.

Your email to us dated 27th February 2019 with attachments.

- 1. Kindly accept this as our strong objection to the above application stated as maximum 5 events per year over 3 days.
- 2. The application attachment headed 'PREMISES LICENCE' is misleading. The applicants state the 2018 FiFest was on this site- this is not the case. The 2018 FiFest was in fact held in a comparatively small field owned by the applicants adjoining the back of their own rear garden and Braywood Hall. It was a much smaller family event on a temporary licence limited to 499 persons including visitors and staff. This new application (2019) is proposed to cater for up to 3000 persons in a completely different location covering a wide area with a great number of frequently used public bridle ways and public footpaths with ditches either side.
- 3. Our objections are contained within the four licensing objectives as follow:
 - The prevention of Crime and Disorder There are a large number of equestrian establishments in Fifield and Holyport and the bridle ways on this site are in constant use by horse riders. Also dog walkers, joggers use the many bridle ways and footpaths that criss-cross this large site. If a unprecedented large number of people came onto this site before, during and after the Event e.g. visitors, staff & performers with their cars, lorries and other vehicles it is not difficult to anticipate conflict of one kind or another.
 - Public Safety This is of high concern to us. There are no footpaths on the Forest Green road (50mph) where the festival exit is proposed. For most of its length Gays Lane has no footpaths but ditches on either side and no passing places. Most of the bridle ways on this site also have ditches either side. Even if tracks going alongside the bridle paths are used it could be particularly dangerous with large vehicles. RBWM Parks and Countryside manager has objected to this application stating 'It appears that no regard has been given in the licence application to the presence of these public rights of way'. There are, as an example, 3 public footpaths 26,27,28 which would have to be traversed by vehicles to gain access to the Stage site and Staff car park off Gays Lane. There is also the question of access for the emergency services with only open farm land criss-crossed with so many public bridleways, footpaths and ditches. Please see attached right of way map.
 - Public Nuisance Loud music late at night would obviously be a nuisance to local residents, some of whom are elderly and live in the immediate vicinity. Again the site is only two open fields away from OLD BEAM KENNELS & CATTERY, which could be very disturbing to the pets that are there.
 - To protect children from harm Within approximately 50 75 metres of this site is the Windsor Horse Rangers, a charity for about 130 children aged 8 -18 years of age. These children use the bridal ways on the site on a regular basis, it being so close by. It should be noted that the Festival is planned during the children's summer holidays. We know that the children regularly do a circuit ride starting at the Green Lane bridle way no.47 off Coningsby Lane going along Green Lane, no.47, coming out at Forest Green road which is where the exit from the Festival is planned. Again another

route the children take is down the same bridle way, no.47 off Coningsby Lane turning right at its junction with bridle path no.44 Gays Lane into Langworthy Lane and back down bridle path no.29 on Forest Green road.

• Town Centre & Venues – The applicants specifically state in this application that they 'are experienced Licensee's and Event managers, who have a proven track record of running a well-managed Town Centre Venue'. We would point out that this site is in the middle of a large area of Farm land. This is not a 'local' event like the one day fair at Holyport and Fifield fun day, both of which are for Charities. As far as we can tell FiFest is a commercial undertaking already selling tickets on the Eventbright website and advertising on social media, which will probably attract people from far and wide. However the applicants have made clear that tickets already sold will be refunded should they be unsuccessful in this licensed application.

This site is completely unsuitable for the type of large scale commercial festival that is proposed and we would suggest that it is important to view the site in order to fully understand the seriousness of these objections and those of the public.

We could not find the site plan appendix.1 stated to be attached to your email.

- c/ increased traffic and in particular parking of cars would cause considerable inconvenience to local residents. Access is difficult so one can only assume that local roads would end up clogged by illegal and improper parking
- d/ Although not mentioned it must be assumed that any such activity would take place until late in the evening and the noise and light pollution would be considerable. This would disturb not only local residents but also pets and wildlife in an unnecessary manner.

Dear Sirs

We are residents of Holyport with our home and offices adjacent to Gadbridge on the B3024 and at Foxley Manor. We have been made aware of an application that has recently been submitted for a licence in connection with a private field at Rinder's Farm, off Forest Green Road, SL6 2NS. A copy of the site notice is attached for your reference.

We understand the Licence Application relates to a field at Rinders Farm and requests permission to supply alcohol on and off the premises for performances of plays, films, live music, recorded music and performances of dance. The site notice requests responses and comments in connection with the application.

We wish to record our strong objection to this application.

The site is in a Green Belt area (as designated under the Town & Country Planning Act and National Policy Framework) and the use class of the field is Agricultural.

Traffic and Highways

The setting of the field is quiet, rural and the access to the field in question from the B3024 (Forest Green Road) whilst suitable for agricultural vehicles would not be suitable for a multi-facility and use purpose and in particular the heavy increase in traffic flow a licensed venue would bring.

We consider in the event that this field was used for plays, films, live music and recorded music including performances of dance, there would be a presumption that vehicles would enter and leave the site with considerable traffic flow and movement immediately prior to and upon completion of any event. This section of the B3024 has already witnessed a number of accidents when used solely as a country road with a speed limit currently of 50mph. Therefore, we consider there would be a substantial increase in risk to both pedestrians and motor vehicle users brought about by increased traffic flow due to any event.

The 'field' in question does not reside near any natural car park or area where motor vehicles can safely reside and therefore it is highly likely that existing country lanes and residential roads in and around this site would see a substantial increase in parking with vehicle users then walking along country lanes which currently have no footpaths or pavements to the venue. This would once again increase risk of death and injury to users of the Forest Green Road and other roads.

Noise Pollution

The area in question is a peaceful, rural and quiet agricultural area and the increase in noise pollution brought about by 'music festivals' is totally incongruous to the current countryside and site area. This would cause considerable disturbance to local residents and is utterly unacceptable when considered against other venues for such activities that already exist within the Borough.

Light Pollution

It is quite possible that, should permission be granted, including an alcohol licence, that events would take place in evenings and hence after dark. This would cause light pollution to a tranquil and peaceful part of the countryside which once again is incongruous to the current use class of this land.

Bridleway and Pedestrian Footpath

The access road from Forest Green Road is currently used by pedestrians (dog walkers etc.) and horse-riders (bridleway) and consequently the advent of motor vehicles with their noise, damage to road surfaces, damage to hedgerows and fields etc. would heavily impact the current use of the area and bridleway. This would lead to increased danger and risk to pedestrians.

Refuse

Live events inevitably bring with them a significant number of people and experience shows that, irrespective of measures taken, substantial refuse and waste result, not only on the actual site but also on surrounding roads, ditches and field areas.

Examination of existing ditches in and around this area will show the number of discarded cans, plastic bottles, plastic bags and other waste material discarded presumably from passing vehicles and this would be massively increased leading not only to an increased risk to health, increased cost to the Local Authority for clearance and increased costs to local residents in having to clear waste from their own land where discarded indiscriminately by venue users.

Conclusion

This application in our opinion therefore would add cost to the Local Authority and also Holyport Parish Council and local residents that would not be acceptable.

For the reasons outlined above, namely noise pollution, safety and road traffic, environmental pollution, light pollution and completely unacceptable use of a quiet countryside area as an event location, we write to express our strong objection to the proposal and would appreciate, in the first instance, confirmation that you have received and registered this objection and secondly that we will be kept informed of the Council's processing of this application. We feel quite sure that the Parish Council in Bray and Holyport will oppose this proposal as indeed will may if not practically all local residents (bar the applicant).

At present it is relatively easy for villagers to spot 'Nottingham knockers', fraudulent tradespeople and potential criminals accessing properties with such a large influx of people we are at much greater risk, and yet much less able to identify that this is happening.
 - 2. Public safety;
- the access to the site is via narrow lanes which are not in a good state of repair for vehicles, but are used by walkers, cyclists and horse riders on a regular basis. This amount of traffic down our small lanes will be a huge danger to public safety and make areas of the village 'no go' for the duration. This wouldn't just be for the festival goers themselves, but for the lorries, equipment, caterers, providers of other facilities etc. The village can't safely cope with this influx of traffic particularly when we already battle Legoland traffic down the back lanes and speeding traffic through our village.
 - 3. The prevention of public nuisance:
- With the amount of traffic generated, as well as the noise from the sound systems, this will be a public nuisance for the residents of Holyport. The sound will carry across the fields for quite some distance, causing nuisance to a large number of people in a currently quiet and neighbourly village.
 - The protection of children from harm.
- At present Holyport is a safe and quiet village, with local residents allowing their children a good degree of freedom within its boundaries. However an influx of 3000 festival goers, plus the organisers, traffic increases, etc would totally disrupt this way of life and children would be unable to safely explore the village boundaries. In addition, with potential drink and drug use highly visible, this would set a terrible example to our children. I would be hugely uncomfortable with an event of this size taking place so close to my home and strongly feel it is against the interests of the children in the village.

With these points in mind, I would respectfully ask that this licence request is rejected.

Bray Parish Council have reviewed this application and have voted unanimously to write in to object to this application for the following reasons:

- 1. It should be noted the 2018 event was much smaller and held in a different field behind Braywood Hall, Fifield and not over three days at a time (Friday/Saturday/Sunday).
- 2. The licence now is for up to 3,000 attendees and for five separate events x three days.
- 3. The fields where this licence is now proposed are criss-crossed with public foot paths and are surrounded by three public bridleways 29/44/47.
- 4. The proposed use of two of these bridleways, Gays (44) and Green (47) Lane, for entering and exiting this event are single car width tracks with ditches either side. The use of these for this amount of cars, including lorries required for setting the event up, are a serious concern regarding the safety of members of the public walking/horse riding/cycling etc along them with cars trying to enter/exit the fields when parking, lorries delivering etc. It should be noted there are no passing areas on any of these Bridleways.
- 5. The exit onto Forest Green road from Green Lane Bridleway is onto a 'S' bend that has had along that stretch of road, at least 4 car accidents since January 2019. Up to 3,000 attendees etc entering and exiting onto this 'S' bend where one of the accident occurred is a safety issue for attendees and other road users.

Gays Lane bridleway leads onto Langworthy Lane which is a tramac road which is in places single car only width with ditches either side/no footpaths and not suitable for large vehicles or large volumes of cars - it should be noted that Bridleway 29 leads onto Langworthy Lane.

One end of Langworthy exits into Moneyrow Green via a single narrow entrance/exit onto a blind bend leading from Holyport green, the other end of it exits onto Holyport Road again on a blind bend - neither of these are suitable for large volumes of traffic or lorries.

None of the surrounding roads in Moneyrow Green and Holyport Road feed into are suitable for large volumes of additional traffic as most attendees will travel by car.

6. The applicants noise report is for humans but there is no report how it will affect the dogs and cats at Old Bean Kennels and Catteries which is just two open fields from site, nor how it will effect horse riders or families walking their dogs on the footpaths and bridleways.

Animals are more sensitive to noise and the Old Beam Kennels are in this quiet location as their lodgers are already in a environment which can make them stressed.

These events will also impact on the potential safety and well being of local equestrian/polo yards in the area, one of which is the Windsor Horse Rangers a charity for approximately 130 8-18 year old children which is located not more than 50 yards away from the site and who all use these bridleways.

There will also a impact on local wildlife, which include Great Crested Newts whose DNA has been found in surrounding ditches, which we understand are endangered.

We would like to finish by saying that BPC are aware that this event was well received last year by those who attended at the previous location behind Braywood hall, though admittedly with less attendees. We appreciate the organisers would like to increase attendance, hence the new location, but we feel for the reasons above this new proposed location is not the right one.

I would like to raise my objections to this licence application on the following grounds

- 1. Festivals are known for drug abuse and this licence would encourage and facilitate drug abuse in the Village of Holyport.
- 2. The festival organisers and attendees would need to use Green Lane and Gays Lane for access to the site. These are public Pathways and Bridleways. It is not safe for the public to be sharing these access routes with 3000 visitors and the necessary organising traffic. Gays Lane is used daily by horse riders and dog walkers for journeys between Fifield and Holyport. Gays Lane is not suitable for heavy traffic usage as there is no place to safely pass pedestrians and horse riders.
- 3. The festivities will create a public nuisance for residents in the vicinity of the events. Noise from the event will travel a long way particularly the bass frequencies from any music. Holyport is a quiet village environment in a conservation area. Also horse riders will be unable to use Gays Lane due to the sound from the festival which will spook the horses.
- 4. Children will be at risk at the festival due to more traffic using the surrounding roads in the villages of Fifield and Holyport. They will also be exposed to drug users who frequent music festivals.

Using the words of fellow Holyport resident and Chairman of the Holyport Residents Association please accept this email and following text as our objection to this application.

I write to object as follows using the topics that your website identifies;

- (1) Prevention of Crime and Disorder Such festivals are known for drug misuse.
- (2) Public Safety It is unsafe to use Gays and Green Lane (which are public pathways and bridleways) for access for the 3,000 attendees, including lorries for setting everything up etc, and traffic difficulties if 3,000 attendees arrive in vehicles. I write with reference to the above licensing application for up to 5 festivals per annum for the entertainment of 3000 people each occasion on land adjacent to Gays Lane, Holyport. Known as Fi Fest.

I object in the strongest possible terms to the granting of this license. The location and site are wholly unsuitable for such festival events in the small village of Holyport.

Public nuisance - Loud music until late at night often concluding with fireworks will be intrusive and unacceptable to local residents, families, pets and livestock. The frequencies of base speakers transmitting over open fields and farmland and will also be a nuisance and unacceptable.

Festival events are known to attract drug misuse and the paraphernalia associated with it, creating potential crime and disorder. This must be deterred at all cost.

Access to the proposed site along Gays Lane and Green Lane which are just narrow public pathways and bridle ways are wholly unsuitable for traffic generated by 3000 attendees and the associated lorries and vans with equipment for staging and breaking down such an event. It is essentially adjacent to a quiet residential area where people, children and dogs enjoy walking. A festival and associated traffic would turn these small roads into accidents waiting to happen.

The proposed site is exposed and often very windy and given the inevitable rubbish mountains generated at these events the potential debris and polluting of the local area is unacceptable for both residents and wildlife. Who will fund the clear up?

Permitting such public gatherings on Green Belt Land up to 5 times a year will create unacceptable inconvenience to the people of the village of Holyport. I wish to object to this application. This is not the right site.

I would like to start by advising that even though permission has not been granted for this licence, Eventbrite is already selling online tickets for an 13/14 July 2019 event on this application site at https://www.eventbrite.co.uk/e/fifest-2019-tickets-55081589517.

There are also discrepancies with times for the licence ie in their Noise Management supporting document states the event on Sunday, 14 July will end at 9 pm, but the Eventbrite website says 11 pm and their licence application form says 10pm on Sundays. There seems little consistency on what is an important issue.

1. the prevention of crime and disorder

- a. have Thames Valley Police been consulted about the suitability of this site for such large events and given their current financial constraints, do they have the resources to ensure it can be adequately policed in the event of an incident?
- b. I note that alcohol will be served up to 11 pm Fri/Sat and up to 10 pm on Sunday which is worrying as ticket holders will be able to drink for an 11 hour period during what could be hot summer weekends and be dehydrated
- c. how will the organisers ensure that drugs will not be sold at this event?

2. public safety

- a. the applicants advise that a similar event was held last year and was successful. However, this was a one-day event, on a different site with only 300 people attending. I do not think this is comparable to the current application for 5 x 3-day events per year. And by their own admission they say they have long experience of running a town centre venue which is again not comparable to this application site on farmland for 3000 people
- b. The applicants say that to control the number admitted to max 3000 for the licence, only advance ticket holders will be admitted. However, on one of their supporting documents (Traffic Management see attached) it clearly states at the Forest Green Road entrance that people can pay on entry which is clearly not advance booking tickets only. See below, so how will they control the number admitted in the interests of public safety?

ENTRANCE - All Fi.Fest customers would have to produce their booking confirmation at the main gate or pay on entry. Taxis would be directed to the drop off zone

- c. the entrance via Forest Green Road is unsafe. This is a B-road with a 50 mph and is near an S-shaped bend. To have a large volume of traffic entering/departing the site in a limited timeframe would be very dangerous
- d. Green Lane and Gays Lane are bridleways frequented by horse riders, cyclists and dogwalkers. Not only will loose dogs be in danger from the traffic but horses will be spooked by the loud music from the field and all the activity there in addition to cars and lorries accessing the site using these single carriageways which could potentially cause a serious accident as there are no passing points
- e. The Applicants advise that Gays Lane entrance will be used for bands only to access the site. Members of the public are supposed to access via Forest Green Road. However, Gays Lane is only accessible via Langworthy Lane which is another single-track carriageway and is not meant to be used for lorries which will undoubtedly be used by the bands to carry their equipment. This will be dangerous to users of the bridleways.
- f. Additionally, local people familiar with Holyport will know that the site can be accessed via Langworthy Lane/Gays Lane and will not want to drive the extra distance to access via Forest Green Road/Green Lane. Will they be turned away by Marshalls at the Gays Lane security site and told to access via Forest Green Road? There is no turning point in Gays Lane!

3. the prevention of public nuisance

- a. Holyport is an historic village and this will disturb the peace of the countryside late into the night. A licence until 11 pm Fri/Sat and 10 pm Sun is too late in a rural area close to residential developments. Residents in Fifield will also be affected. Sunday which is a school night for local children so a 10 pm finish is too late
- b. noise nuisance will upset the dogs/cats at Old Beams Kennels and the Horse Rangers not too far from the proposed venue on the Forest Green Road
- c. The applicant states there will be sound checks and rehearsals from 10 am but how and at what time will the support staff and other suppliers attending the event access the site? If the licence is from 10 am surely drink stalls, the bands, toilet facilities, large film screens etc will need to be onsite and setting up much earlier than that and also taking down well after the times stated on the licence. Local residents will have the noise of lorries/activity well before 10 am and after midnight.

Dear Sir/Madam,

I refer to the application to hold festivals on land adjacent to Gays Lane, Holyport for up to 3,000 persons annually and submit my strong objection to the proposal for the following reasons:-

- 1) Access from every direction to the proposed venue is by single track road, much of which is tarmacked but a part is just a cinder track, which would be destroyed by vehicular traffic. It is not just the very poor access that I object to but the imposition of thousands of people trying to find somewhere to park along the single track road or even along the adjacent main road, would result in really bad traffic congestion for the regular road users and for residents. This does not take into account the large number of lorries that would be required to bring the seating, stages and sound equipment to the venue. It is not as though Holyport has a history of such events or the means to park a few thousand cars, with several points of access and egress. The proposed location is not at all comparable to other events in the area such as the Henley Music Festival.
- 2) The public nuisance resulting from such a festival cannot be underestimated not only will there be loud music and the transmission of such music with possibly some very heavy bass sections over long distances but there is the likelihood that the attendees will be careless with their rubbish which will be blown around the surrounding fields. As mentioned in the previous paragraph the lack of any parking near the proposed venue will have a knock on effect on all the inhabitants. Further as evidenced by the invasion of the travellers several times on Holyport Green last year and the appalling mess they left, such a proposal really makes on think about the impact on the Green Belt of other much larger crowds. No one thought that the Travellers would behave as they did but I had to clear up human excrement and used nappies from my property.
- 3) Indeed following on from the last paragraph, there may well be disorder and petty crime as a result of so many people attending a festival in Green Belt farmland. It would not be unusual for drug taking and petty larceny to occur.

In conclusion if such an event were to go ahead, it would set a terrible precedent for such events to occur with some regularity much against the wishes of local residents.

I am more than surprised that the organisers are apparently already selling tickets for an event for which they do not even have a licence — what presumption.

7. The proposal by the applicant to litter pick 100m after these events is not enough. These are mainly open fields with a few hedgerows and litter can be blown further afield due to its flat landscape there by causing a health and safety issue for local residents and wildlife.





We are writing to object to the above New Premises Licence.

- 1. Last year the event was held in a field behind Braywood Hall in Fifield under a TENs (temporary event notices), a TEN covers only 499 people (including staff or volunteers).
- 2. This new licence is for up to 3,000 attendees in a different location in a agricultural field on a Farm, on the Holyport/Fifield boarder, over three days for up to five events a year. You really cannot compare like for like here in regard to either event or location.
- 3. The fields where this licence is now proposed are criss-crossed with public foot paths and are surrounded by three public bridleways 29/44/47, all of which are well used.
- 4. The bridleways, Gays (44) and Green Lane (47), proposed for entering and exiting this event, are single car width tracks with ditches either side. The use of these for this amount of cars, including lorries required for setting the event up, are a serious concern regarding the safety of members of the public, including walkers/horse riders/cyclists. Cars would be trying to enter/exit the fields when parking, lorries delivering etc.

It should be noted there are no passing areas on any of these Bridleways.

5. The exit onto Forest Green Road from Green Lane Bridleway is onto a 'S' bend that has, in the past, had at least 4 car accidents along it since January 2019. Up to 3,000 attendees etc entering and exiting onto this 'S' bend, is a safety issue for attendees and other road users. It should be noted that there are no footpaths on Forest Green Road.

Gays Lane bridleway leads onto Langworthy Lane which is a tramac road which is, in places, single car only width with ditches either side. There are no footpaths and it is not suitable for large vehicles or large volumes of cars - it should be noted that Bridleway 29 leads onto Langworthy Lane.

One end of Langworthy Lane exits into Moneyrow Green is via a single narrow entrance/exit onto a blind bend leading from Holyport Green. The other end exits onto Holyport Road again on a blind bend from Holyport Green - neither of these are suitable for large volumes of traffic or lorries.

None of the surrounding roads that Moneyrow Green and Holyport Road feed into are suitable for large volumes of additional traffic as most attendees will travel by car.

6. The applicants noise report is for humans but there is no report on how it will affect the dogs and cats at Old Beams Kennels and Catteries which is just two open fields from the stage. Neither does it show how it will affect horse riders or families walking their dogs on the footpaths (some of which will be blocked by the events) and bridleways.

Animals are more sensitive to noise and the Old Beams Kennels are in this quiet location as their lodgers are already in a environment which can make them stressed.

These events will also impact on the potential safety and well being of local equestrian/polo yards in the area, one of which is the Windsor Horse Rangers a charity for approximately 130 8-18 year old children which is located not more than 50 yards away from the site and who all use these bridleways.

There will also be an impact on local wildlife, which include Great Crested Newts whose DNA has been found in surrounding ditches, which we understand are endangered.

7. The proposal by the applicant to litter pick 100m after these events is not enough. These are mainly open fields with a few hedgerows and litter can be blown further afield due to its flat landscape there by causing a health and safety issue for local residents and wildlife.

Holyport, as a village, has four public houses which regularly during the year have events for both adults and families which are well supported. We also have three events on Holyport Green each year, Holyport Fair, Carters Steam Fair and Christmas Carols. We do not need anymore events.

We ask you please, not to allow this licence.

I write to OBJECT to the application using the topics that your website identifies;

(1) Prevention of Crime and Disorder:

With lots of visitors' cars parked in neighbouring roads, where there is little to no security, opportunistic thieves will be tempted the area to break into cars. Cars of local residents will become at greater risk from theft as a result.

I would think that a significant number of people who attend the event will be drinking, If they are not allowed to leave their car overnight in the car park, this could increase the risk of drink drivers in the area.

(2) Public Safety:

Cars currently drive far too fast down Langworthy Lane. With additional cars using the lane on event weekends and cars parking on this lane when the events are on, the chances of an accident occurring are increased. Many do walkers use this lane every day and they will be at increased risk of being involved in an accident.

I would think that a significant number of people who attend the event will be drinking, If they are not allowed to leave their car overnight in the car park, this could increase the risk of drink drivers in the area, causing a huge concern for public safety.

(3) The prevention of public nuisance

The event will have car parking available, but not overnight parking. As a result, many visitors to the event will park their car in a neighbouring road where they can then drink and pick their car up the next day. The lanes in close proximity to the event are very narrow and the parking of any cars on these would cause a public nuisance.

The event organisers say that they will pick up litter within 100m of the site following an event. People will be walking towards the event from much further away than 100 metres and therefore litter from the event will be a problem way beyond their 100m boundary.

(4) The protection of children from harm

Cars currently drive far too fast down Langworthy Lane. With additional cars using the lane on event weekends and cars parking on this lane when the events are on, the chances of an accident occurring are increased. Children are more difficult to see on the road due to their size and will be at increased risk of injury.

Two aspects of this licence application are of particular concern to us:

- (1) The site of the proposed festivals lies between two frequently used bridleways and it should be obvious that horse riding and the type of festival outlined are mutually exclusive activities. The real possibility of horses being startled raises an issue of public safety. In addition the associated vehicular movements on Forrest Green Road, which already attracts large numbers of weekend cyclists, could easily coincide with periods of Legoland traffic diversions and this would inevitably constitute another potential safety issue.
- (2) Regarding public nuisance issues there exists a network of footpaths crisscrossing the farmland between Gay's Lane and Primrose Lane making this the first area of readily accessible, truly open, quiet countryside south of the Holyport conurbation. As frequent local walkers ourselves we can confirm that these tracks and paths are used daily but especially at weekends by local walkers, many with dogs, and enjoyment of this amenity would be totally destroyed by the noisy activities of multiple festivals.

For the above reasons we oppose the granting of this licence.






I live in the village of Holyport and was recently made aware of a licensing application by our Residents Association. The email circulated to all of the residents on its mailing list included several reasons why it felt the application should be rejected whilst encouraging others to join them by writing into the Borough with similar (if not the same) reasons for objections. In doing this, they unfortunately spread various inaccurate information including how dangerous the events would be, the nuisance they would bring and to be quite frank, scare mongering without any justification or supporting evidence for its claims.

It needs to be said that these concerns are not representative of many residents within the village. Last year's Fi.Fest event was a great success, both very well organised and run and a great boost for the community. I am not aware that there were any problems relating to those highlighted by the Residents Association and so ask that the the application be approved.

I understand there are various suggestions by some residents that public rights of way are to be temporarily blocked off to allow the events to proceed. I find this difficult to understand since the plans accompanying the application clearly demonstrate something quite different. The extents of the event have been designed to fall within the public rights of way and not obstruct them at all.







Our Residents Association also stated that the Borough's Rights of Way Officer had raised (or intends to raise) various objections relating to the use of the public rights of way surrounding the field. Green Lane and Gays Lane, for which will be the two roads used to access the events from the public highway are considered Bridleways on the Borough's Definitive Map (sheet 10). Albeit there are therefore restrictions on the general public as to how they can use them, the land for which they run is privately owned and can be used for any purpose its landowner sees fit. If the landowner wants to grant permission to allow cars or other vehicles to pass over them without restriction then it can and this is not a consideration the licensing department should be concerning themselves with.

At the end of the day, if it is felt that the event organiser is not able to meet the various conditions the Borough can impose on the applicant to ensure they are safely run should it grant it a licence, the Borough can at any time revoke the licence or simply not issue a new one should another application be made in the future. It is very simple and ask that our community be allowed to enjoy the events in its village.

I attended last years event with my 5 year old son, Max. Max is autistic and attends Manor Green school. Much of Max's life exists at a certain level of segregation from 'normal' children. There really is a limited amount of businesses and experiences that Max can visit or undertake that exposes him to the things that we all take for granted. Last year's Fi.Fest event was one of those. It was incredibly well organised and safe. The KidsZone had an array of attractions for all ages, tastes and abilities and anyone that attended could have seen how happy and engaged the children were and how proud and happy that made the parents. Max had one of the best days of his life, playing, taking part and interacting with other children, in a capacity that is incredibly rare for him. I feel it would be a real shame, even a tragedy if you allow me to be emotional about this; if after only one successful year that this event would be lost to the local community on the grounds of such technicalities of the disruption of public rights of way and the like over a two day period. 

So this event allows young people to see their parents socialising at an event where alcohol is served under a controlled environment. There are no packs of unruly youths running around with cans of beer, as in some uncontrolled events which are free for anyone to wander in or out. I would not want my kids to see that or be exposed to it. This event reminded me of some of the European festivals, like the Asparagus festival in Hamburg, where unruly youngsters are unheard of.

In a time where communities are losing their central sources of togetherness, such as community centres etc, I strongly believe that events such as these can galvanise the community ethos, and are beneficial towards the prevention of all of the terms under which licensing applications may be granted.

The children that attended last years Fi.Fest event were by far the greatest beneficiaries of all. The children's area was a safe environment, that consisted of many events of what can only be termed, good wholesome entertainment. There was a strong emphasis on interaction, learning and fun; and all events were managed by children's entertainment professionals. Anyone that attended last year could testify to the positive impact that this event had on their children. In terms of the licensing objective of prevention of children from harm, I feel this event strongly qualifies as fulfilling this objective.

On a personal level, I am aware, after being forwarded an email circulated to the Holyport Residents Association, the basis for the objections to this application. I find the contents of that email to be so far from the actuality of what the event entailed last year, and the planning put in place to manage this year's event; that I worry that the local community has been entirely misled about the application. Further to that, I was surprised to see details of the application in that email, that when I checked could not be accessed by me via the RBWM website. Given the dialogue that has been taking place within the local community about where

the opposition to this application is actually being generated from, I find the whole affair to reflect incredibly badly on those sources.

I strongly urge this application to be granted.
