## MEMBERS' GUIDE TO DECLARING INTERESTS IN MEETINGS

### Disclosure at Meetings

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a DPI or Prejudicial Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

A member with a DPI or Prejudicial Interest **may make representations at the start of the item but must not take part in the discussion or vote at a meeting.** The speaking time allocated for Members to make representations is at the discretion of the Chairman of the meeting. In order to avoid any accusations of taking part in the discussion or vote, after speaking, Members should move away from the panel table to a public area or, if they wish, leave the room. If the interest declared has not been entered on to a Members' Register of Interests, they must notify the Monitoring Officer in writing within the next 28 days following the meeting.

### Disclosable Pecuniary Interests (DPIs) (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any licence to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where:
  - a) that body has a piece of business or land in the area of the relevant authority, and
  - b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body **or** (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

A Member with a DPI should state in the meeting: ***'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

Or, if making representations on the item: ***'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

### Prejudicial Interests

Any interest which a reasonable, fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs the Member's ability to judge the public interest in the item, i.e. a Member's decision making is influenced by their interest so that they are not able to impartially consider relevant issues.

A Member with a Prejudicial interest should state in the meeting: ***'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

Or, if making representations in the item: ***'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

### Personal interests

Any other connection or association which a member of the public may reasonably think may influence a Member when making a decision on council matters.

Members with a Personal Interest should state at the meeting: ***'I wish to declare a Personal Interest in item x because xxx'. As this is a Personal Interest only, I will take part in the discussion and vote on the matter.***

#### **A) The Application – Appendix A**

Applicant: - Martin McColl Limited

Premises: - McColls, 4 Brockenhurst Road, South Ascot, Berks. SL5 9DL.

The application relates to an application for a new Premises Licence

A summary of the application is as follows:-

The standard opening hours of the premises:

- 06.00 until 23.00 Monday to Sunday

To permit the sale by retail of alcohol for consumption OFF the premises:

- 06.00 until 23.00 Monday to Sunday

Designated Premises Supervisor (DPS): Mr. David Davenport

#### **B) Relevant Representations Received**

Where a representation about an application is made by a responsible authority or by another person, and the representation is relevant, the application is brought before a Licensing Panel Sub Committee.

To be “relevant”, the representation has to relate to the likely effect of the grant of the licence on the promotion of at least one of the four licensing objectives which are set out in the Licensing Act 2003.

The four licensing objectives are;

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance; and
- The protection of children from harm.

In this case the representations received from the responsible authorities are as follows;

Please note, the response from the Planning Officer is not “relevant” for the purposes of the Licensing Act 2003 as it does not relate to one or more of the four licensing objectives (it relates to the authorised use class of the building which is the subject of this application) and so is included here for information only at **Appendix B**.

Representations received from other persons are as follows;

- 24 individual representations from local residents (**Appendix C**)
- Petition signed by 275 local residents (**Appendix D**)

The representations from local residents are relevant because they relate to one or more of the four licensing objectives.

The petition refers to public safety (the increased dangers of crossing the road) and public nuisance (noise and disruption for the people and the village). It can therefore be regarded as relevant and the Sub Committee will make its own judgement as to the weight to give to this document.

The sections of the RBWM Licensing Policy relevant to this application are;

#### 6.1 Framework Hours

Having considered the evidence of alcohol related crime, disorder and anti-social behaviour, the number of late night premises and, in particular, the social, practical and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours are:

Premises Type	Commencement Hour for Licensable Activities No earlier than :	Terminal Hour for Licensable Activities No later than:
• Off licence	• 09.00	• 23.00
• Restaurant	• 09.00	• 01.00



• Pub/bar/night club	• 10.00	• 02.00

(As can be seen, the licenced hours applied for in this application fall outside RBWM framework hours for “off licence” premises.)

Framework Hours are intended to guide applicants on the Licensing Authority’s expectations when preparing their Operating Schedule. However, if no relevant representations had been received, the application would have been granted by the Licensing Authority under delegated powers.

#### 6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the Licensing Authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to\*:

- The nature of the activities
- The character of the surrounding area
- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas
- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours
- Winding down periods, particularly in public houses and nightclubs etc.

(\*Note – not all of these will be relevant to this particular application)

#### 7. Promoting the Prevention of Crime and Disorder

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues\* in relation to the crime and disorder objective:

- Measure to prevent bottles being carried from premises
- Use of drinks’ promotions
- Measure to prevent binge drinking
- Participation in the Pub Watch Scheme
- Use of door supervisors
- Training staff in crime prevention measures

- Search procedures
- Use of close circuit television
- Lighting
- Where premises are new, designing out crime
- Quality of surveillance of premises

(\*Note – not all of these will be relevant to this particular application)

## 9. Promoting the Prevention of Public Nuisance

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues\* in relation to the public nuisance objective:

- The disposal of waste, particularly glass
- The use and maintenance of plant, including air extraction and ventilation systems
- Litter in the vicinity of the premises
- Noise from deliveries / collections to and from the premises
- Measures to control behaviour and queues
- Whether door supervisors are able to stay at the entrance to encourage quiet departure
- The provision of Hackney Carriage / Private Hire services at the premises
- Signs on doors and on tables encouraging consideration to the neighbours

(\*Note – not all of these will be relevant to this particular application)

## 10. Promoting the Prevention of Children from Harm

RBWM recognizes that the protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms directly associated with alcohol consumption but also wider harms such as exposure to strong language and the need to protect children from sexual exploitation.

All applicants need to demonstrate how children and young people will be safeguarded if attending the licenced premises, or how it will be ensured that they do not gain access to the premises if not appropriate. Where relevant representations are made in relation to the protection of children from harm the Licensing Authority may impose conditions restricting the access of children or excluding them altogether from licensed premises.

### Proof of Age Cards

Where necessary and appropriate, a requirement for the production of proof of age cards before any sale of alcohol is made could be attached to any premises licence or club premises certificate for the protection of children from harm.

The sections of the Guidance relevant to this application are;

### **Licensing objectives and aims**

1.2 The legislation provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are undertaken.

1.3 The licensing objectives are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance; and
- The protection of children from harm.

1.4 Each objective is of equal importance. There are no other statutory licensing objectives, so that the promotion of the four objectives is a paramount consideration at all times.

1.5 However, the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work. They include:

- protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises;
- providing a regulatory framework for alcohol which reflects the needs of local communities and empowers local authorities to make and enforce decisions about the most appropriate licensing strategies for their local area; and
- encouraging greater community involvement in licensing decisions and giving local residents the opportunity to have their say regarding licensing decisions that may affect them.

### **Crime and disorder**

2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).

2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and

crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

## **Public nuisance**

2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.

2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.

2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.

2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

## **Protection of Children from harm**

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly to alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered.

2.26 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.

2.27 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:

- Restrictions on the hours when children may be present;
- Restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
- Restrictions on the parts of the premises to which children may have access;
- Requirements for an accompanying adult (including for example, a combination of requirements which provide that children under a particular age must be accompanied by an adult); and
- Full exclusion of people under 18 from the premises when any licensable activities are taking place.

## **Hearings**

9.38 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the licensing authority must give appropriate weight to:

- the steps that are appropriate to promote the licensing objectives;
- the representations (including supporting information) presented by all the parties;
- this Guidance;
- its own statement of licensing policy.

## **E) Conclusion**

The Licensing Panel Sub Committee is obliged to determine this application with a view to promoting the four licensing objectives which are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Sub Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy. Of course, the Committee must have regard to all of the representations made and the evidence that it hears.

The Sub Committee must then take such of the following steps as it considers appropriate for the promotion of the four licensing objectives:

- Grant the application as submitted
- Modify the conditions of the licence, by altering, omitting or adding to them
- Reject the whole or part of the application.

Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.

- Live music: no licence permission is required for:
  - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience,

and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.

We have had a series of antisocial behaviour with youths 'hanging out' on the green in front of the Oliver Road houses (numbers 13 to 41), often staying on the green until the sun rises and leaving us residents unable to sleep. I absolutely believe that a premises on the corner with an alcohol licence from 6am to 11pm will drive even further antisocial behaviour and nuisance to the immediate residents. ### PUBLIC SAFETY AND THE PREVENTION OF PUBLIC NUISANCE

This locality is already served by convenience store which sells alcohol. There are also two public houses.

According to Public Health England:

Alcohol sales in England in 2014: Analysis to assess suitability for inclusion as an indicator in the Local Alcohol Profiles for England.

"The concentration of licensed premises was found to have a positive association with (hospital) admissions. For every additional licensed premise per square kilometre the alcohol- specific admission rate rose by 4.4 on average."

These premises are on the corner of South Ascot Village Green, there is already a problem with excess alcohol consumption by groups gathering on the green, and I have myself twice felt threatened by drunken youths whilst making my way to my home. The proximity of McColls to the green would only exacerbate this problem of antisocial behaviour fuelled by alcohol.

There is inadequate parking provision for customers and no place for lorries to park to make deliveries without blocking access to Oliver Road (west). This means no access for ambulances (there are elderly residents) or fire engines.

This can also cause considerable inconvenience to residents to either leave or gain access to their homes.

- In 2016/17 in England and Wales, 12.4% of theft offences, 20.6% of criminal damage and 21.5% of hate crimes were alcohol-related [15].

- In 2014-2016 in England and Wales, alcohol-related violent incidents made up 67% of violent incidents which take place at the weekend and 68% of those which take place during the evening and night [12].

I am writing to register my objection to the application for a premises licensed by Martin MCColls Limited.

The basis for this opposition is that granting a licence for these premises will not promote the licensing objectives, particularly the prevention of crime, disorder and antisocial behaviour.

4 Brokenhurst Road, South Ascot, SL5 9DL is situated on a heavily populated residential road with young families and elderly residents. Enabling the premises to sell alcohol would be totally detrimental to a safe environment clear from nuisance and anti-social behaviour.

The application proposes that alcohol will be sold for consumption off the premises between 6:00am and 11:00pm, seven days a week. I would like to point out that the license policy statement 2016-2021 in line with Section 5 of the Licensing Act 2003, states that off licenses are only authorised to sell alcohol between the hours of 9:00am -11:00pm. Furthermore, granting a licence would provide a further source of alcohol within an area already so heavily populated with licensed premises that crime, disorder and public nuisance have already reached problem levels for the local police and local residents.

Residents in this area already suffer noise nuisance and antisocial behaviour at all hours of the day and night from Ascot high street pubs, restaurants, Ascot Racecourse (especially in peak seasons) and the Swinley Pub on Brockenhurst Road. I've only lived on Brockenhurst Road for a year and have witnessed as a result of alcohol consumption, homeless men drinking and hurling abuse at neighbours and children. The homeless men lived in the currently vacant Hynns Restaurant and also often camp on the village green. Drinkers from the Swinley pub and Ascot racecourse and high street urinating down the side of my property and other property's down the road. Please understand that granting permission will fuel this activity.

If this application does proceed, how can the Licensing Authority have particular regard to the following issues in relation to the crime and disorder objective and prevent them from occurring in the future if permission is granted?:

1. Use of close circuit television on the premises and neighbouring residential properties - to discourage anti-social behaviour and damage.
2. Lighting - to prevent theft and robbery and violence?
3. Where premises are new, designing out crime?
4. Quality of surveillance on premises?

5. Ensuring that the effects caused from drinking outside and buying alcohol from the proposed premises does not impact on the neighbouring residents, including noise and behaviour?

The local residents along Brockenhurst Road have endured inconveniences such as these since 2003 when the licensing legislation was first amended, and it is totally unacceptable to expect them to continue to do so.

The licensing authority will also need to consider the likely effect the proposed application will also have on local business. The Swinley Newsagents who are a local business would struggle to compete against a larger business such as MCColls. This would be a real shame to see local business go under as a result of poor planning.

I am writing to object to the alcohol license and planning application for McColls at 4 Brockenhurst Road, South Ascot. There is no need for yet another shop/pub/restaurant selling alcohol in our quiet neighbourhood. I believe there are already well over a dozen such places within a mile radius! The main reasons for my objection include:

- Concern for the increase in crime and disorder in the neighbourhood resulting from easier access to alcohol from the proposed very long business hours to sell alcohol (understood to be 6am-11pm). We have recently had a series of antisocial behaviour incidents down Oliver Rd, with people drinking and socialising on the green in front of the Oliver Road houses (numbers 13 to 41) late into the night and several cars also being broken into along the road (caught on cameras).
- The parking facilities to support a shop with such long business hours and frequent usage are wholly inadequate. There are not enough spaces provided and the set-up of the parking means cars will have to reverse out onto the main Brockenhurst Road (there is no 'turning circle' for cars pulling into the store). There is the added potential to block cars from Oliver Rd home owners entering and leaving Oliver Rd (a private road) due to poorly parked cars and inconsiderate customers is inevitable -- historical evidence can be fully understood from recent local examples along Ascot High Street (Tesco Express and Sainsbury's Local), Sunninghill (One Stop and Londis), Chobham (Tesco Express and The Co-Op), and many others.
- I'm also aware that the convenience stores in Sunninghill High Street (both One Stop and Londis, within 1 mile of the site) has been 'raided' on more than a few occasions, and would expect that a larger shop such as McColls will be a target for this type of crime. I am writing to make a formal objection to the conversion of Hyn's restaurant, 4 Brockenhurst Rd, South Ascot into a McColl's off licence and newsagent under Section 17 of the licensing act 2003. I live directly opposite the site and neighbours and myself would be directly affected by the creation of such a business on our doorstep.

**Preventing this business from opening is essential** as it will affect:

- **Public disorder** in an area that already deals with anti-social behaviour, drunkenness and drug taking in local parks.
- **Public safety**; loitering will almost inevitably take place, intimidating all, but especially both young children and elderly people. It would contribute to considerable **public nuisance**; the neighbouring park is likely to provide an area for alcohol to be consumed, affecting the safety of the area, as well as contributing considerable noise.




