## MEMBERS' GUIDE TO DECLARING INTERESTS IN MEETINGS

### Disclosure at Meetings

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a DPI or Prejudicial Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

A member with a DPI or Prejudicial Interest **may make representations at the start of the item but must not take part in the discussion or vote at a meeting.** The speaking time allocated for Members to make representations is at the discretion of the Chairman of the meeting. In order to avoid any accusations of taking part in the discussion or vote, after speaking, Members should move away from the panel table to a public area or, if they wish, leave the room. If the interest declared has not been entered on to a Members' Register of Interests, they must notify the Monitoring Officer in writing within the next 28 days following the meeting.

### Disclosable Pecuniary Interests (DPIs) (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit made in respect of any expenses occurred in carrying out member duties or election expenses.
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the relevant authority.
- Any licence to occupy land in the area of the relevant authority for a month or longer.
- Any tenancy where the landlord is the relevant authority, and the tenant is a body in which the relevant person has a beneficial interest.
- Any beneficial interest in securities of a body where:
  - a) that body has a piece of business or land in the area of the relevant authority, and
  - b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body **or** (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

A Member with a DPI should state in the meeting: ***'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

Or, if making representations on the item: ***'I declare a Disclosable Pecuniary Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

### Prejudicial Interests

Any interest which a reasonable, fair minded and informed member of the public would reasonably believe is so significant that it harms or impairs the Member's ability to judge the public interest in the item, i.e. a Member's decision making is influenced by their interest so that they are not able to impartially consider relevant issues.

A Member with a Prejudicial interest should state in the meeting: ***'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

Or, if making representations in the item: ***'I declare a Prejudicial Interest in item x because xxx. As soon as we come to that item, I will make representations, then I will leave the room/ move to the public area for the entire duration of the discussion and not take part in the vote.'***

### Personal interests

Any other connection or association which a member of the public may reasonably think may influence a Member when making a decision on council matters.

Members with a Personal Interest should state at the meeting: ***'I wish to declare a Personal Interest in item x because xxx'. As this is a Personal Interest only, I will take part in the discussion and vote on the matter.***

### CONSIDERATION OF AN APPLICATION OF A NEW PREMISES LICENCE UNDER THE LICENSING ACT 2003

#### **A) The Application – (Appendix A)**

Applicant: La Cloche Pub Company Ltd

Registered Number: 07000819

Premises: Carpenters Arm, 78 Upper Village Road, Sunninghill, SL5 7AQ

A map of the area surrounding the premises is at **(Appendix B)**.

The application is to:

1. To extend the terminal hour for the sale of alcohol to 00:00, Monday to Sunday.
2. To extend the opening hours to allow the premises to close at 00:30 hours Monday to Sunday.
3. To add the provision of late night refreshment from 23:00 hours until 00:00 hours, Monday to Sunday.
4. To remove the existing non-standard timings for Good Friday and Christmas Day.
5. To add non-standard timings for live music, recorded music and late night refreshment on New Year's Eve until 01:00 hours.
6. To remove all conditions in Annex 2 of the premises licence, and replace them with the operating schedule detailed in the application.

A summary of the application is as follows:

#### **B) Relevant Representations Received**

#### 6.1 Framework Hours



Having considered the evidence of alcohol related crime, disorder and anti-social behavior, the number of late-night premises and, in particular, the social, practical and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours are:

Premises Type	Commencement Hour for Licensable Activities No earlier than:	Terminal Hour for Licensable Activities No later than:
• Off licence	• 09.00	• 23.00
• Restaurant	• 09.00	• 01.00
• Pub/bar/night club	• 10.00	• 02.00
• Takeaway	• n/a	• 02.00

(As can be seen, the licensed hours applied for in this application fall outside RBWM framework hours for “ Off Licence” premises.)

Framework Hours are intended to guide applicants on the Licensing Authority’s expectations when preparing their Operating Schedule. However, if no relevant representations had been received, the application would have been granted by the Licensing Authority under delegated powers.

#### 6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the Licensing Authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to\*:

- The nature of the activities
- The character of the surrounding area
- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas

- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated

Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours

- Winding down periods, particularly in public houses and nightclubs etc.

(\*Note – not all of these will be relevant to this particular application)

## 7. Promoting the Prevention of Crime and Disorder

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues\* in relation to the crime and disorder objective:

- Measure to prevent bottles being carried from premises
- Use of drinks' promotions
- Measure to prevent binge drinking
- Participation in the Pub Watch Scheme
- Use of door supervisors
- Training staff in crime prevention measures
- Search procedures
- Use of close circuit television
- Lighting
- Where premises are new, designing out crime
- Quality of surveillance of premises

## 9. Promoting the Prevention of Public Nuisance

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues\* in relation to the public nuisance objective:

- The disposal of waste, particularly glass
- The use and maintenance of plant, including air extraction and ventilation systems
- Litter in the vicinity of the premises
- Noise from deliveries / collections to and from the premises
- Measures to control behaviour and queues
- Whether door supervisors are able to stay at the entrance to encourage quiet departure
- The provision of Hackney Carriage / Private Hire services at the premises
- Signs on doors and on tables encouraging consideration to the neighbours

## 10. Promoting the Prevention of Children from Harm

RBWM recognizes that the protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms directly associated with alcohol consumption but also wider harms such as exposure to strong language and the need to protect children from sexual exploitation.

All applicants need to demonstrate how children and young people will be safeguarded if attending the licenced premises, or how it will be ensured that they do not gain access to the premises if not appropriate. Where relevant representations are made in relation to the protection of children from harm the Licensing Authority may impose conditions restricting the access of children or excluding them altogether from licensed premises.

#### Proof of Age Cards

Where necessary and appropriate, a requirement for the production of proof of age cards before any sale of alcohol is made could be attached to any premises licence or club premises certificate for the protection of children from harm.

The sections of the Guidance relevant to this application are;

#### **Licensing objectives and aims**

1.2 The legislation provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are undertaken.

1.3 The licensing objectives are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance; and
- The protection of children from harm.

1.4 Each objective is of equal importance. There are no other statutory licensing objectives, so that the promotion of the four objectives is a paramount consideration at all times.

6.5 However, the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work. They include:

- protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises;
- providing a regulatory framework for alcohol which reflects the needs of local communities and empowers local authorities to make and enforce decisions about the most appropriate licensing strategies for their local area; and
- encouraging greater community involvement in licensing decisions and giving local residents the opportunity to have their say regarding licensing decisions that may affect them.

## **Crime and disorder**

2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).

2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

## **Public nuisance**

2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.

2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.

2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.

2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

### **Protection of Children from harm**

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly to alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered.

2.26 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.

2.27 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:

- Restrictions on the hours when children may be present;
- Restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
- Restrictions on the parts of the premises to which children may have access;
- Requirements for an accompanying adult (including for example, a combination of requirements which provide that children under a particular age must be accompanied by an adult); and
- Full exclusion of people under 18 from the premises when any licensable activities are taking place.

## **Hearings**

9.38 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the licensing authority must give appropriate weight to:

- the steps that are appropriate to promote the licensing objectives;
- the representations (including supporting information) presented by all the parties;
- this Guidance;
- its own statement of licensing policy.

## **E) Conclusion / Summary**

The Licensing Panel Sub Committee is obliged to determine this application with a view to promoting the four licensing objectives which are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Sub Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy. Of course, the Committee must have regard to all of the representations made and the evidence that it hears.

The Sub-Committee must, having regard to the application and to the relevant representations, take such step or steps as it considers appropriate for the promotion of the licensing objectives. The steps are:

- (a) Reject the application;
- (b) Refuse to specify a person in the licence as the premise's supervisor;  
(\*Note – not all of these will be relevant to this particular application)
- (c) Grant the application but modify the activities and/or the hours and/or the conditions of the licence;
- (d) Grant the application.

Where conditions are attached to a licence then reasons for those conditions must be given.

The Sub-Committee are reminded that any party to the hearing may appeal against the decision of the Sub-Committee to the Magistrates' Court within 21 days of the notification of the determination.

**The Sub-Committee are asked to determine the application.**

**Financial implications:** None directly but Members should be aware that any decision of the Sub-Committee may be appealed against in the Magistrates' Court and such an appeal may involve additional costs and possible costs against the Council.

**Environmental/Sustainability Implications:** Any authorisation under the Licensing Act 2003 may give rise to environmental implications both positive and negative depending upon the application and any measures proposed to take control adverse environmental factors.

The application seeks to extend the terminal hour for the sale of alcohol to midnight and to extend the closing time to 00:30, seven days a week. The application also seeks to add late night refreshment to the same terminal hour as alcohol so the premises can serve hot food and drink until this time.

In addition, the applicant is seeking non-standard timings for late night refreshment, live and recorded music to allow these activities to be carried out on New Year's Eve until 01:00 hours. - 1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
    - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - ii. drink as much alcohol as possible (whether within a time limit or otherwise)
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
  - (f) The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (3) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (4) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy
- (5) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph date of birth and either:
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.

The responsible person shall ensure that:

- (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available in the following measures -
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
  - (iii) still wine in a glass: 125ml; and
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises, and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(2) For the purpose of the condition set out in paragraph 1:

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979  
 (b) "permitted price" is the price found by applying the formula:

$$P = D + (D \times V)$$

where -

- (i) P is the permitted price.  
 (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged in relation to the alcohol as if the duty were charged on the date for the sale or supply of the alcohol and  
 (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol.

(c) "relevant person" means, in relation to the premises in respect of which there is in force a premises licence -

- (i) the holder of the premises licence.  
 (ii) the designated premises supervisor.  
 (iii) the personal licence holder who makes or authorises a supply of alcohol under such a

licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a charge to the rate of duty or value added tax.

5) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Any individual employed to carry out a security activity must be licensed by the Security Industry Authority (SIA).

Admission of children is restricted in accordance with the recommendation by the British Board of Film Classification. If the film has not been classified the restriction of children must be approved by the Licensing Authority. (Children means any person under 18 years).

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

- a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10 a.m. to 11 p.m.
- b) On Sundays, other than Christmas Day or New Year's Eve, 12 noon to 10.30 p.m.
- c) On Good Friday, 12 noon to 10.30 p.m.
- d) On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.
- e) On New Year's Eve, except on a Sunday, 10 a.m. to 11 p.m.
- f) On New Year's Eve on a Sunday, 12 noon to 10.30 p.m.
- g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31 December).

The above restrictions do not prohibit:

- a) during the first twenty minutes after the above hours of consumption of the alcohol on the premises;
- b) during the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- c) during the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- d) consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- e) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- f) the sale of alcohol to a trader or club for the purposes of the trade or the club;
- g) the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.
- h) the taking of alcohol from the premises by a person residing there;
- i) the supply of alcohol for the consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied;
- or
- j) the supply of alcohol for consumption on the premises to persons employed there for the purpose of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

I live opposite the Carpenters Arms. There are already significant parking problems at the location with vehicles causing an obstruction not only of the road but also the pavement. Cars are often left overnight particularly at the weekends.

The noise at closing time is considerable again particularly at the weekends while people leave the premises often quite drunk. The road is narrow and even talking in a normal tone outside can be heard clearly from the front bedroom. Unfortunately voices are often raised when the customers are inebriated and stand outside the front of the premises smoking and waiting for cabs. There have been a number of altercations outside the front of the pub too. It is usually not quiet until after midnight. The sound reverberates throughout my house.

Extending the hours inevitably means this noise will continue until the early hours. There are two other pubs in this road and extending opening hours in this one will no doubt attract those leaving the other establishments as they seek out somewhere else for a final drink.

I have no objection to extended hours for special events but to extend Mon - Sun will no doubt cause anti-social behaviour to continue into the small hours. We often find detritus tossed into our garden or in the gateway to the communal car park. This takes the form of cigarette butts, litter and more recently paper masks discarded by those waiting outside the pub, returning to their vehicles or walking home.

The Carpenters Arms is located in a heavily built up residential area with narrow streets and any noise impacts on a large number of residential premises.

I am quite often woken up at closing time as people leave the pub or in the summer when the noise from the pub garden is increased. My bedroom is at the back of my premises, I would not be able to occupy the front bedroom or the one on the second floor as the noise would be intolerable.

I do hope you take into consideration the location of this pub and the inevitable environmental impact extending opening hours will have on its neighbours.

I strongly object to any variation of the licence which would extend opening hours.

I am writing to make comment to the current license application by the Carpenters Arms under the reason of prevention of public nuisance.

I live at 59, Lower Village Road, Sunninghill and my house backs directly onto the rear of the Carpenters Arms pub.

As Lower Village Road runs lower than Upper Village Road my upstairs/bedroom windows are at the same level as the pub and it's gardens.

My windows are approximately 4 metres from the fencing of the pub garden.

I have attached several photos to show the close proximity.

We have always had some noise from the pub which is to be expected, but since COVID and the pub erecting a large stretch tent across the rear of their property this has increased considerably. You can see the stretch tent in the attached photos.

There was always an increase in outside noise due to summer and people using the garden more, but now with the tent people are out in the garden in all weather and until late in the evening.

I am really concerned by the application they have made as if this is approved for later opening we will be unable to get to sleep until the early hours of the next day.

As you will know, the more alcohol is consumed, the louder people's voices become and we have already been subject to loud conversations, shouting, singing, loud laughing and swearing later in the evening from the garden, making it impossible to relax and get to sleep. My son has, on occasion, slept downstairs on the sofa to get away from the noise.

The staff members never appear to notice the noise levels in their garden and do nothing to quieten down any loud situations.

I have previously had to complain to the pub as we experienced a few evenings where once the pub was closed, the staff members who live above the pub, came back out into the garden and were creating enough noise to stop us sleeping, this has on occasion, gone on until 3am.

The manager did deal with this but this has made us very aware of the noise that we will be faced with if they are able to stay open longer.

I also had to complain recently when they were able to re-open after closure due to COVID measures, as on the first day open they started playing music outside on their decking area. This was heard throughout my house and was very disruptive.

I feel this application has no regard for the local residents and they should appreciate the close proximity the pub has with people's homes.

The pub is in a residential road, surrounded by residential properties, some of which sit very close to the pub and I feel the impact this would have on members of the public, some with young families, living in the area concerned is unacceptable.

They already open until 11pm and some nights it can be 11.30/45 by the time the garden area is cleared of people from both the pub and restaurant areas, especially at the weekend.

Surely this is late enough for neighbours to put up with?

They also screen the main sporting events in the bar area and the windows and doors are always open with people spilling out onto their decking area, the noise of shouting, swearing and cheering we have to experience on these occasions is very loud and disruptive.

People leaving the pub so much later in the evening will also cause noise and disruption in the surrounding streets as they make their way home.

I accept the pub will create some noise and I'm not a killjoy, but the level of noise created in their garden area is getting so much worse and if they are able to stay open and serve alcohol later and be able to play live and recorded music this will make it unbearable and result in unreasonable disturbance to neighbours.

Does the pub have adequate glazing or sound barriers or a noise management plan?

Could there be earlier timings to vacate the outside areas prior to the closing time?

Can the staff deal with and respect the peace and quiet of local residents while customers are in the garden in the evening?

If showing sport can windows and doors be kept closed?

I have also been made aware of the other pub in the same street, the Dog and Partridge, has previously requested a similar change of license as this one, this was rejected due to the noise and disturbance it would cause the neighbours, I hope this application is dealt with in the same way.

Due to the above mentioned points I request that this application is refused.

If you wish to visit my property and see the proximity you are more than welcome.

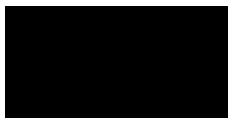

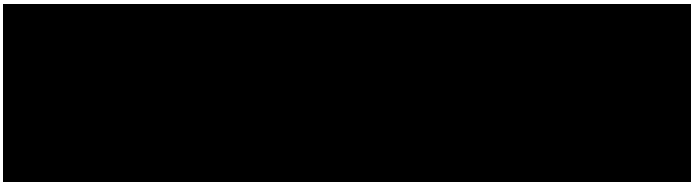

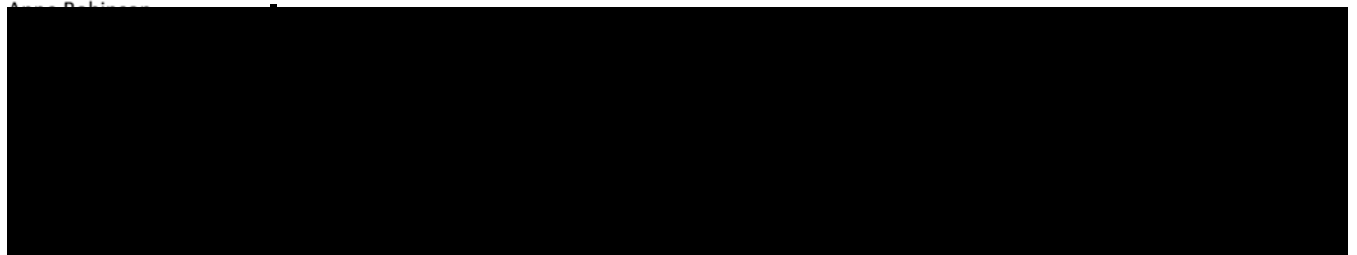

I write to comment on the proposed variations of the license of the Carpenter's Arms. I consider the terms of the variation to be inappropriate for the following reasons:

1. The Carpenter's Arms is located on a street with a considerable number of residential homes very close to the pub/restaurant. Any noise associated with the Carpenter's Arms late at night would seriously disturb a considerable number of residents.
2. The potential for noise comes from two sources. A large number of people leaving the premises late at night after consuming alcohol increases the potential for noise as they take their leave of their friends and guests. The great majority of customers drive to the pub. There is therefore potential for the noise caused by many vehicles leaving at almost the same time.
3. The application is for late night opening 7 days a week, which would therefore disturb the rest of residents who would work the next day every working day of the week, 52 weeks of the year.
3. If approved, this extension of licensing hours would set a precedent for potential applications by the two other pubs in Upper Village Road: the Dog & Partridge and the Duke. Several years ago residents who live close to the Duke (then the Duke's Head) suffered considerable noise nuisance from the pub during normal hours. Late opening would make a repeat of such a situation more serious. If three pubs were to close late at night in one street 7 days a week all year, the number of residents affected by the associated noise would be very considerable.
4. Upper Village Road is a residential road, not a nightlife centre. Late night opening could cause a substantial public nuisance.

I live directly opposite the Carpenters Arms Public House and I have the following objections to the variation in licence.

1. This is a residential Street and the venue is surrounded wholly by residential properties. There is already issues with parking in the vicinity of the pub, as the car park cannot accommodate the large vehicles that attend the venue. Vehicles park on the pavement causing pedestrians to walk in the road often into oncoming traffic. At most the car park has spaces for 15 cars. The extension will mean people will travel from other local establishments to the venue late at night causing further chaotic scenes and noise pollution.
2. There is already an issue with taxis turning up at the venue at closing time to take noisy and often drunk patrons home. The vehicles often leave engines running and sound their horns. Patrons often congregate outside the venue in groups making a lot of noise whilst waiting for their taxis. It is unreasonable to expect this disturbance into the early hours of the morning.
3. I have a teenager child who sleeps in the front bedroom who is studying for exams, who already has his sleep disturbed by patrons leaving the venue.
4. On several occasions I have challenged patrons who have walked across the road into the BT exchange car park to smoke cannabis. This is totally antisocial and also illegal. They also have no regard to the noise they make which echoes around the car park.
5. As a former police officer I have had to go outside late at night to quell disturbances outside the venue. This required me to disclose to individuals that I was a police officer, which I was reluctant to do due to the implications for my families safety. Any extension of the license would mean more disruptive alcoholic fuelled behaviour outside the venue. As I am no longer a serving officer, this would now require local police intervention.
6. We have 2 further licensed premises in the vicinity of this venue, who close earlier. Patrons from these venues would seek out the Carpenters to continue drinking. The transfer from venue to venue would cause further noise pollution.

I have other matters that I would like to discuss with you that are not suitable for this email.

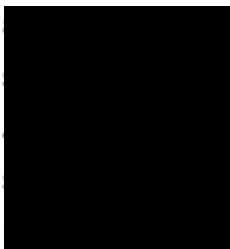

We would like to object to the change in licence for The Carpenter Arms on the following grounds:

- The prevention of crime and disorder
  - Public safety
  - The protection of children from harm; and
  - The prevention of public nuisance
1. The Carpenters Arms is a small village pub in an open location, extremely close to residential properties.
  2. Extending business hours is not compatible with this location.
  3. Where alcohol is involved, the possibility for inappropriate behaviour is increased.
  4. As there are residential properties and gardens in the immediate vicinity, a carpark with the inevitable opportunities present to persons that are, possibly not in total control of all their faculties.
  5. As there is limited parking on Upper Village Road, this extended licencing will put pressure on local parking and will result in residents unable to park near their properties, or as is the case frequently at our property, people parking and blocking drives. This is wholly unacceptable and poses a real risk of not being able to get road access in an emergency.
  6. Assuming that the application for these premises has included for adequate provision for parking.
  7. Parking one's vehicle on the street at night has its inevitable risks attached.
  8. If that risk of possible damage is increased by introducing an increase in the number of people, late at night and having been in an environment where alcohol is involved, then this is not an acceptable risk to have placed on existing residents.
  9. Generally, any activity involving increased numbers of people, vehicles, music and alcohol after 11:30 at night is not appropriate for a residential area and it increases the possibility of becoming a public nuisance and significantly raises the risk of criminal and disorderly

behaviour in local streets at a time when most respectable local residents are in bed and trying to sleep.

10. A number of young families live in Upper Village Road and Lower Village Road, and when people drink alcohol, people's voices tend to raise in volume. Also, the pub may want to close at 00:30 but people often linger and talk loudly for 30 mins past closing time whilst waiting for taxis (often the case outside out house which is opposite another local Pub)
11. We also strongly believe that there should be no use of amplification equipment. The pub will inevitably have to open windows and there would be considerable noise pollution late at night.

In summary we consider that the extension of hours as requested by the applicant would be detrimental to the promotion of the licensing objective 'the prevention of public nuisance.' We feel that extending the opening hours to 00.30 Monday to Sunday, as requested by the applicant, would have a direct impact on members of the public living, working, or engaged in normal activities in the area concerned. The extension of hours would cause unnecessary noise and disturbance in a residential area.

My wife and I live at 61A Lower Village Road, Sunninghill, SL5 7AF. Our house is one of a number of houses on Lower Village Road where the rear of the property is only 50 metres (and in some cases much less) from the rear of the Carpenters Arms. The outside space for the Carpenters Arms is at the rear of the pub and is therefore very close to several properties on Lower Village Road.

Our objection to the proposal is that it contravenes the RBWM Licensing Objective 'The prevention of public nuisance'. In the past, obviously before COVID, there has been significant noise emanating from the pub well after 23:00. We suspect that this is largely generated by staff employed by the pub and who are living on the premises. Our concern is that extending the opening hours to midnight every day will simply mean that the same 'after hours' noise will happen well into the following day.

For the record we do not object to addition of non-standard timings for live music, recorded music and late night refreshment on New Year's Eve until 01:00 hours.

We would like to object to the change in licence for The Carpenters Arms on the grounds of "The Prevention of public nuisance".

We believe that the extension of the opening hours to 24.30 Monday - Sunday would cause a public nuisance and have a direct impact on members of the public living, working or engaging in normal activities in the area concerned. The extension of the hours would cause unnecessary noise and disturbance in a residential area.

- This is not a pub in a town, but in a very quiet village location and is surrounded on all sides by residential properties, there are also two other pubs in the same road.
- Whatever time the pub closes people will linger in the road outside chatting and waiting for taxis for at least 30 mins after closing time, so a closing time of 24.30 would seriously affect neighbours ability to sleep up to 1.00am which is not acceptable when they have to work the next day.
- The extension of the hours would lead to an inevitable increase in late night traffic (cars and pedestrians) that would be created in a very quiet residential roads surrounding the pub.
- Similar applications were made in 2005 to extend the opening hours for the Dog and Partridge in Upper Village Road.
  - The hours applied for then were rejected on the grounds of the unnecessary noise and disturbance that would it would cause in a residential area - see the applications and panel decisions below.
- The Dog and Partridge decision in 2005 was that it must close by 23.30 Sunday - Thursday and 24.00 on Friday and Saturday. And also all patrons must vacate the garden area by 22.30 Monday - Thursday and 23.00 Friday and Saturday. A decision which still stands today.
- So it would reasonable that the Carpenters Arms should have similar opening hours as they are in the same location and both surrounded by residential properties.
- Should the Carpenters Arms be granted a later closing time than the neighbouring pub it is likely that patrons (already the worse for wear) may move from one pub to the other causing even more disturbance to neighbouring properties.
- We also think that the Carpenters Arms should have the same time to vacate the garden area as the Dog and Partridge. We regularly hear noise from the garden of

---

the Carpenters after 23.00 from quite a distance away, so it must cause the neighbouring properties a great deal of disturbance and affect their ability to sleep, especially those with children.

- We would also suggest that similar limitations to those at the Dog and partridge being implemented in regard to live or recorded music events again to reduce the disturbance to neighbouring properties.
- We would also ask that consideration is made to deal with the parking situation outside The Carpenters Arms, cars are parked in front of the pub and others parked on the road opposite. Upper Village Road is a very narrow road and the cars parked outside the pub stick out into the road, there are many times when it is very difficult to drive down the road in a normal car, emergency vehicles would not be able to get through.

We live on Upper Village Road in Sunninghill – in close proximity to the Carpenters Arms. While it is a great asset to the village as a venue, there is no question that there is already considerable noise and disruption caused by the customers. We can hear it at night when people are in the pub garden – a general hubbub of noise coupled with shouting and booming laughter. It can be extremely loud at times. Coupled with that, the customers are noisy when they leave the premises – shouting, revving cars etc. It's an aspirational venue and the clientele like to show off – they are competing to be heard all the time.

On a daily basis we find it very difficult to drive past the pub because the customers show no consideration when they park – leaving the backs of their cars sticking out onto the road, parking up on the pavements so that they become unpassable and leaving very little room on the road to get through. At times it would be impossible for a fire engine to get through for example.

While we have a great deal of respect for the owners of the pub, we have very real concerns that the application for licence extension will cause considerable disruption to the surrounding neighbours – us included. It is causing us untold distress to think that the noise might continue on later into the night and the prospect of music on top of that is unthinkable. The longer the bar is open, the drunker people will be and the more noise that will happen as a result – both while drinking and on leaving the premises. It's a peaceful village and the houses are closely positioned. This is simply not the place for late night licences.

I understand that the above pub has applied for an extension to its opening hours as part of its License.

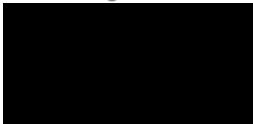
I live at 55 Lower Village Road in Sunninghill and my garden backs up to the pub garden.

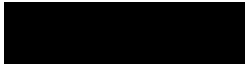
