MEMBERS' GUIDE TO DECLARING INTERESTS AT MEETINGS

Disclosure at Meetings

If a Member has not disclosed an interest in their Register of Interests, they **must make** the declaration of interest at the beginning of the meeting, or as soon as they are aware that they have a Disclosable Pecuniary Interest (DPI) or Other Registerable Interest. If a Member has already disclosed the interest in their Register of Interests they are still required to disclose this in the meeting if it relates to the matter being discussed.

Any Member with concerns about the nature of their interest should consult the Monitoring Officer in advance of the meeting.

Non-participation in case of Disclosable Pecuniary Interest (DPI)

Where a matter arises at a meeting which directly relates to one of your DPIs (summary below, further details set out in Table 1 of the Members' Code of Conduct) you must disclose the interest, **not participate in any discussion or vote on the matter and must not remain in the room** unless you have been granted a dispensation. If it is a 'sensitive interest' (as agreed in advance by the Monitoring Officer), you do not have to disclose the nature of the interest, just that you have an interest. Dispensation may be granted by the Monitoring Officer in limited circumstances, to enable you to participate and vote on a matter in which you have a DPI.

Where you have a DPI on a matter to be considered or is being considered by you as a Cabinet Member in exercise of your executive function, you must notify the Monitoring Officer of the interest and must not take any steps or further steps in the matter apart from arranging for someone else to deal with it.

DPIs (relating to the Member or their partner) include:

- Any employment, office, trade, profession or vocation carried on for profit or gain.
- Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses
- Any contract under which goods and services are to be provided/works to be executed which has not been fully discharged.
- Any beneficial interest in land within the area of the council.
- Any licence to occupy land in the area of the council for a month or longer.
- Any tenancy where the landlord is the council, and the tenant is a body in which the relevant person has a beneficial interest in the securities of.
- Any beneficial interest in securities of a body where:
 - a) that body has a place of business or land in the area of the council, and
 - b) either (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body <u>or</u> (ii) the total nominal value of the shares of any one class belonging to the relevant person exceeds one hundredth of the total issued share capital of that class.

Any Member who is unsure if their interest falls within any of the above legal definitions should seek advice from the Monitoring Officer in advance of the meeting.

Disclosure of Other Registerable Interests

Where a matter arises at a meeting which *directly relates* to one of your Other Registerable Interests (summary below and as set out in Table 2 of the Members Code of Conduct), you must disclose the interest. You may speak on the matter only if members of the public are also allowed to speak at the meeting but otherwise must not take part in any discussion or vote on the matter and must not remain in the room unless you have been granted a dispensation. If it is a 'sensitive interest' (as agreed in advance by the Monitoring Officer), you do not have to disclose the nature of the interest.

Other Registerable Interests (relating to the Member or their partner):

You have an interest in any business of your authority where it relates to or is likely to affect:

- a) any body of which you are in general control or management and to which you are nominated or appointed by your authority
- b) any body
 - (i) exercising functions of a public nature
 - (ii) directed to charitable purposes or

one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)

Disclosure of Non- Registerable Interests

Where a matter arises at a meeting which *directly relates* to your financial interest or well-being (and is not a DPI) or a financial interest or well-being of a relative or close associate, you must disclose the interest. You may speak on the matter only if members of the public are also allowed to speak at the meeting but otherwise must not take part in any discussion or vote on the matter and must not remain in the room unless you have been granted a dispensation. If it is a 'sensitive interest' (agreed in advance by the Monitoring Officer) you do not have to disclose the nature of the interest.

Where a matter arises at a meeting which affects -

- a. your own financial interest or well-being;
- b. a financial interest or well-being of a friend, relative, close associate; or
- c. a body included in those you need to disclose under DPIs as set out in Table 1 of the Members' code of Conduct

you must disclose the interest. In order to determine whether you can remain in the meeting after disclosing your interest the following test should be applied.

Where a matter *affects* your financial interest or well-being:

- a. to a greater extent than it affects the financial interests of the majority of inhabitants of the ward affected by the decision and;
- b. a reasonable member of the public knowing all the facts would believe that it would affect your view of the wider public interest

You may speak on the matter only if members of the public are also allowed to speak at the meeting but otherwise must not take part in any discussion or vote on the matter and must not remain in the room unless you have been granted a dispensation. If it is a 'sensitive interest' (agreed in advance by the Monitoring Officer, you do not have to disclose the nature of the interest.

Other declarations

Members may wish to declare at the beginning of the meeting any other information they feel should be in the public domain in relation to an item on the agenda; such Member statements will be included in the minutes for transparency.

B) Relevant Representations Received

The sections of the RBWM Licensing Policy relevant to this application are;

6.1 Framework Hours

Having considered the evidence of alcohol related crime, disorder and anti-social behavior, the number of late-night premises and, in particular, the social, practical and regulatory impacts on the morning after the night before, the Licensing Authority has adopted a Framework Hours Policy. This Framework Hours Policy will apply to new and variation applications.

The Framework Hours are:

(As can be seen, the licensed hours applied for in this application do not fall within RBWM framework hours for a premises.)

Framework Hours are intended to guide applicants on the Licensing Authority's expectations when preparing their Operating Schedule. However, if no relevant representations had been received, the application would have been granted by the Licensing Authority under delegated powers.

6.4 Wider Community Interest

The Licensing Authority considers that its licensing functions are exercised in the public interest, furthermore that the Licensing Authority is under a duty to take any steps with a view to the promotion of the licensing objectives in the interests of the wider community and not just those of the individual licence holder.

The Licensing Authority will have particular regard to those applications in close proximity to residential premises and the likely effect on the promotion of the licensing objectives in such circumstances. Subject to any relevant representations, the Licensing Authority will have particular regard to*:

- The nature of the activities
- The character of the surrounding area

- Measures for limitation of noise emissions from the premises. These may include as appropriate; noise limitation devices, sound insulation, whether windows are to be opened, the insulation of acoustic lobbies and double glazing
- Measures to deal with queuing, where necessary
- Use of outdoor areas
- Measures to deal with dispersal of customers from the premises as necessary, including the employment of door supervisors, use of dedicated Hackney Carriage / Private Hire firms, notices in the premises requesting customers to respect neighbours
- Winding down periods, particularly in public houses and nightclubs etc. (*Note not all of these will be relevant to this particular application)

7. Promoting the Prevention of Crime and Disorder

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues* in relation to the crime and disorder objective:

- Measure to prevent bottles being carried from premises
- Use of drinks' promotions
- Measure to prevent binge drinking
- Participation in the Pub Watch Scheme
- Use of door supervisors
- Training staff in crime prevention measures
- Search procedures
- Use of close circuit television
- Lighting
- Where premises are new, designing out crime
- Quality of surveillance of premises

9. Promoting the Prevention of Public Nuisance

Where relevant representations are made, the Licensing Authority will have particular regard to the following issues* in relation to the public nuisance objective:

- The disposal of waste, particularly glass
- The use and maintenance of plant, including air extraction and ventilation systems
- Litter in the vicinity of the premises
- Noise from deliveries / collections to and from the premises
- Measures to control behaviour and gueues
- Whether door supervisors are able to stay at the entrance to encourage quiet departure
- The provision of Hackney Carriage / Private Hire services at the premises
- Signs on doors and on tables encouraging consideration to the neighbours

10. Promoting the Prevention of Children from Harm

RBWM recognizes that the protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms directly associated with alcohol consumption but also wider harms such as exposure to strong language and the need to protect children from sexual exploitation.

All applicants need to demonstrate how children and young people will be safeguarded if attending the licenced premises, or how it will be ensured that they do not gain access to the premises if not appropriate. Where relevant representations are made in relation to the protection of children from harm the Licensing Authority may impose conditions restricting the access of children or excluding them altogether from licensed premises.

Proof of Age Cards

Where necessary and appropriate, a requirement for the production of proof of age cards before any sale of alcohol is made could be attached to any premises licence or club premises certificate for the protection of children from harm.

The sections of the Guidance relevant to this application are;

Licensing objectives and aims

- 1.2 The legislation provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are undertaken.
- 1.3 The licensing objectives are:
 - The prevention of crime and disorder;
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm.
- 1.4 Each objective is of equal importance. There are no other statutory licensing objectives, so that the promotion of the four objectives is a paramount consideration at all times.

- 1.5 However, the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work. They include:
- protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises;
- providing a regulatory framework for alcohol which reflects the needs of local communities and empowers local authorities to make and enforce decisions about the most appropriate licensing strategies for their local area; and
- encouraging greater community involvement in licensing decisions and giving local residents the opportunity to have their say regarding licensing decisions that may affect them.

Crime and disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

Public nuisance

2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.

- 2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
- 2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.
- 2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.

Protection of Children from harm

- 2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly to alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 2.23 The Government believes that it is completely unacceptable to sell alcohol to children. Conditions relating to the access of children where alcohol is sold and which are appropriate to protect them from harm should be carefully considered.
- 2.26 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.

2.27 Conditions, where they are appropriate, should reflect the licensable activities taking place on the premises. In addition to the mandatory condition regarding age verification, other conditions relating to the protection of children from harm can include:

- Restrictions on the hours when children may be present;
- Restrictions or exclusions on the presence of children under certain ages when particular specified activities are taking place;
- Restrictions on the parts of the premises to which children may have access;
- Requirements for an accompanying adult (including for example, a combination of requirements which provide that children under a particular age must be accompanied by an adult); and
- Full exclusion of people under 18 from the premises when any licensable activities are taking place.

Hearings

9.38 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the licensing authority must give appropriate weight to:

- the steps that are appropriate to promote the licensing objectives;
- the representations (including supporting information) presented by all the parties;
- this Guidance:
- its own statement of licensing policy.

E) Conclusion / Summary

The Licensing Panel Sub Committee is obliged to determine this application with a view to promoting the four licensing objectives which are:

- The prevention of crime and disorder;
- Public safety;
- The prevention of public nuisance
- The protection of children from harm.

In making its decision, the Sub Committee is also obliged to have regard to national guidance and the Council's own Licensing Policy. Of course, the Committee must have regard to all of the representations made and the evidence that it hears.

The Sub-Committee must, having regard to the application and to the relevant representations, take such step or steps as it considers appropriate for the promotion of the licensing objectives. The steps are:

- (a) Reject the application;
- (b) Refuse to specify a person in the licence as the premise's supervisor; (*Note not all of these will be relevant to this particular application)
- (c) Grant the application but modify the activities and/or the hours and/or the conditions of the licence;
- (d) Grant the application.

Where conditions are attached to a licence then reasons for those conditions must be given.

Reason Should;

- Refer to every relevant representation
- Start with the policy
- State the extent to which it has taken account of guidance and policy
- When deciding in accordance with policy, explain why it has not considered a departure justified
- When deciding contrary to policy, explain the basis and reason for the departure
- When refusing in whole or in part, or attaching further conditions state, both that it considered it appropriate to do so in order to promote one or more specified licencing objectives and why this was so.
- The committee may use a legal adviser in helping it to draught its reasons, but the reasons must be the committee's.

The Sub-Committee are reminded that any party to the hearing may appeal against the decision of the Sub-Committee to the Magistrates' Court within 21 days of the notification of the determination.

The Sub-Committee are asked to determine the application.

Financial implications: None directly but Members should be aware that any decision of the Sub-Committee may be appealed against in the Magistrates' Court and such an appeal may involve additional costs and possible costs against the Council.

Environmental/Sustainability Implications: Any authorisation under the Licensing Act 2003 may give rise to environmental implications both positive and negative depending upon the application and any measures proposed to take control adverse environmental factors.

Statement of Objection:

The present Application is for a New Premises Licence (PL). There are two existing, current, PL's (No. PL000329, issued 25/12/2005 & PL107021, issued 09/02/2016. They cover the same Premises and are in the name of the same Premises Licence Holder (PLH), Mr Mehmet Kutlubay. They are included here as Appendix 1. & Appendix 2. The material changes in the present Application are:

- 1. The terminal hour for Late Night Refreshment and operating hours to be extended from 01:40 to 03:40 on Wednesdays.
- 2. The Sale of Alcohol (PL107021) to be removed.
- 3. The Applicant has offered to surrender PL000329, if this is granted.

A similar Application was submitted in 2016 and attracted Objections from both Thames Valley Police (TVP) and the Royal Borough. That Application was heard at the Licensing Sub-Committee on 18th January 2016 when PL107021 was granted, with additional Conditions.

It is not clear why, on this occasion, the requested amendments are being applied for by means of a New PL, rather than a Full Variation, as the latter, if granted, would offer the same permissions.

SIA Guard did not seem to understand the situation, the purpose of a Premises Licence and its Conditions. The Licence Holder seemed to believe that they only needed two security guards on duty from 01:00. The premises was very quiet. 01:22 – Officers returned to Istanbul Kebab House. They had two SIA security guards on duty. We spoke to CELAL who explained we had previously spoke to his cousin whose name is MEHMET.

The investigation around the findings of the Premises Inspection of 11th September 2021, is still ongoing.

Amongst the many Incidents recorded by TVP, we would draw the Panel's particular attention to that recorded by them on Friday 26th April 2019 at 01:00 hours. It relates to a previous breach of Condition 11, when only one door staff was present at the time of inspection. The same breach that forms the basis of the Royal Borough's Objection on this occasion.

Reasons that justify the RBWM Objection:

Condition 11. of PL107021 states; "Two (2) Security Industry Authority (SIA) licensed door supervisors, wearing high visibility jackets, to be present on or in the immediate vicinity of the Premises on Friday and Saturday from midnight until closing."

Reference is also made here to TVP report of 01/02/2020, as it includes mention of a further breach of Condition 11. At an interview on 7th February 2021, Mr Kutlubay stated that the doorman had arrived 5 minutes late and wouldn't wear his high viz jacket.

1. The Prevention of Crime and Disorder:

Breaches of Premises Licence Condition 11. is an offence under the Licensing

Act, 2003 and compromises the ability of Premises staff to prevent crime and disorder, at or near the Premises.

2. Public Safety:

Absence of prescribed S.I.A. security staff increases risks to the public, at or near the Premises.

3. The Prevention of Public Nuisance:

Absence of prescribed S.I.A. security staff jeopardises the ability of Premises staff to prevent public nuisance, emanating from the Premises.

The PLH has, repeatedly, been found unable to comply with the terms of his PL; in particular, Condition 11. Furthermore, his management in terms of delegating responsibilities during his absence from the Premises, has been found to be inadequate.

Recommendation of RBWM Licensing Department:

RBWM recommends that

- 1) the Application to extend the terminal hour from 01:40 to 03:40 on Wednesdays should be refused and
- 2) the terminal hours on Thursday to Sunday should be reduced to 01:40.

CH - OK perfect can you confirm that the discs were unsealed in your presence, and we opened these? yeah

SC - so the reason question interview today to further yes regarding a possible breach which premises licence Istanbul kebabs on Saturday the 11th of September 2021 this will be contrary to section 136(1a) of the licencing act 2003 OK do you don't you understand? Yes

just to start with just a few general questions alright, Mr KUTLUBAY, you are the licence holder and DPS of Istanbul kebabs Victoria Road Windsor is this correct? Yes

what if I can ask what is your day-to-day involvement in the business? what do you generally do?

MK - owner of the business. family run business last 20 years.

SC - are you there most days when it's open? here mainly from Thursday to Sunday I'm there and from when you open to when you close is that right? opening closing time yes. yeah so, you're generally run the business. because we've got another two restaurants, the mezze grill.

Istanbul kebab has premises licence issued to it, which is licence number PL 107021, What that sound correct to you? Yes

And roughly how long have the premises had a premises licence? can you remember? yeah on the premises 2006, 2007 something like that. So, it is fair to say that it's been a long time you've had a premises licence? yes

So, for the benefit of the tape, I am just going to show Mr KUTLUBAY a copy off the premises Licence. This is exhibit number CH/27-09-21/01 Mr KUTLUBAY can you confirm that is your premises licence as far as your aware? Yes

I am just going to bring your attention condition 11 on the licence, I've highlighted it for your benefit okay. could you just have look at that and just confirm that condition is on your licence? That's Correct.

So, on the 11th of September at midnight 16 hours so that's 0016 hours two licencing colleagues Lauren Deane and Giuseppe attended the premises or a routine inspection at this time only one SIA doorman was present at the venue can you explain why that was?

MK - Yeah actually my shop is being closed two years now. When Attic open because the old before we supply for two SIA door staff couldn't find them could they work with me seven

years the same two person, my shop is closed two years, I was working summer and then I meet new manager from Attic for door staff, he said I explained how much should a copy of my licence I look at midnight and it is Friday Saturday and it from midnight until 4.30 in the morning. 2 SIA door staff the same door stop from the Atik as well the same company

Friday, I called him about 9:00 o'clock Friday night and I said them can you confirm that attending 12:00 o'clock he said I couldn't find it because this short staff and then many times I have to contact somebody else. The one of them arrived 5 to 12. The other gentleman was working with me was number 5 St Leonards Road. and he said to me you will be able to come at 00:45 and then we did that time and what shop open business was operating fine but this time is because it was close two years, and I couldn't find the properly like used to be regular door staff. now everything is done even this Friday and one of them attend twelve o'clock one of them attended 00:15 I closed the shop until the 2-door staff come, because of issue happening/ traffic. It's no excuse for it. Because it's the issue only happens Sarah.

I've been there more than 13 years, the doors staff, 2 years ago was closed and then the Atik the manager I'm setting is happy to work together because it's 2 companies I'm for Atik and my shop 2 SIA door staff from St company is more benefit from the same company you know. they come back up each other that's why I was confident but Friday night 9:00 o'clock he confirmed with me said I couldn't find this because the short staff then I have to look up a personal Find different door staff

SC- so that was why on the 11 September? how long did it take for the second doorman to arrive?

MK - Arriving I'm not sure 00:35 or 00:45

SC – 00:35 or 00:45? And what did you do in the meantime? Between the officers attending and the doorman arriving? Did you continue to trade? I wasn't there at the time

MK - It was a new door employer, I called them to not serve anybody they weren't rang me on the point that said there's only one door staff hear and the second one I said this that they said no I said don't serve them, but they leave the door open they didn't close the door.

SC – They didn't close the door? Yeah

MK – But they didn't serve the customer.

SC – But no customers were served?

MK - No as far as I am aware they didn't serve any food to customers until second door staff arrived.

SC- Mr KUTLUBAY what I am going to do know for the benefit of the tape. I'm going to read from Gen 40 so this is a report from Thames Valley Police from the 27th of April 2019 you get number Ch/ 27-09-21/03 this is from a report from officers who attended Istanbul kebabs at after midnight as at 00:55 hours on the 27th of April 2019 the officers were made aware that Istanbul kebabs licence states that after midnight the premises required two door staff from midnight 00:55 there was only one doorman present at the premises a police officer PC PS baffle enter the premises and stated that it had been observed that there was only one member of door staff present the shop closed internal until door staff had been located do you remember that incident? No

SC- It maybe that you were not at the premises at the time.

For the benefit of the tape going to read from a meeting that yourself Debie Pearmain Police licencing officer and Steve Smith the RBWM Licensing Officer do you remember that? Yes

so exhibit number Ch/27-09-21/04, this is from a meeting at 11:00 AM on the 24th of May 2019 at Windsor police station and the meeting was arranged to discuss the gen 40 from the 27 April which relates to issue with staff members downloading CCTV and the lack of door staff okay? at that point you were informed about the report of anyone doorman until 00:55 and at that point Steve Smith the RBWM licencing officer cautioned you for an offence okay do you remember? That would have been 2019.

SC - what I'm trying to suggest here is Mr KUTLUBAY is this happened previously and at that point when it happened you were made aware that only have a one doorman on is an offence in the licencing act. I appreciate the issues and also the premises had been closed for two years I do understand that I last appreciate your explanation, but it's been difficult to get doorman to attend.

what I have to make you aware though is that even with issues it is still an offence under the licencing act 2003 to failed comply with your licence, Do you understand what I am saying? I understand

We've also previously cautioned you for offences previously OK the same condition not being adhered to, OK? do you understand? I understand

You're fully aware of conditions, aren't you? yes, I am

SC - And you are fully aware of that condition that two doormen after midnight

MK- On Friday and Saturday, Yes

SC - is that you cannot maintain and if you cannot comply with those conditions, you have you will know it is a business decision but the only thing that you can do at that point is if you do not have any both doors stuff at midnight as you have been doing is to close the shop.

MK - this weekend gone one of my door staff arrive like 5/10 minutes before 00:00 and one of them didn't arrive until 00:15 straight away I close the door not operating, I told my staff sometimes physically I'm not there coming in restaurant because now is regular door staff regular staff inside. now because people didn't, they didn't realise but I'm sorry I apologise for that, and it wouldn't happen again 100% make sure stop even one minute after midnight they could not to door staff closed the door.

Because even sometimes the inside then not serving but they leave the door open an even the police or the licensing officer when they see past and not see the door staff. They think we are serving the customers because door is open but not serving customers, I've told them closed door turn the sign that says close.

SC – Further discussions around keeping the door closed or not during hot summer months or some sort of barrier to deter customers from trying to enter when closed until door staff arrive.

- 12 Retail Radio to be used by staff members.
- 13 The premises licence holder (hereinafter The Licensee) shall ensure that at all times when the premises are open for any licensable activity, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder.
- Except for the delivery service, no alcoholic drinks shall be sold or supplied for consumption off the premises.
- The licensee shall ensure that all material staff will undertake training in their responsibilities in relation to the sale of 15. alcohol, particularly with regard to drunkenness and underage persons. New delivery staff will be trained before commencing their duties. All established and material staff would be subject to periodic refresher training (not normally less than six monthly intervals). Records will be kept of all training, which will include the English required for the delivery service.
- 16. Orders for delivery service are only to be taken over the telephone.
- 17 Alcohol can only be delivered with a food order.
- 18. The sale and supply of alcohol shall be ancillary to food
- 19. The sale and supply of alcohol shall be made to a person occupying a dwelling house.
- 20. A sign is to be displayed on the premises that no alcohol is sold on the premises.
- No alcohol is to be displayed on the premises 21.
- Only beer and lager up to 6.5% and only non-fortified wines to be sold.

Public Safety

- Appropriate fire safety procedures are in place and shall be maintained including fire extinguishers (foam, H20 and C02], fire blanket, internally illuminated fire exit signs, numerous smoke detectors and emergency lighting.
- All appliances are inspected annually.
- All emergency exits shall be kept free from obstruction at all times.

Prevention of Public Nuisance

- All customers are asked to leave quietly.
- Clear legible notices will be displayed to remind customers to respect neighbours and leave quietly.
- 28. No queuing to be allowed on the public highway.
- The applicant to provide a litter bin and to ensure all waste and litter is collected from the area outside the premises on 29 Victoria Street.
- 30. Ventilation and extract systems are designed and maintained so as to prevent noxious smells causing a nuisance to nearby properties.
- 31. Trade waste agreement to be maintained at all times and all refuse generated by the premises will be dealt with appropriately and efficiently.

Protection of Children from Harm

- A suitably worded public notice of sufficient size and clarity must be written on all menus of the business where alcohol is to be offered for sale, advising customers that they may be asked to produce evidence of their age and card details.
- 33 A refusal book will be kept at the premises.
- 34. The delivery driver will check details of the person ordering and receiving to ensure that they are both over 18 and the owner of the credit card.

Objection made to Premises Licence - Istanbul Kebab House, 67 Victoria Street, Windsor, SL4 1EH

We act on behalf of CC Stim UK Tradeco 3 Limited, the Premises Licence Holder for ATIK, 19 William Street, Windsor, SL4 1BB, and are objecting to the application for a new Premises Licence by Mehmet Kutlubay for late night refreshment at Istanbul Kebab House, 67 Victoria Street, Windsor, SL4 1EH for the following hours:

- Monday and Tuesday to 01:40 the following day
- Wednesday, Thursday and Sunday to 03:40 the following day
- Friday and Saturday to 04:30 the following day

and to the extended hours sought for licensable activities (we assume late night refreshment) on notable days.

We understand that these premises already have a Premises Licence permitting the provision of late night refreshment to 01:40 Monday to Wednesday, 03:40 Thursday and Sunday, and 04:00 Friday and Saturday.

The new Premises Licence, if granted, would mean that the hours for late night refreshment would be extended on a Wednesday from 01:40 to 03:40 and on Fridays and Saturdays from 04:00 to 04:30.

Whilst the applicant will argue there is already a Premises Licence in place, since this is a new application, then the entirety of the hours are open for consideration by the Licensing Committee.

Our client's objection is based upon the licensing objectives of crime and disorder and public nuisance.

- Our client's premises, ATIK, which trade on William Street, Windsor, SL4 1BB, is permitted to provide licensable activities until 03:00, 7 days per week, closing at 03:30
- Customers from ATIK and other late night premises in Windsor, go to Instanbul Kebab House at the end of the evening.
- Our client operates a comprehensive dispersal policy, which includes door staff supervising customers whilst they walk up to Victoria Street from ATIK. Door staff are then positioned at particular points on Victoria Street.
- Our client's door staff have, on occasions, had to intervene with incidents which happen both inside and outside Istanbul Kebab House.
- The current licensing condition requiring two SIA licensed door supervisors wearing
 visibility jackets to be present "on or in the immediate vicinity of the premises on
 Friday and Saturday night from midnight until closing" is not being complied with.
 This condition is being breached on a Friday and Saturday by the applicant, and if
 the same condition has been offered for the hours now sought as part of this
 application, then my client does not believe that the condition will be observed either.
- The door staff who work at Istanbul Kebab House are reactive and not proactive in stopping incidents happening in the first place, and they do not come out of the applicant's premises to give any assistance but, instead, remain inside.
- As soon as Istanbul Kebab House closes, their door staff remain inside and do not come outside to assist dispersal and do not remain in the area until the last customers have left, meaning that our client's door staff can still be working in the area after 05:00.

Our client therefore objects to this application in its entirety, since it is clear the applicant does not observe the condition currently, which only requires 2 door staff to be on duty, and our client has little faith it will observe any such condition in the future whilst enjoying the benefit of additional hours, should the Licensing Committee be minded to grant this application.

Objection to Premises Licence Application

Dear Licensing team,

I am writing to register my representations to the application for a premises licence by Istanbul Kebab, 67 Victoria Street, Windsor.

I am a central Windsor resident where I have lived for five years. The evidence within this statement relates to my personal experience as a resident.

The basis for my representation is that granting a licence for these premises will not promote licensing objectives, particularly the prevention of crime and disorder and prevention of public nuisance.

1. Prevention of crime and disorder

Windsor and its residents' lives are disrupted by the anti-social behaviour and crime that can be attributed to the Istanbul Kebab, predominantly on Friday and Saturday nights (into Sunday morning). Patrons of ATIK congregate in the venue after ATIK closes where incidents especially ASB occurs because of the intoxicated state of people, causing further misery for residents. As patrons disperse, they dump their food and litter in the surrounding streets, car park and driveways. I often pick up rubbish at the weekend as it such an eye sore and health hazard.

2. Prevention of public nuisance

I can see no reason why Istanbul Kebab wishes to operate Monday & Tuesday to 1.40am; Wednesday, Thursday & Sunday until 3.40am; Friday & Saturday until 4.30am; especially when it is such close proximity to residential streets. Apart from wish to service ATIK patrons there is no need for a kebab shop to open into the early hours midweek in Windsor. A 4.30am closure at the weekend will only extend the issues associated with patrons leaving ATIK i.e., the ASB and noise emanating from the premises causes disruption for local residents.

3. Conditions

To conclude, granting a licence for Istanbul Kebab would be of no benefit to Windsor and its residents, as it is an ASB and litter generator draining the resources of TVP and the Local Authority environmental teams. It does not service the residents of Windsor and should not have opening hours extended beyond 11pm.
