- 4. The policy has now been redrafted in line with Members wishes and Counsel's advice and Members are now asked to approve the policy for consideration by Full Council.

1. Details of Recommendations

RECOMMENDATION:

That Members endorse the draft policy attached to this report for forwarding to Full Council for final approval.

2. Reason for Recommendation and Options Considered

- 2.1. At previous Licensing Panels, Members authorised the process and timetable for producing a new Licensing Policy for the borough, including the undertaking of a consultation process (as required by Section 5(3) of the Licensing Act 2003) on a first draft of the new policy.
- 2.2. Following the consultation Members, at the July 2015 Panel, authorised an updated version of the policy, but asked for advice to be obtained on the proposed policy as a whole from a senior barrister working in the area of licensing.
- 2.3. Attached as Appendix A is a copy of the proposed policy, which now includes changes made as a result of the advice obtained from a senior barrister.
- 2.4. The changes advised by Counsel were for the most part minor technical matters reflecting recent changes in legislation but Members should be aware of the following changes now incorporated into the redrafted policy.
- 2.5. Counsel advised that the Pool of Conditions, the Licensing and Planning Protocol and the Delegation of Functions should be included as Annexes to the policy, rather than within the body of the policy itself, and this has now been carried out.
- 2.6. Counsel also advised that the procedural note setting out Licensing Sub-Committee Procedures should be treated as a separate stand-alone document and removed from the policy document altogether. This has been done.
- 2.7. Members were keen for Framework Hours to be a cornerstone of the new policy. This remains indeed, current statistics for violent crime in Windsor between 00:00 and 04:00 indicate that the concept of Framework Hours for pubs and clubs, in particular, would very much be vindicated.
- 2.8. Counsel has, however, suggested that the 01:00 terminal hour within the Framework Hours provisions for venues that supply hot food and drink between 23:00 and 05:00 hours ("late night refreshment premises") would be considered too restrictive and contrary to the spirit of the

Licensing Act 2003. Consequently, an extra hour has been added, with the recommended terminal hour for late night refreshment premises within the Framework Hours provisions now being 02:00.

2.9. Members will be aware, of course, (and the draft policy makes this clear) that the hours outlined within the Framework Hours provisions are not an entitlement and that an applicant will still need to demonstrate that, for the terminal hour of 02:00 to apply, it can operate so as to promote the licensing objectives and that the application and proposed operation is reasonably acceptable in the particular location.
