 I have attended the victim's address today due to the lack of contact via the telephone. He stated that he did not have a phone any more, which is why I have not been able to get hold of him. He has stated

that he heard the suspect in this case had lost his job as a result of the police action on the night, and feels that this is punishment enough and does not want to pursue a criminal complaint as well as that. He has provided a PNB entry to this effect and declined to provide a statement.

As this was such a low level assault, which was provoked by the victim in the first place, and given the fact that he is no longer supporting, and that the CCTV was not produced in a timely manner by the venue, I don't think it is in the public interest to pursue a victimless prosecution of the suspect. The victim is aware and happy that the case was followed up on. Task sent for S/R and filing. GEN40 submitted regarding obstructive nature of the venue regards the CCTV.
