Application for variation under the Licensing Act 2003

Re: Novello, Bath Road, Littlewick Green, Maidenhead, SL6 3RX

I refer to the application under the provisions of the above legislation for the variation of the existing licence relating to the above premises and would advise that the Environmental Protection Unit of the Council has no objection to the application subject to the following conditions:

- 1) Noise arising from any PA or amplified or live music, vocalisation, live or recorded event transmission or any other source should be controlled to such a level that the noise will be inaudible inside residential properties.
- 2) All windows, doors (with the exception of access and egress) must remain closed during regulated entertainment i.e. the playing of live music performances.
- 3) No live or recorded music shall be played outside the premises.
- 4) Speakers should not be placed outside the premises at any time. Indoor speakers should be pointing away from residential properties and should not be positioned close to openings such as doors or windows
- 5) The disposal of bottles into waste receptacles outside the premises is not permitted between 21.00 hours and 09.00 hours.
- 6) No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.



7) A noise limiter must be fitted to the musical amplification system set at a level determined by and to the satisfaction of an authorised officer of the Environmental Health Service, so as to ensure that no noise nuisance is caused to local residents or businesses. The operational panel of the noise limiter shall be secured by key or password to the satisfaction of the officers from Environmental Health Service and access shall only be by persons authorised by the Premises Licence Holder. The limiter shall not be altered without prior agreement with the Environmental Health Service. No alteration or modification to any existing sound system(s) should be effected without prior knowledge of an authorised officer of the Environmental Health Service. No additional sound generating equipment shall be used on the premises without being routed through the sound limiter device.
