

## ALLOWANCES PAID TO MEMBERS 2018/2019

To comply with The Local Authorities (Members' Allowances) (England) Regulations 2003, the Royal Borough is required to publish the total sum paid to every Councillor each year under the Council's Members' Allowances Scheme. All Allowances are subject to National Insurance and Income Tax deductions where appropriate. All Councillors received a basic allowance and a number of Councillors receive Special Responsibility Allowances for holding certain positions, such as the Leader of the Council, Leader of the main Opposition Party, Cabinet Members and Committee/Panel Chairmen. Set out below are the payments made to Councillors in the 2018/2019 financial year.
