## Reasons for decision:

Approximately 11.9% of the adult population in the Royal Borough are estimated to be smokers. As smoking is the leading cause of preventable illness and premature death in England, as well as one of the main causes of health inequalities, it was decided that provision to support residents to stop smoking should continue and
